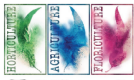

FOOD & TRADE SITE APPLICATION PACK 2026 GENERAL INFORMATION

APPLICATIONS CLOSE

Deadline for trade sites applications and payments is strictly Friday November 6th.

PAYMENTS NOT PAID IN FULL BEFORE SHOW DAY
WILL INCUR A LATE FEE CHARGE OF \$10.00.

ACCESS TO SITES

Trade site operators may have access to their site for set up from 12 - 5 pm on Friday for pre set up.
Show day set up from 7:30 am on Saturday, sites to be set up and operational by 9 am.
Trade sites to remain set up until 4 pm.
Food sites may remain open until 9 pm if they wish.
Further Information will be emailed closer to the show included site allocation and any other additional details.

CAR PARKING

Trade site operators are permitted to park at the Parndana Show grounds for the duration of the show adjacent to their trade site if space allows, otherwise we ask vehicles to be moved to allocated parking area.
Vehicles are not permitted to move around trade site spaces between 9 am to 4 pm.

CLEAN UP

It is appreciated if all items and equipment used and displayed at trade sites to be removed promptly after the conclusion of the show. All rubbish to be placed in allocated disposal locations, sites to be left as they were found.

GATE PASSES

Gate passes are NOT included with your booking and are required to enter the showground.
Passes can be pre-purchased with your application form or at the gate on show day.
Pre-purchased tickets will be sent to the applicant upon payment prior to October 31st. Otherwise must be collected from the show office by arrangement by Friday November 13th.

FOOD & ALCOHOL SITES

Please ensure you have filled out the required forms from Kangaroo Island Council see (pages 5-7) , if alcohol will be sold please ensure you have appropriate liquor licensing.

MARQUEE PEGS

No droppers or pegs are to be used without first consulting the Grounds Coordinator. Weights will be provided if required.

POWER

Single phase power is available to most sites and must be booked upon application. A limit of 2 power point will apply pre application. If you require more power, then we ask that you please provide your own portable generator. Power cords must be supplied by operator and must carry a current, valid test tag of compliance.

Liability and product insurance must be placed by all trade site operators for the entire event including set up and removal. A copy must be provided upon submission of application and is a requirement of approval.
Site holders that do not hold their own insurance are required to pay the first \$1,500 of any liability claim.

Pets of trade site operators are permitted on the Parndana Show grounds area, they must be appropriately restrained at all times.

PUBLIC SERVICES

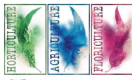
Emergency services will be in attendance and on call at the Parndana Show to provide emergency First Aid.

Conditions for Temporary Food Premises

- Hand washing, antibacterial liquid soap and a single use means of drying hands must be provided where food is packed, prepared or served. Cloth towels must not be used. If using disposable gloves change them often and wash & dry hands periodically before putting on fresh gloves.

Hands must be washed:
- Before commencing work;
- After using a toilet;
- After smoking or eating or handling a handkerchief;
- After touching hair;
- Between handling raw and cooked foods;
- Any other time hands may be contaminated.
- Only single serve, disposable containers should be used to minimize need to wash-up
- Work surfaces and utensils are to be regularly cleaned and if the utensils come in contact with ready-to-eat food, then the utensils must also be sanitised.
- Solid wastes are to be temporarily stored in rubbish receptacles with close fitting lids.
- Operators are required to take all practical steps to prevent access to food by flies and other vermin.
- All food on display shall be covered so as to protect it from contamination by the public, dust, insects, etc.
- The public is to be denied access to work areas. No ground surface storage of food or equipment is allowed unless it is contained within suitable impervious storage containers with tight fitting lids.
- Cold storage refrigeration and heating/ holding appliances must be provided to keep food within the correct temperature range (cold food below 5°C, hot food above 60°C). Eskies with ice or freezer bricks may be used to keep food cold.

You can transport or keep potentially hazardous food out of temperature control for short periods of time by applying the 2 hour / 4 hour guide. This guide means that you can have freshly prepared food out of temperature control for up to 2 hours then refrigerate it for later use. If out of temperature control for between 2 hours and 4 hours the food is to be consumed. After 4 hours the food is to be thrown out.
- Suitable probe thermometers with alcohol swipes accurate to +/- 1°C must be available on the site.
- Farm killed meat is prohibited to be sold for human consumption under the Meat Hygiene Act 1994. Meat must have been processed by the holder of an accreditation or a person exempt from the requirement to hold an accreditation in relation to processing the meat. Evidence of the origin of meat may be required of the outlet.
- Fire extinguishers should be provided where cooking or heating processes are used. Where hot fat or oil is used for cooking a fire blanket must also be held.

Hand Washing Facilities in Temporary Food Outlets

Sufficient quantities of potable (drinking) water must be available for activities such as hand washing, food preparation and cleaning. It is suggested that a plastic drum of around 10-20L capacity be used with an integral tap.

Frame Tent Stalls

Water supply as above, basin or bowl, antibacterial liquid soap, single use paper towels on a separate stand or table at waist height. Bin for used paper towels. Cloth towels must not be used due to the risk of cross-contamination.

Food Vending Vehicles

These should have approved existing hand washing facilities. If not then the same provisions apply as for frame tent stalls.

Water Temperature

Warm water for hand washing is desirable.

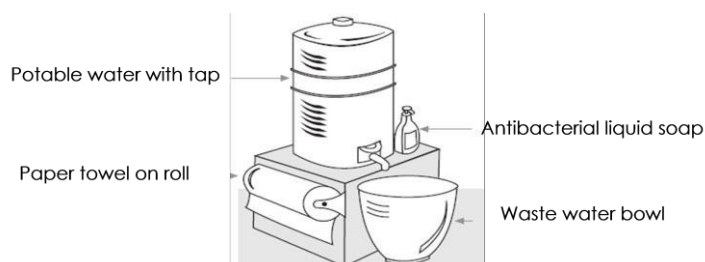

- A copy of Public Liability and Product Liability Insurance must accompany the Trade/Food Site Application- Please contact the Food and Trade Site Coordinators if you have any questions
- No refunds given unless negotiated with the committee prior to the show
- Stall holders to provide own extension cords and connections etc
- Tables available for hire during the show, please include in application, tables are limited
- The Show Society reserves the right to refuse sale of any item it deems unsuitable
- The Show Society reserves the right to accept or refuse any trade space application
- All Trade Site Applications received before 31/10/2026, pre-purchased tickets will be sent to the applicant upon payment prior to October 31st. Trade Site Applications received after the 31/10/2026 will need to organise to pick up pre-purchased tickets for entry prior to the show. If tickets are not picked up the trade site applicant will need to pay entry on the day and this will not be reimbursed. No exceptions will be made
- Tickets must be produced at the gate
- All powered items must be to Australian Standard including tagging. The Society will undertake checks
- Safety tagged extension cords with the name of the owner to be securely attached and joins to be in an approved waterproof cover
- Gas cylinders must be date compliant
- Hygiene must be adhered to when selling or offering food products for tasting
- Raffles will not be permitted unless approved by committee prior to event
- Due to the high demand of power on show day, A limit of 2 power point will apply pre application. If you require more power, then we ask that you please provide your own portable generator.
- Marquee pegs, no droppers or pegs are to be used without first consulting the grounds coordinator. Weights will be provided if required.

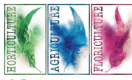

- Trade sites must comply with directions from committee members and ground stewards regarding allocation of sites and site safety

- The operator accepts all responsibility for and shall hold the committee indemnified against any death, personal injury, damage or loss to any person, persons or property howsoever arising and whether at or in consequence of the Show by reason of any act, omission or neglect of the Operator or arising out of the transport, installation, use or demonstration of any machinery, implement, apparatus, static display or stand AND the Operator hereby undertakes to faithfully conform with any regulations, by-laws or ordinances made under such Acts of Parliament or by any Government, Semi Government or Local Government Authority duly authorised to make regulations, by-laws or ordinances in connection herewith, and any such directions the Committee or its delegates may give

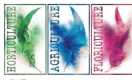
