SALE AGREEMENT

THIS IS AN E-AGREEMENT BETWEEN PDG BULLIES ("SELLER") AND FIRST & LAST NAME ("BUYER") AND IS DATED ON THE JANUARY 15th OF 2025.

BUYER AGREES TO PURCHASE FROM THE SELLER THE FOLLOWING ITEMS: PUPPY NAME, PUPPY SALE.

THE PURCHASE PRICE SHALL BE \$2,500 BY (PAYMENT METHOD) AND SHALL BE ON THE FOLLOWING TERMS:

TERMS AND CONDITIONS

DEPOSIT: \$1,000.00 USD

- In the form of: \$1,000.00 by Payment Method.
- Deposit goes towards final payment.

PAYMENT: \$1,500.00 USD

- Payment shall be \$1,500.00 USD by Payment Method.
- All payments are due before puppy is released to Buyer from Seller.

PICK-UP OR DELIVERY:

- Buyer has chosen Personal Pick Up.
- Buyer will pick puppy up from Sellers on January 23rd, 2025.

LIABILITY: BUYER receives liability of puppy at point of Pick Up.

PET HOME OR BREEDING RIGHTS:

- BUYER has chosen PET HOME. The buyer DOES NOT have the right to breed the canine, PUPPY NAME.
- Puppies sold with PET HOME Registration can not be bred for any reason and all be in violation of agreement if the puppy is bred. We, PGD Bullies will take all legal actions for breeding violations.
- If a violation occurs, Buyer will be required to pay \$2,500 to PGD Bullies for compensation and cover all legal fees for all parties.

INSPECTIONS & RETURNS

If Seller is to find any form of abuse, the canine is to immediately return to Seller. Purchase of canine (as well as any fees included in the invoice) is final with no returns. If canine is sick or passes away in the first 30 days, Buyer is entitled to HALF of payment that was provided to Seller to purchase the canine. Seller requests that Buyer will send updated photos of canine every 2 months, so Seller can see the progress of the canine.

BREEDING PROMISE

If a female canine is purchased with full breeding rights, overbreeding of the purchased canine is prohibited. This means the canine shall not be bred more times than her body can safely handle and has been provided documents from a Vet, approving the health of the dam to the litter. Occurring health conditions caused by overbreeding include eye problems, hearing loss, respiratory issues, and birthing difficulties.

If a male canine is purchased with full breeding rights, We PGD Bullies, have the right to 2 stud credits from the male canine. If we decided to use the stud credits, any fees connected with collection, shipping of semen, or any and all breeding costs, will be paid by PGD Bullies. We will solely use the stud credits within our program.

SELLERS WARRANTIES

Seller agrees with signature that he/she is authorized to enter into this e-agreement, is the lawful owner of the canine he/she is selling under this agreement and can otherwise lawfully transfer title of the canine to buyer.

BUYER PROMISE

Buyer agrees with all in breeding promise.

The canine will always be maintained and kept in buyers proximity and control. To regularly take canine to the Vet, get required shots, and take care of any and all of the canines needs. We have the right to take a picture of you with said canine at pickup/drop-off. We have the right to use the canines name, photography and videography of said canine, and any and all information on said canine. Keep in contact with PGD Bullies for the rest of said canines life. Seller requests that Buyer will send updated photos of canine every 2 months, so Seller can see the progress of the canine.

ABKC REGISTRATION

Any person to purchase a canine from PGD Bullies and sign Our Puppy Contract is required to sign the "New Owner" section on the ABKC Application for Permanent Registration.

By signing this agreement both participants understand and agree to the terms above. Both participants understand that in the court of law, this document stands as the legal contract for the transfer of the property stated in this SALE AGREEMENT provided by PGD Bullies.
