### **ROUND Table**

Below listed items were discussed and reviewed with AOC members and GTAA. Where applicable, new items were added to the AOC log of open items for follow-up.

## High speed people movers → Johnathan Lock

Air carriers are raising concerns for both T1 and T2

Large carriers with larger airplanes arriving at Pearson at similar times/increased volume of pax at international arrivals corridors, during this time there is tremendous congestion that is aggravated by surrey's

- The first concern is communications with the AOC membership when the high-speed people over that has been OTS for a long time will be removed to gain real estate in the area for passenger/surrey traffic
- Second concern on the arrivals segment International towards CBSA 2 out 3 people movers are OTS with a return to service date of June 20<sup>th</sup> that already passed, no new information when it will be ready and back into service.

#### Issues with ITD on T3 → Action Item For Dan Riddle

Passengers arriving outside SPIL hours of operation proceed to SPIL to find it closed. There was an understanding by the Airport community of someone (TSR) from GTAA who will manage that process to avoid long walking distances to SPIL when closed

• This is aggravated with very confusing signage on the T3 (AT) arrivals level.





**Bus availability for IFC carriers**→**Action Item For Glen Henderson** 

Multiple carriers operating at IFC have reported issues with BUS availability, especially from T1 to IFC and vice versa. Carriers claim that although buses are there to comply with the one every 15 min departure, the number of passengers is such that sometimes they must wait for bus number 2 or 3, increasing waiting times to 30 to 45 min for a bus to/from the terminal.

Item raised at high priority, as this has caused carriers flight delays, impacting OTP and misconnects on the arrivals.

• Request to increase bus frequency between the hours of 1500-1800 where there are multiple wide body aircraft operating at the same time

# **Meetings Schedules** → **Action Item For Dalia Wells**

**Meetings Schedules**: Suggestion for meetings like the "Air Carrier Working group meeting" is to give plenty of heads up to the participants on what is to be discussed. Being the only forum, the air carriers will have to understand changes to the GH licensing program, they might have the need to include support people like the Corporate real estate people/procurement/contracts, etc

# **GPU** → Action Item For Michael Quelhas

- Gate 173 GPU multiple failures and a secondary portable GPU not available at the gate. Multiple items get called, fixed, then GPU trips again.
- Gate B12 a few calls regarding GPU tripping as well as PCA malfunctioning.

## Pearson Standards Infractions → Action Item For Abdur Syed

Concerns on the notification of failures from the Pearson standards, two carriers advised they only learned of an infraction several weeks later via invoicing. Community would like to see faster communication from the Pearson standards team so things can be researched properly by the carrier/GH
