GTAA Update and Round Table

GTAA meeting portion was opened with a statement of concern raised by AOC Chair, related to operational



issues remaining unresolved due to insufficient follow-up and lack of documented updates from GTAA leadership.

- Burak requested that GTAA share outcomes from internal meetings to enable communication of progress to the airline community.
- Emphasis was placed on the importance of receiving formal follow up reports to track outstanding items and ensure accountability.
- The absence of a structured issue log or update mechanism hinders the ability of airline representatives to inform their teams and headquarters about ongoing efforts and resolutions.

Carousel Management

- Chargeback Reporting for Carousel Alarms: Daily reports to be distributed to airlines
- Airlines to receive fault notifications per flight for alarms exceeding 2 minutes.
- Clarification: Supervisor charge replaces carousel management fee on invoices

Construction & Equipment Maintenance

Terminal 1:

- OSO1 aisle 4 CTX unit to return to service on Monday.
- OSO2 aisle 13 scheduled for upgrade starting November 10.
- CF6 carousel replacement to begin early January.

Terminal 3:

- OS6 carousel to return to service on November 8.
- OS7 scheduled outage from November 24 to December 19.
- CI4 construction nearing completion; expected return first week of December.
- CD1 next in line for replacement.

Security and Safety→Project Vigilance

Recent incidents of unauthorized items being trafficked through Pearson Airport have raised serious concerns. These incidents were reported in the media and involved insider threats, where airport employees or ground handlers allegedly used their access to facilitate trafficking.

Airlines affected are working with OPP, RCMP, CBSA, and own security teams to investigate & mitigate risks.

Focus Group Formation: GTAA will organize a focus group with concerned carriers to:

Regulatory Change Advocacy: GTAA and airlines to jointly approach Transport Canada (TC) and CATSA to: *Expand search criteria, recognize contraband as a civil aviation threat and push for regulatory changes to improve screening and oversight*

GTAA detailed the action plan in place to addressing trafficking trend:

- Focus on random patrols, employee engagement, and spot checks to disrupt suspicious activity. Over 2,000 employees have been engaged in field checks. No arrests to date, but unauthorized items have been intercepted.
- **26 new cameras** to be installed at all **baggage induction points**, Manual and coded entry locations. Cameras will be visible to act as a **visible deterrent**.
- In assisting the airlines to communicate with their HQs and demonstrate proactive steps. GTAA committed to providing written advisories and shareable documents outlining:

 Project Vigilance, Surveillance upgrades, Preventive measures

Winter Operations Readiness

- o Winter Workshops Completed held Oct 21–28. Airline-specific meetings to be scheduled.
- o **De-Icing Operations** 22 new seasonal staff hired and trained.15 new de-icing units deployed.
- Snow Clearing Protocols
 - Snow desk to be contacted for gate clearing post aircraft departure.
 - Bridge snow accumulation concerns raised; updates requested next month.
 - Testing of heated floors and baseboard heaters underway.
- Potable Water Cabinet Freezing: Staff reminded to close cabinet doors and return hoses.
 Heated hoses discussed; further market research suggested

GTAA Welcome Team Expansion Team growing to 310 members by January 2026.

New Internal Officer Role TSR and SSO teams amalgamated for better accountability starting Nov 19.

Revitalization vs. Emergency Repairs: Prioritize repairs before FIFA 2026.


GTAA to separate urgent infrastructure needs from long-term Gateway project.

- Draw on December 6 will determine teams arriving in Toronto.
- Expect VIP and commercial passenger influx starting January–February.

- GTAA leading FIFA operations and communications.
- Airlines encouraged to prepare for increased demand and fan behavior.
