### Business Incentive Grant

#### LICENSE DAY CARE PROVIDERS

The Axtell Economic Development Corporation Incentive Grant is intended to encourage the startup of new daycares and the continuation of existing day care units in the Axtell Community. The grant funds will be disbursed as a reimbursement upon the recipient's submission of paid receipts for licensing and other approved expenses. Reimbursement will be in the form of Axtell Cash. Below is a list of participating businesses you may use the Axtell Cash at.

Axtell Cash is only available for redemption at participating Axtell businesses listed

Axtell Cash is not redeemable for cash. If any remaining balance is left after use, any amount not used in full will be turned into a gift certificate to that particular business

#### Criteria

- The applicant must be a licensed daycare operating under the current Kansas Department of Health and Environment daycare licensing guidelines.
- The daycare must be located in Murray Township, unless otherwise approved by the Axtell Economic Development Board.
- Grant funding is awarded after the recipient provides receipts/documentation.
- New daycares that are approved will receive a total of \$500.00 the first year to assist with offsetting start-up costs.
- A licensed daycare that has met all Kansas Department of Health and Environment guidelines, but currently has no children enrolled, will not be considered for funding.

The AEDC reserves the right to revoke any applications that do not meet the objectives of this grant.

#### **New Daycares (\$500.00 Grant) Requirements:**

- An application requesting grant funding

- A copy of the current State Day Care Renewed License
- A copy of the State Annual Inspection

Upon approval of the AEDC, a grant of \$500.00 will be awarded. The first \$250.00 will be awarded following a request for funding and proper documents for reimbursement. The second \$250.00 will be disbursed six months following the first disbursement of funds, providing the daycare remains in good standing with the Kansas Department of Health and Environment, (refer to copy of state inspection) and is in operation with a minimum of at least 2 children, who are not members of their immediate daycare provider.

This grant will be renewed in the amount of \$250.00 yearly by submitting a copy of the State renewed license and copy of the annual state inspection. Applicants must remain in good standing with the Kansas Department of Health and Environment at all times in order to receive funding and have a minimum of at least 2 children, who are not members of the immediate family of the daycare provider.

Current licensed daycare providers who are submitting and approved, must remain in good standing with the Kansas Department of Health and Environment (refer to copy of Annual State Inspection) and are in operation with a minimum of at least 2 children, who are not members of their immediate daycare provider.
