DEFAULT:

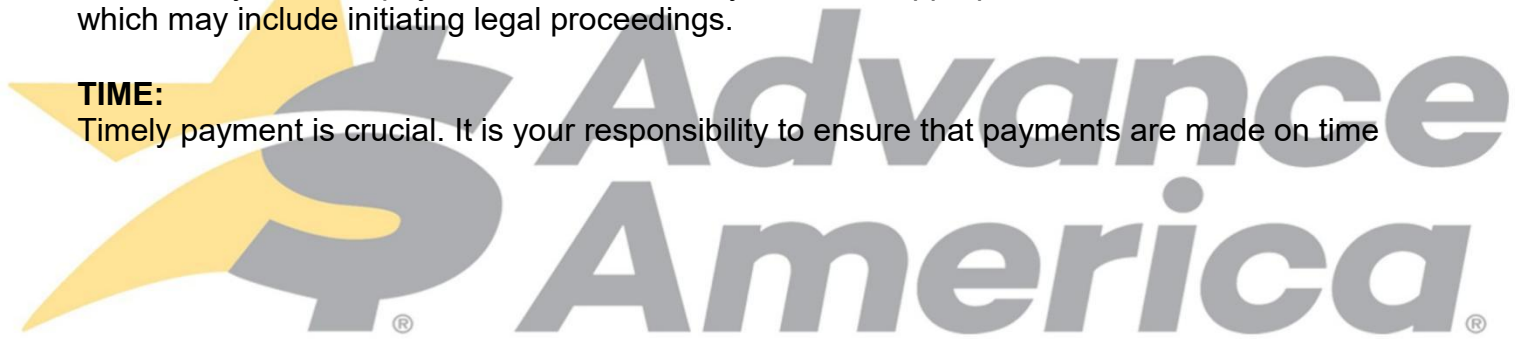

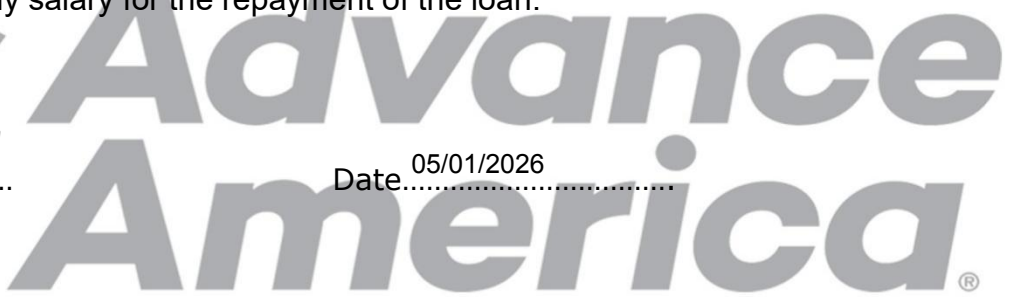
