MISSION

Live Coal Gallery is a Detroit-based social venture that fosters a passion for art, community, and learning by engaging Detroit neighborhoods with the transformational and restorative power of the arts. Our Live Coal Arts Mobile, an 18' trailer that doubles as a gallery and workshop space, provides opportunities for our Collective to exhibit work, create installations, conduct workshops, and put on performances. We provide hands-on experiences for children and families, and collaborate with businesses, organizations, and schools on a variety of arts-based projects. Our children's art museum, The RED, is a program of Live Coal. The RED holds our permanent collection of student art and features special exhibitions of art created by Detroit-area youth. The RED also conducts its own drop-in-workshops, arts-based camps, has a creative play space, and an open studio. The RED is located at Clairmount Studios in Detroit's Piety Hill neighborhood.

ART & THEATER CAMP

This summer, The RED will host its first ever Art & Theater Camp (ATC) for children ages 6-11. ATC will be facilitated by a group of middle and high school theater students. At least one Live Coal adult staff member will always be on site. There are 12 slots open for this camp. Students are accepted on the following basis: completed registration form, full payment received by July 20, 2019, and meet the age requirement. Cost for camp is \$100 per child with a \$10 sibling discount. In order to give several families the opportunity to participate, we will accept two children per household. If registration is not filled by July 20, 2019, we will contact families who have registered already and are interested in registering more of their children (with a max of four kids p/household). Please only send students who are able to come for the entirety of the camp as we will be rehearsing and preparing for a final performance scheduled for July 26th at 4pm.
