Please be advised that it is the position of the United Way that, when you have brought issues to it, Ms. Liesveld and others have listened and given careful consideration to each and every one of your concerns. Please also be advised that the United Way has numerous processes in place in which it regularly engages to ensure that donor dollars provided to a program or agency are spent appropriately. This includes regular monitoring and receipt of an audit from each program and agency funded through the allocation process.

Please treat this correspondence as the formal demand of United Way that you immediately cease and desist from making any further false and defamatory statements about the United Way, Ms. Liesveld, or any other executive or representative of the United Way. We will continue to monitor your conduct, and all public statements which in any way reflect upon the United Way. In the event that you continue to make public statements about the United Way, or any specific representative of the United Way which are false and defamatory, we will have no
