If purchases are not paid as specified, I will pay interest at the rate of \_\_\_\_\_ percent per annum (six percent if left blank) or highest rate allowed by law, whichever is lower, until the full amount of the purchase price is paid in full. If the Market takes legal action to collect my account and prevails, the Market and its successors and assigns shall be entitled to reasonable attorney@ fees and court costs.
