Grumble, groan!

Commonly expressed concerns about ethical review:

- Inappropriate medical/health presumptions that researcher-participant relationships are like doctorpatient relationships
- Processes/protocols are unwieldy, time consuming, and restrictive
- Ethical clearance isn't necessary/journalism, social sciences and humanities should be exempt
- Review committees don't understand our disciplines



Grumble, groan!

By contrast, some dismiss critiques:

- Social science victim narrative" based on "provocative" + "anecdotal 'horror stories" (Stark 2007)
- Often rely on individual perspectives and experiences, so they aren't necessarily generalizable (Wynn 2011)
 Fixes real problems in applications (Batterbury 2014)

Generational change?


- Research on sociologists and anthropologists suggests that senior, male academics resist ethical review as threat to autonomy/freedom
- Junior, female academics are more compliant and cooperative (Taylor & Patterson 2011; Wynn 2011)





Results

Email a one-page summary to participants and anyone else who requests it

Identify broader sets of experiences—positive and negative—for ethical review

Find best practice and problems, to improve the overall culture

Open new windows for dialogue, negotiation and leverage about ethical review




Seeking Ethical Clearance to Study Ethical Clearance
