

THIRD AMENDMENT TO DECLARATON OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR COSTA BELLA

This Third Amendment to Declaration of Covenants, Conditions and Restrictions for Costa Bella (the "Declaration") is made by Falcon of Lake Travis, Inc., a Texas corporation ("Falcon"). The Declaration encumbers real property located in Travis County, Texas as follows: The Costa Bella subdivision as originally platted consisted of Lots 1-54, Block A, and Lots 1-4, Block B, Costa Bella Section Two, as recorded in Volume 100, Page 382, Plat Records of Travis County, Texas. Portions of the Property (i.e., Lots 7-23, Block A, Costa Bella) were subsequently re-platted to become Lots 7A-27A, Costa Bella Section Two, according to the map or plat of record in Document No. 199900344, Official Public Records of Travis County, Texas.

RECITALS

Falcon is the original Declarant pursuant to that certain Declaration of Covenants, Conditions and Restrictions for Costa Bella, as amended, said document being filed in the Travis County Land Records in Vol. 13141, Page 3594, et seq., Real Property Records of Travis County, Texas, and re-recorded in Volume 13143, Page 812 of said Records (collectively, the "Declaration").

Section 9.02 of the Declaration states, in pertinent part, "This Declaration may be amended by Declarant, acting alone, to correct a typographical error or if such amendment is required to bring any provision of this Declaration into compliance with any applicable governmental statute, rule, regulations, requirement or judicial determination."

Falcon makes this Amendment to correct a typographical error in the Declaration as follows. Any reference to the "Association" to the contrary in the Declaration, as recorded, re-recorded and amended is hereby changed to "The Costa Bella Waterfront Community, Inc., a Texas non-profit corporation."


