#### ORDINANCE NO. 2018-07

## AN ORDINANCE AUTHORIZING THE PURCHASE OF THE MARGARET LUCILLE HAAS PROPERTY

The Village Council of the Village of Belle Center, Ohio, met September 11, 2018, at its regularly scheduled monthly meeting and has determined that action should be taken to enable the Village to purchase the Margaret Lucille Haas property which is a property currently enrolled in the Ohio Development Services Agency Abandoned Gas Station Clean Up Grant Program.

WHEREAS, the Village has previously advanced \$5,000.00 to cover the preliminary environmental costs as part of the grant program, and,

WHEREAS, the Village has placed a lien upon the Haas property with the Logan County Recorder's Office securing the repayment of the \$5,000.00 advance and,

WHEREAS, the Village is entitled to be repaid out of the sale of the property or otherwise to be reimbursed pursuant to the terms of the grant program, and

WHEREAS, the Village Council believes that it might be in the best interests of the Village to actually acquire the property and be exclusively in control of the future use of this property (subject to any regulatory guidelines of the grant program),

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Belle Center, Ohio, as follows:

- 1. When the grant monies have been extended, and all tests have been completed, and all required remedial actions have been taken and the State of Ohio EPA issues a No Further Action Required so that the property is considered a "clean property", the Council authorizes assuming title of the property subject to the conditions set forth herein.
- 2. The Village shall not assume title or ownership of the property unless or until it has received certification from the Ohio EPA that all required actions have been taken and that no further remedial actions will be required.

3. When the Village receives its reimbursement money or repayment money for the \$5,000.00 advance, it will instead retain only \$2,500.00 of that advance and will pay to Margaret

Lucille Haas the other \$2,500.00 as a reimbursement or payment to her for expenses that she has incurred in maintaining the property throughout the grant application and completion process.

4. The Village will only assume title and ownership of the property when it is determined that it is not at risk relating to underground tanks, soil contamination, or other volatile conditions or provisions which will place it at risk for penalties, fines, or other action by the Ohio EPA or other regulatory agencies.

It was moved by Rick Bednarki and seconded by Donna Hesser to waive the requirement of three readings and to pass this Ordinance on a single reading as an emergency measure and the Council voted 5-0 to pass it on an emergency basis. It was then moved by Russ Hogue and seconded by Dione Campbell to effect passage of this Ordinance and again the vote was 5-0.

This Ordinance, shall, therefore, become effective as soon as allowable by law.
