



**AN ORDINANCE PROVIDING COMPENSATION AND EMPLOYING A VILLAGE
SOLICITOR FOR THE VILLAGE OF BELLE CENTER, LOGAN COUNTY, OHIO,
FOR A ONE-YEAR TERM BEGINNING JANUARY 1, 2026 AND ENDING
DECEMBER 31, 2026 AND DECLARING AN EMERGENCY IN THE VILLAGE OF
BELLE CENTER, OHIO.**

WHEREAS, the legislative authority of the Village of Belle Center, Ohio deems it necessary to employ counsel for the Village under the authority granted in Ohio Revised Code Section 733.48; and

WHEREAS, Madyson S. Stratton, Attorney at Law, Bellefontaine, Ohio, has made application for employment as Village Solicitor for the Village of Belle Center, Ohio; and

WHEREAS, the council of the Village of Belle Center, Ohio finds the above-named applicant duly qualified for the position of Village Solicitor for the Village of Belle Center, Ohio.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Belle Center, Logan County, Ohio, that:

SECTION 1: Madyson S. Stratton, Attorney at Law, Bellefontaine, Ohio, shall be, and hereby is, employed as Village Solicitor of the Village of Belle Center, Ohio, for a one-year term beginning January 1, 2026 and ending December 31, 2026.

SECTION 2: The annual salary for the position of Solicitor of the Village of Belle Center, Ohio, shall be Nine Thousand and 00/100 Dollars (\$9,000.00), and shall be payable in twelve (12) monthly installments, in the amount of Seven Hundred Fifty and 00/100 Dollars (\$750.00) per month, payable on the second Tuesday of each month. In addition to the foregoing, the Village of Belle Center shall pay all costs involved to maintain Madyson S. Stratton's enrollment in the Public Employees Retirement System (OPERS). In the event the Village of Belle Center requires legal counsel beyond the usual scope of a Village Solicitor (attending one council meeting per month, drafting Ordinances and Resolutions, and the review and drafting of basic contracts), Madyson S. Stratton shall be paid her prevailing hourly rate for legal work, as an independent contractor.

The solicitor shall be supervised by and shall coordinate through the Mayor all of her services on behalf of the Village. The Mayor shall also, arrange for the provisions of office space or equipment, if required, by the solicitor to perform her duties for the Village. The Solicitor's attendance is required at One Village council meeting per month, unless otherwise directed by the Mayor.

In the event Madyson S. Stratton should become unable to perform services of Solicitor of the Village, then, in that event, the Village shall employ another attorney to complete and perform those services.



ORDINANCE NO. 2025-15

**AN ORDINANCE TO ADOPT AND IMPLEMENT THE PROCEDURES UNDER
CHAPTER 5722 OF THE OHIO REVISED CODE TO FACILITATE THE
REUTILIZATION OF NONPRODUCTIVE LAND SITUATED IN THE VILLAGE, AND
DECLARING AN EMERGENCY IN THE VILLAGE OF BELLE CENTER, RICHLAND
TOWNSHIP, LOGAN COUNTY, OHIO.**

WHEREAS, economic development and revitalization of all areas of the Village, both residential and commercial, have been and continue to be goals of the Village; and

WHEREAS, the goal of economic development and revitalization contemplates turning nonproductive land within the Village into productive land that generates tax revenues or is otherwise used in a manner that advances the public interest by noncommercial use; and

WHEREAS, the existence of nonproductive land within boundaries of the Village is such as to necessitate the implementation of a land reutilization program to foster the return of such nonproductive land to tax revenue generating status or the devotion thereof to appropriate noncommercial use; and

WHEREAS, in order for the Village to employ the provisions of Chapter 5722 of the Ohio Revised Code, this Council must approve legislation to adopt and implement the provisions of this Chapter.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Belle Center, Logan County, Ohio, that:

SECTION 1: This council adopts and implements the procedures set forth in Chapter 5722 of the Ohio Revised Code to facilitate the reutilization of nonproductive land situated in the Village.

SECTION 2: This council further declares that the existence of nonproductive land within its boundaries is such as to necessitate the implementation of a land reutilization program to foster either the return of such nonproductive land to tax revenue generating status or the devotion thereof to appropriate noncommercial use.

SECTION 3: This council finds and determines that all formal actions of this council, concerning and relating to the passage of this Ordinance, were taken in an open meeting of this council, and that all deliberations of this council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

SECTION 4: That this Ordinance is hereby declared to be an emergency measure made necessary to protect the health, safety and welfare of the Village of Belle Center, Ohio, provide for its continuous uninterrupted services, and to sell real estate not needed for any municipal purpose, and it shall, therefore, be in force and take effect immediately upon its passage and signature by the Mayor.





AN ORDINANCE TO SELL REAL ESTATE NOT NEEDED FOR ANY MUNICIPAL PURPOSE, AND DECLARING AN EMERGENCY IN THE VILLAGE OF BELLE CENTER, RICHLAND TOWNSHIP, LOGAN COUNTY, OHIO.

WHEREAS, the Village of Belle Center, Ohio is the owner of real estate described on the attached Exhibit A (which is a Quit Claim Deed from Ohio UST Community Improvement Corporation to the Village of Belle Center, Ohio) consisting of Permanent Parcel No. 39-022-06-10-001-000 and further being real estate in VMS 9972 and part of Lot 161 of the Village of Belle Center, Ohio; and

WHEREAS, the property is located at the corner of 302 W. Main Street and 101 S. State Street, Belle Center, Ohio; and

WHEREAS, the property consists of 0.1340 acres, more or less; and

WHEREAS, the property was acquired by the Village as part of a governmental program to assist governmental entities and communities by correcting, improving, cleaning, and otherwise doing all steps necessary to remedy properties which may have formerly had buried tanks, or otherwise might have characteristics which presented EPA violation problems; and

WHEREAS, the Village of Belle Center, Ohio, through its Council has determined that the real estate is not needed for any municipal purpose.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Belle Center, Logan County, Ohio, that:

SECTION 1: This council has determined that the property has a value of at least \$10,000.00, which this council has determined will be the minimum bid price acceptable to the Village through a private or public sale.

SECTION 2: The mayor or village administrator, or fiscal officer may take immediate steps to advertise the sale of the property one time per week for a period of five weeks pursuant to R.C. 721.03.

SECTION 3: The property will then be sold to the highest bidder who proffers a bid of at least the minimum acceptable bid price as set by this Ordinance and also on the condition that the required cost of advertising shall also be paid by the successful bidder so that the successful bid will be the highest bid of at least \$10,000.00 in addition to payment of the advertising cost.

SECTION 4: The mayor of the Village of Belle Center, Ohio is hereby authorized and empowered to execute and sign a deed and any other necessary closing documents to convey the property to the successful bidder upon the completion of the process.

SECTION 5: This council finds and determines that all formal actions of this council, concerning and relating to the passage of this Ordinance, were taken in an open meeting of this council, and that all deliberations of this council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

SECTION 6: That this Ordinance is hereby declared to be an emergency measure made necessary to protect the health, safety and welfare of the Village of Belle Center, Ohio, provide for its continuous uninterrupted services, and to sell real estate not needed for any municipal purpose, and it shall, therefore, be in force and take effect immediately upon its passage and signature by the Mayor.

WHEREAS, the purpose of this requirement is to strengthen protections of public data, information systems, and technology resources from cybersecurity threats and risks; and

WHEREAS, the Village of Belle Center recognizes the importance of safeguarding sensitive and confidential information; and

WHEREAS, a Cybersecurity Policy has been prepared and reviewed by staff and is recommended for adoption as a framework for compliance with Ohio Revised Code §9.64 and HB 96; and

WHEREAS, the policy provides guidance on access control, system security, data protection, incident response and training;

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Belle Center, Logan County, Ohio, that the attached Cybersecurity Policy is hereby adopted.

VILLAGE OF BELLE CENTER
CYBERSECURITY POLICY

1. Purpose

The purpose of this policy is to establish a framework for protecting the confidentiality, integrity, and availability of the Village of Belle Center's information systems, data, and technology resources in compliance with R.C. §9.64 cybersecurity requirements.

2. Scope

This policy applies to all elected officials, employees, contractors, vendors, and third parties who access or manage The Village of Belle Center's technology resources, including but not limited to:

- * Computers, servers, and mobile devices
- * Cloud services and hosted applications
- * Networks and telecommunications systems
- * Sensitive or confidential data

3. Policy Statement

The Village of Belle Center is committed to safeguarding its information systems against cybersecurity threats and ensuring compliance with R.C. §9.64 by:

- A. All information and security and privacy incidents shall be immediately reported to the Ohio Department of Administrative Services (DAS) Customer Service Center (CSC). Incident reporting option's: CSC Phone 614-644-6860 or 877-644-6860, CSC Email csc@ohio.gov, website ohioauditor.gov/fraud/cybersecurity.html and form (attached).
- B. The Village of Belle Center will undertake the following Security Incident Response.
 1. Preparation: Setting up the necessary architecture and processes to detect potential incidents.
 2. Detection and Analysis: Monitoring for anomalies and identifying whether an incident is occurring.
 3. Containment: Taking steps to prevent the incident from spreading to other systems.
 4. Eradication: Removing the threat from the affected systems.
 5. Recovery: Restoring affected systems and processes to their normal state.
- C. Training and Awareness: Provide cybersecurity awareness training. Require employees to complete cybersecurity awareness training at ohioauditor.gov/training/cybersecurity.html.
- D. Compliance and Review: This policy will be reviewed annually and updated to reflect changes in technology, law, and organizational needs.

4. Effective Date. This policy took affect after being adopted by the Village Council on 10/14/2025

**AN ORDINANCE AMENDING THE CREATION OF DELINQUENCY SHUT-OFF AND
RE-ESTABLISHMENT OF WATER/SEWER SERVICES, AND DECLARING AN
EMERGENCY IN THE VILLAGE OF BELLE CENTER, RICHLAND TOWNSHIP,
LOGAN COUNTY, OHIO.**

WHEREAS, this Council previously determined that pursuant to Ohio Revised Code Section 715.01, it is a body politic and has the right and duty to manage and control all Village property and make all rules and regulations necessary to carry out the provision of its policies; and

WHEREAS, this Council previously determined that pursuant to Ohio Revised Code Section 743.02, the Village has the right to make regulations necessary for the safe, economical and efficient management of the utility systems of corporations; and

WHEREAS, this Council previously determined that pursuant to Ohio Revised Code Section 743.04, the expenses of conducting and managing the water works or sewer works of the Village of Belle Center, Ohio, make it necessary to charge a monthly water fee and/or a monthly sewer fee in an amount necessary to properly run the systems; and

WHEREAS, this Council previously determined that from time to time, residents and/or account holders fail to make timely payments of their utility obligations; and

WHEREAS, the legislative authority of the Village of Belle Center, Ohio deems it necessary to the health, safety and welfare of its citizens to amend the creation of delinquency shut-off and re-establishment of water/sewer services in order to account for leaks in water systems within the Village.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Belle Center, Logan County, Ohio, that:

SECTION 1: Each water and/or sewer or any other utility bill is payable on or before the 15th day of each month.

SECTION 2: If any utility bill is not paid in full by the end of the month, a late penalty will be charged in the amount of 5%. The 5% penalty will be assessed for each month the delinquency remains, or any late fee applies.

SECTION 3: If the bill is not paid in full by the 15th day of the following month, the account will be determined to be delinquent.

SECTION 4: If the bill is not paid in full by the 30th day of the following month, service for the account will be terminated.

SECTION 5: Residents may make partial payments on a bill at any time, but partial payments shall not preclude the assessment of the late penalty or the termination of service if the bill is not paid in full by the applicable dates.

SECTION 6: Any costs associated with terminating and reactivating service will be added to the delinquent charges and must be paid in full before service is re-activated. There will be a fee in the amount of \$35.00 charged for any termination or reactivation of service.

SECTION 7: To the extent a deposit is required, and to the extent any deposit on file has been utilized to help make up for the past due amounts, a new deposit shall be required before service is re-activated.

SECTION 8: Two different parties are responsible for each account. A tenant or any other person designated as a responsible party or who has placed the billing account in his or her name shall at all times remain jointly and severally liable with any tenant for the billing. Ultimately, the Village has a collection process to assess delinquent accounts against the real estate tax bills with the Logan County Auditor and as a result the owner must remain active with any tenant to be sure the charges get paid because each shall be separately or completely responsible for any and all utility charges with the Village of Belle Center, Ohio.

SECTION 9: All leaks in the property owner's water system, whether detected by the party to whom the bill is sent or a representative of the Village, shall be repaired within seventy-two (72) hours of its detection. If the leak is detected by a Village representative and the leak is not repaired within the required time and is creating a hazard or is deemed by the Village to potentially cause damage to other property, or in the opinion of the Village representative is causing significant loss of water, water service may be shut off until the leak has been repaired.

SECTION 10: This Ordinance hereby amends previous Ordinance No. 2020-07 creating a delinquency shut-off and re-establishing water/sewer services in the Village and shall become effective immediately.



ORDINANCE NO. 2025- 05

**AN ORDINANCE TO PROHIBIT THE OWNING, KEEPING, HARBORING, AND
PERMITTING OF CERTAIN ANIMALS AND TO LIMIT THE NUMBER OF
CHICKENS AND RABBITS WITHIN THE VILLAGE, TO IMPOSE CONDITIONS ON
THE KEEPING OF SAME, AND DECLARING AN EMERGENCY IN THE VILLAGE
OF BELLE CENTER, RICHLAND TOWNSHIP, LOGAN COUNTY, OHIO.**

WHEREAS, the legislative authority of the Village of Belle Center, Ohio deems it necessary to the health, safety and welfare of its citizens to prohibit ownership, keeping, harboring and permitting of certain animals and to limit the number of chickens and rabbits that may be kept in the Village.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Belle Center, Logan County, Ohio, that:

SECTION 1: The owning, keeping, harboring, or permitting of certain farm animals, wild animals or non-domestic animals and an excessive number of chickens and rabbits within the Village limits shall be prohibited.

SECTION 2: Definitions:

(A) "Person" includes a natural person, association, partnership, organization or corporation or other similar legal entity.

(B) "Own, keep, harbor, or permit" includes having legal title, custody or control over a prohibited farm animal or livestock.

SECTION 3: It shall be prohibited to own, keep or harbor, within the Village limits, farm animals, wild animals or non-domestic animals consisting of but not limited to sheep, pigs, horses, mules, goats, cattle, roosters or other animals or fowl usually known as "farm animals" or "livestock" but not solely limited to the aforementioned and not including common household pets, chickens, and rabbits.

SECTION 4: No person shall own, keep, harbor or permit more than ten (10) live chickens and six (6) live rabbits within the Village.

(A) A person is allowed to own, keep, harbor or permit ten (10) or less live chickens and six (6) or less live rabbits if the animals are:

- a. At all times when outdoors kept securely enclosed in a yard or pen that is cleaned to prevent the accumulation of animal waste;
- b. No enclosure shall be located closer than fifteen (15) feet to an occupied residential dwelling on an adjoining lot, ten (10) feet to a side yard line and five (5) feet to a rear lot;
- c. Strictly for personal or household use, rather than for any commercial use;
- d. Any structures or fencing associated with the keeping of chickens or rabbits may not be situated in a front or side yard in a residential area.

(B) No person shall slaughter any animals within the Village.

SECTION 5: No person shall keep any chicken or rabbit without first obtaining a permit from the Village. This permit may be revoked at any time by the Village Administrator.

- (A) Any person desiring to have chickens or rabbits shall contact the Village Administrator prior to obtaining any chicken or rabbit.
- (B) Persons that currently have chickens or rabbits shall contact the Village Administrator and will be given six (6) months to abide by the restrictions placed on the ownership of ten (10) chickens and six (6) rabbits.
- (C) The permit application shall be accompanied by the payment of a fee of \$25.00 to process the application.

SECTION 6: The prohibitions set forth in this Ordinance shall be activated by the Village Council issuing a written notice to the violating person to correct the violation within ten (10) days of the service of the notice. The notice shall be served in a manner guaranteed to show actual delivery, which may include any of the following:

- (A) Certified mail service, return receipt requested;
- (B) Personal service by the Logan County Sheriff's Office or any other entity providing police or sheriff services within the Village of Belle Center, Ohio;
- (C) Residence service by a private service provider.

The notice shall state that the person in question violates this section and shall instruct that the violation must be remediated within ten (10) days after receipt of the notice. Failure to do so shall be a minor misdemeanor punishable as set forth hereinafter.

SECTION 7: Any person in violation of this Ordinance shall be subject to a minor misdemeanor if the violation persists more than ten (10) days after service of notice described in Section 6 above and, upon conviction thereof, be fined in an amount not to exceed One Hundred

and Fifty Dollars (\$150.00). The offense shall be a minor misdemeanor as is defined by the Ohio Revised Code. Each day such violation is committed or permitted to continue is a separate offense.

A violation of this section is deemed to constitute a nuisance and shall be subject to abatement procedures under the Ohio Revised Code and/or pursuant to the ordinances of the Village.

SECTION 8: This council finds and determines that all formal actions of this council, concerning and relating to the passage of this Ordinance, were taken in an open meeting of this council, and that all deliberations of this council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

SECTION 9: That this Ordinance is hereby declared to be an emergency measure made necessary to protect the health, safety and welfare of the Village of Belle Center, Ohio, provide for its continuous uninterrupted services, and to prohibit the owning, keeping, harboring, and permitting of certain animals, to limit the number of chickens and rabbits within the Village, and to impose conditions on the keeping of same at the earliest possible time, and it shall, therefore, be in force and take effect immediately upon its passage and signature by the Mayor.





723.04 Change of name, vacating or narrowing streets on petition. The legislative authority of a municipal corporation, on petition by a person owning a lot in the municipal corporation praying that a street or alley in the immediate vicinity of such lot be vacated or narrowed, or the name thereof changed, upon hearing, and upon being satisfied that there is good cause for such change of name, vacation, or narrowing, that it will not be detrimental to the general interest, and that it should be made, may, by ordinance, declare such street or alley vacated, narrowed, or the name thereof changed. The legislative authority may include in one ordinance the change of name, vacation, or narrowing of more than one street, avenue, or alley. The original ordinance or a certified copy thereof shall be recorded in the official records of the county recorder.

**AN ORDINANCE PROVIDING COMPENSATION AND EMPLOYING A VILLAGE
SOLICITOR FOR THE VILLAGE OF BELLE CENTER, LOGAN COUNTY, OHIO,
FOR A ONE-YEAR TERM BEGINNING JANUARY 1, 2025 AND ENDING
DECEMBER 31, 2025 AND DECLARING AN EMERGENCY IN THE VILLAGE OF
BELLE CENTER, OHIO.**

WHEREAS, the legislative authority of the Village of Belle Center, Ohio deems it necessary to employ counsel for the Village under the authority granted in Ohio Revised Code Section 733.48; and

WHEREAS, Madyson S. Stratton, Attorney at Law, Bellefontaine, Ohio, has made application for employment as Village Solicitor for the Village of Belle Center, Ohio; and

WHEREAS, the council of the Village of Belle Center, Ohio finds the above-named applicant duly qualified for the position of Village Solicitor for the Village of Belle Center, Ohio.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Belle Center, Logan County, Ohio, that:

SECTION 1: Madyson S. Stratton, Attorney at Law, Bellefontaine, Ohio, shall be, and hereby is, employed as Village Solicitor of the Village of Belle Center, Ohio, for a one-year term beginning January 1, 2025 and ending December 31, 2025.

SECTION 2: The annual salary for the position of Solicitor of the Village of Belle Center, Ohio, shall be Nine Thousand and 00/100 Dollars (\$9,000.00), and shall be payable in twelve (12) monthly installments, in the amount of Seven Hundred Fifty and 00/100 Dollars (\$750.00) per month, payable on the second Tuesday of each month. In addition to the foregoing, the Village of Belle Center shall pay all costs involved to maintain Madyson S. Stratton's enrollment in the Public Employees Retirement System (OPERS). In the event the Village of Belle Center requires legal counsel beyond the usual scope of a Village Solicitor (attending one council meeting per month, drafting Ordinances and Resolutions, and the review and drafting of basic contracts), Madyson S. Stratton shall be paid her prevailing hourly rate for legal work, as an independent contractor.

The solicitor shall be supervised by and shall coordinate through the Mayor all of her services on behalf of the Village. The Mayor shall also, arrange for the provisions of office space or equipment, if required, by the solicitor to perform her duties for the Village. The Solicitor's attendance is required at One Village council meeting per month, unless otherwise directed by the Mayor.


In the event Madyson S. Stratton should become unable to perform services of Solicitor of the Village, then, in that event, the Village shall employ another attorney to complete and perform those services.

SECTION 3: Any time incurred beyond sixty (60) hours will be billed to the Village by Thompson, Dunlap & Heydinger, Ltd. ("TDH Law"), directly, as an independent contractor at the contract rate of \$175.00 per hour for all time incurred in after, and in excess of, sixty (60) hours. The Village will be invoiced monthly for said time upon its accrual.

SECTION 4: This council finds and determines that all formal actions of this council, concerning and relating to the passage of this Ordinance, were taken in an open meeting of this Council, and that all deliberations of this council and of any committees that resulted in those formal actions, were in meetings open to the public in compliance with the law.

SECTION 5: That this Ordinance is hereby declared to be an emergency measure made necessary to protect the health, safety and welfare of the Village of Belle Center, Ohio, provide for its continuous uninterrupted services, and to allow for the hiring of said Village Solicitor at the earliest possible time: and it shall, therefore, be in force and take effect immediately upon its passage and signature by the Mayor.


