We offer a minimum of three half sessions per week and do not offer half days for children under two years old.

All day sessions must include either a Monday or a Friday.

We offer a discount rate for our full-time children (five days per week – full days).

* Funding covers childcare only and therefore meals, snacks, consumables, or additional activities are charged separately.

Fees & Funding

We are proud to offer a range of government-funded childcare entitlements alongside clear and transparent fee structures to support families

Funding Entitlements

Universal 15 Hours Funding (3 & 4 Year Olds). All three and four-year-olds are entitled to 15 hours of free early education per week, funded by the government for 38 weeks of the year (term time). Children become eligible from the term after their third birthday.

Our funded nursery education sessions are: 8:00am – 1:00pm, **or** 1:00pm – 6:00pm

Sessions can be taken as: Three half-day sessions, or One full day and one half-day session

30 Hours Free Childcare (Working Parents). Eligible working parents may be entitled to 30 hours of free childcare per week during term time (38 weeks per year).

We offer this funding and can stretch the hours across 12 months, allowing families to pay the same monthly amount for easier budgeting.

This funding is available for eligible working parents of children from 9 months old, starting from the term after your child turns 9 months.

Government Childcare Support

This government website outlines the different childcare support options available to help reduce childcare costs. Through the site, parents can apply for a **Government Childcare Account**, where you will receive: **£2 for every £8 you pay into the account towards your childcare costs.**

Meals, Consumables & Extra Activities

While funded nursery hours are provided free of charge, government funding does not cover: Meals and snacks, Consumables (such as nappies, wipes, creams, craft materials, etc.) and extra activities. Charges for these items will therefore apply.

Fees

Registration Fee:

Once a place has been offered, a **non-refundable registration fee of £50** is payable within **72 hours** to secure the place.

Deposit:

A deposit equivalent to one month's payable fees is required upon acceptance of a nursery place.

- The deposit will be **offset against your final month's fees** when your child leaves.
- The deposit will **not** be deducted from your first month's fees.
- To reclaim the deposit, you must:
 - Provide one month's written notice.
 - Ensure all outstanding fees are paid in full.

- Comply with all nursery terms and conditions.

If you withdraw your child during or at the end of the free settling-in sessions, you are still required to provide one month's written notice. Your deposit will be refunded provided no terms and conditions have been breached.

Fees Payable in Advance:

Fees are payable monthly in advance, due on the 1st of each month. Invoices are issued through our nursery management software, Famly.

If payment is not received by the 5th working day of the month, you will be contacted requesting immediate payment by debit or credit card.

Late Payment Charges

- £50 late payment charge after the 5th working day.
- £5 per day thereafter until payment is received.

If the outstanding balance (including late charges) is not cleared by the end of the month:

- Your child's place will be terminated.
- The debt will be referred to a collection agency.
- The deposit will not be refunded.

Calculation of Fees:

Fees are calculated over 51 weeks of the year.

- The nursery closes for one week at Christmas.
- Fees apply to all booked sessions, including:
 - Bank holidays
 - Up to 5 INSET (staff training) days per year

There are **no refunds** for: Holidays, Sickness, absences for any reason. Booked sessions remain payable whether your child attends or not. If the nursery is required to close due to circumstances beyond our control (such as infectious diseases or environmental factors like snow), fees will not be refunded.

Sibling Discount:

We offer a 10% sibling discount, which:

- Applies to the older sibling's fees.
- Continues only while both siblings attend.
- Reverts to full fees once the older sibling leaves the nursery.

Late Collection Charges

Late collection is charged at: **£5 per 5 minutes** beyond your child's booked session time.

Notice Period or Reducing Sessions

One month's written notice is required to reduce the number of sessions your child attends.

If less notice is given, you will still be charged your usual fees during the notice period, whether the sessions are used or not.

Leaving the Nursery

One month's written notice is required before your child leaves.

If less notice is provided, payment for the full notice period will still be required.

Changes to Fees

The nursery reserves the right to increase fees at any time by giving 28 days' written notice.

Please note that fees may change between your initial visit and your child's start date. We recommend requesting the current fee schedule prior to your child starting with us.
