1 WHEREAS, the Court has designated the above listed action as the Lead Action for all
2 related cases (collectively the “Palisades Fire Cases”);

3 WHEREAS, the Court has designated the Lead Action and all related cases as complex
4 within the meaning of the California Standards of Judicial Administration for Complex Litigation
5 Section 3.10, and California Rule of Court (“Rule”) 3.400 (specifically, Rule 3.400(b)(2), (b)(3),
6 and (b)(4)), and Rule 3.502;

7 WHEREAS, the Court has consolidated the Palisades Fire Cases for pre-trial purposes
8 only;

9 WHEREAS, Liaison Counsel for Individual Plaintiffs filed a Master Complaint on October
10 8, 2025, and a Revised Master Complaint on December 1, 2025, in the Lead Action (“Revised
11 Master Complaint”);

12 WHEREAS, the Court entered Case Management Order No. 3 (“CMO 3”) on March 26,
13 2026, Section VIII.B of which provides: “The Parties shall meet and confer regarding procedures
14 for depositions of Plaintiffs at a later stage of discovery. However, within 30 days of the entry of
15 this order, Liaison Counsel for the Individual Plaintiffs shall identify any Individual Plaintiff who
16 may may [sic.] need to have their testimony preserved due to health considerations or other
17 extenuating circumstances. The Parties agree that Individual Plaintiffs who present such concerns
18 may be deposed before the Parties devise an agreed deposition protocol for the Individual
19 Plaintiffs.”

20 WHEREAS, Liaison Counsel for Individual Plaintiffs, Liaison Counsel for Subrogation
21 Plaintiffs, Liaison Counsel for Public Entity Plaintiffs (collectively, “Plaintiffs”), and Counsel for
22 Defendants listed in **Exhibit B** (together with Plaintiffs, the “Parties”) met and conferred and are
23 in agreement for an order to be entered by the Court based upon the stipulation below (“CMO 4”)
24 regarding the procedures for depositions of plaintiffs who may be eligible for preference pursuant
25 to Code of Civil Procedure section 36 or may need to have their testimony preserved due to health
26 considerations, but all Parties are retaining and reserving their rights to seek a modification of
27 CMO 4 by mutual agreement should it prove problematic or unworkable in practice due to
28 unforeseen issues;

1 WHEREAS, the Parties intend to negotiate a deposition protocol covering depositions of
2 Individual Plaintiffs other than Putative Preference Plaintiffs (as defined below) at a later stage of
3 this case;

4 NOW THEREFORE, the Parties, by and through their respective undersigned counsel and
5 subject to the approval of the Court, hereby agree as follows:

6 **I. GENERAL PROVISION**

7 Nothing in this CMO 4 is intended to or does supersede the Case Management Order filed
8 on April 23, 2025 (“CMO 1”), the Case Management Order filed on December 2, 2025 (“CMO
9 2”), or CMO 3 in this matter, unless otherwise noted.

10 **II. PUTATIVE PREFERENCE/PRESERVATION PLAINTIFF DISCOVERY**

11 **Purpose.** Certain Individual Plaintiffs may meet the criteria set out in C.C.P. 36(a)(2)
12 because of their health and age (i.e., plaintiffs over 70 years of age with health issues), or
13 otherwise require preservation of their testimony (collectively, “Putative Preference Plaintiffs”).¹
14 Attached hereto as **Exhibit A** is the present list of Putative Preference Plaintiffs.

15 **Accelerated Discovery Procedure.** Putative Preference Plaintiffs may elect an
16 accelerated discovery schedule with the goal of preserving the testimony of these Individual
17 Plaintiffs. The Parties shall attempt in good faith to schedule the oral deposition of the Putative
18 Preference Plaintiff within 60 days of service by a Putative Preference Plaintiff of his or her
19 completed Plaintiff Fact Sheet, Liability Questionnaire—including any applicable Defendant-
20 specific addendums—and Damages Questionnaire (the “Pre-Deposition Discovery”). Putative
21 Preference Plaintiffs may complete the Pre-Deposition Discovery at any time after it becomes
22 available in the BrownGreer portal and prior to the deadline for all Plaintiffs to complete the
23 discovery enumerated in CMO 3. The Parties will attempt in good faith to schedule depositions of
24 Plaintiffs who are acutely at risk due to their age or health as soon as practicable. This provision
25 does not apply to deposition by written question.

27 ¹ Defendants do not believe that C.C.P. 36(a) should or does apply to the Palisades Fire Cases. By
28 agreeing to and engaging in the process set forth in this CMO, Defendants are not conceding that
C.C.P. 36(a) applies. Defendants reserve all rights to oppose any C.C.P. 36 motion or petition.

1 For a Putative Preference Plaintiff to avail himself or herself of this accelerated discovery
2 schedule, that person shall serve a notice (“PPP Notice”) via Case Anywhere informing all Parties
3 (a) that the Putative Preference Plaintiff is listed in Exhibit A to this CMO; (b) that the Putative
4 Preference Plaintiff has completed the Pre-Deposition Discovery, and the date of completion; and
5 (c) of any dates of unavailability to be deposed in the 90 day period after the notice is served. No
6 Putative Preference Plaintiff may serve a PPP Notice until that person has completed the Pre-
7 Deposition Discovery.

8 **Discovery Disputes.** If a discovery dispute arises, the parties shall first meet and confer
9 amongst themselves and, if they do not come to an agreement regarding any issue identified
10 regarding the sufficiency or completeness of a Putative Preference Plaintiff’s response to Pre-
11 Deposition Discovery, then any such dispute shall be raised by an expedited Informal Discovery
12 Conference with the assigned Judge or appointed Discovery Referee, to be requested within three
13 (3) court days of the dispute arising, and heard on shortened time, if the Court’s or Discovery
14 Referee’s schedule allows.

15 **Deposition Protocol.** The parties desire to advance the preservation protocol
16 expeditiously, and the parties shall endeavor to conduct a reasonable number of depositions of
17 Putative Preference Plaintiffs each calendar week, not to exceed 10 per week, bearing in mind that
18 certain Putative Preference Plaintiffs may require that her or his deposition be spaced out across
19 multiple days.

20 One Defendant shall serve as the “lead” party taking the deposition of the Putative
21 Preference Plaintiff, however, at the conclusion of the lead’s questioning, any other Defendant has
22 the right to question the Putative Preference Plaintiff.

23 Testimony given at a deposition taken pursuant to this CMO is preserved for use at trial
24 subject to Code of Civil Procedure section 2025.620 and the applicable rules of evidence. Except
25 as to objections premised on availability of the witness, the Parties reserve all objections to the
26 admissibility of such testimony, to be raised at or before trial.

27 **Plaintiffs Who Cannot Sit for Deposition.** Any Putative Preference Plaintiff who asserts
28 they cannot competently sit for oral deposition, shall serve via CaseAnywhere a declaration

1 supporting the reason.

2 Any Putative Preference Plaintiff who identifies that they cannot competently sit for
3 deposition shall waive their ability to testify at trial; if such a Putative Preference Plaintiff recovers
4 their ability to competently sit for deposition before trial, then counsel for such Plaintiff shall
5 promptly inform Defendants and the parties shall meet and confer about whether that Plaintiff's
6 deposition can be scheduled a reasonable amount of time before trial. Defendants reserve all rights
7 to contest whether a Putative Preference Plaintiff can competently sit for deposition and to testify
8 at trial. Counsel for the respective Individual Plaintiffs who identify that they cannot competently
9 sit for deposition shall also consider whether that person needs a guardian ad litem to act for them
10 in the litigation and whether a family member can testify at oral deposition to their experience and
11 shall meet and confer with Defendants on this issue as to specific plaintiffs.

12 **Challenging Designations.** Defendants reserve the right to challenge any Plaintiff's
13 designation as a Putative Preference Plaintiff. A Defendant may serve via CaseAnywhere a notice
14 challenging a Putative Preference Plaintiff designation. Counsel for Plaintiffs shall respond within
15 five (5) business days stating whether they will stipulate to withdraw the designation. If counsel
16 for Plaintiffs does not so stipulate, the matter will be addressed at the next Case Management
17 Conference.

18 **No Waiver.** This Stipulation governs only the matters covered herein regarding Putative
19 Preference Plaintiffs and does not limit, waive, or expand any Party's right to conduct full
20 discovery, including as to liability and common issues, in the ordinary course and within the
21 deadlines set by the Court. It does not govern procedures for Pre-Deposition Discovery or
22 depositions of Plaintiffs who are not Putative Preference Plaintiffs. Nothing herein constitutes a
23 waiver of any objection except as expressly stated, and entry into this Stipulation shall not be
24 construed as an admission by any Party.
