15 **TO ALL INTERESTED PARTIES AND THEIR ATTORNEYS OF RECORD:**

16 The Petitioners listed on the attached Addendum file this Petition against the STATE OF
17 CALIFORNIA and the CALIFORNIA DEPARTMENT OF PARKS AND RECREATION (the
18 “State”); COUNTY OF LOS ANGELES (the “County”), a government entity; MOUNTAIN
19 RECREATION AND CONSERVATION AUTHORITY, a government entity (“MRCA”), and
20 SANTA MONICA MOUNTAINS CONSERVANCY (“SMMC” and, collectively with the State,
21 County, and MRCA, the “Government Defendants”).

22 A Master Complaint was filed in this Court on December 1, 2025, against these same
23 Government Defendants for actions taken before, during, and after the Palisades Fire (the “Master
24 Complaint”). Like the named Plaintiffs in the Master Complaint, Petitioners also lost their homes and
25 sustained physical and emotional damages as a result of the Government Defendants’ actions, the full
26 extent of which will be proven at trial.

27 Pursuant to Government Code section 911.2(a), a claim against a public entity for injury to
28 person or to personal property must be presented in writing within 6 months of the accrual of the cause
of action. For example, Petitioners whose homes were damaged or destroyed by the Palisades Fire
on January 7 were required to file their government claims by July 7, 2025.

When an individual does not file a claim before the 6-month deadline to file government

1 claims for personal injury or damage to personal property, they must follow the procedures outlined
2 in Government Code section 911.4 by filing an application to present a late claim (a “Late Claim
3 Application”) along with a copy of the proposed claim to the relevant government entity. The
4 government entity may then either accept the Late Claim Application or deny it. Govt. Code §§ 901,
5 911.2. If the government entity fails to act on the Late Claim Application within 45 days of its
6 submission, the Application is deemed to have been denied. Govt. Code § 911.6(c).

7 In this case, each of the Petitioners filed Late Claim Applications after July 7, 2025 with the
8 Government Defendants. Petitioners’ claims specified their allegations against the Government
9 Defendants, and their Late Claim Applications explained why Petitioners reasonably based on
10 surprise, mistake, inadvertence, and excusable neglect failed to submit their claims by July 7, 2025,
11 as required by the code. The Late Claim Applications are attached to the Declarations of Christopher
12 Cummiskey (“Cummiskey Decl.”), William A. Daniels Jr. (“Daniels Decl.”), David J. Furtado
13 (“Furtado Decl.”), Ben Odell (“Odell Decl.”), Matthew Stumpf (“Stumpf Decl.”), James West (“West
14 Decl.”), and Sarkis Yenikomshuyan (“Yenikomshuyan Decl.”) filed concurrently herewith.

15 **Grounds for Relief**

16 The Late Claim Applications identified numerous facts that, taken together, required the
17 Government Defendants to accept Petitioners’ applications based upon their on surprise, mistake,
18 inadvertence, and excusable neglect. *See* Govt. Code § 946.6(c)(1). Specifically, each Late Claim
19 Application demonstrated that the untimely filing was due to a confluence of unfortunate events and
20 circumstances that impeded Petitioners' ability to timely file, including:

- 21 1. **Overwhelming daily demands:** The amount of work required to relocate and stabilize
22 Petitioners and their families, deal with insurance claims, and coordinate potential
23 rebuild/restoration/replacement of their property and lives was all-consuming.
- 24 2. **Extensive logistical burdens:** Petitioners had to relocate, settle into new locations, replace
25 destroyed personal property, obtain medical treatment, manage insurance claims and
26 financial matters, coordinate debris removal, and work with numerous building
27 professionals including architects, engineers, surveyors, and geologists.
- 28 3. **Psychological impact:** Since the fire, Petitioners have suffered from difficulties

concentrating, focusing, and completing tasks, along with emotional disruption and disorientation.

4. **Family health and wellbeing:** Petitioners' primary concern was the health and wellbeing of their families, each of whom was under considerable stress and uncertainty.

5. **Complete life upheaval:** The total destruction of Petitioners' lives as they existed before the fire.

6. **Mistake of counsel:** In a small number of instances, a mistake made by an attorney handling hundreds or thousands of government claim submissions resulted in the inadvertent omission of a Petitioner's claim from those filed before July 7, 2025. Such mistakes were immediately corrected upon discovery with the submission of a Late Claim Application.

(See Cummiskey Decl. Exs. 1-8, Daniels Decl. Exs. 1-2, Furtado Decl. Exs. 1-2, Odell Decl. Exs. 1-7, Stumpf Decl. Exs. 1-3, West Decl. Ex. 1, and Yenikomshuyan Decl. Exs. 1-3.)

Given these extraordinary circumstances resulting from the fire, the six-month deadline was far too short. Indeed, the fire was not brought under control until at the earliest January 31, 2025—twenty-four days after it began. Many Petitioners homes were completely destroyed. And for those whose homes were damaged, most of the Petitioners were not allowed back into the area for several more weeks. Many Petitioners were caught unaware given the enormous pressures they faced to care for their families and survive this horrendous ordeal. Upon discovering the deadline, Petitioners acted quickly to seek counsel to submit their claims and Late Claim Applications within the one-year period specified in Government Code § 911.4(b). These facts establish that the only reason Petitioners' claims were not timely filed was due to surprise, mistake, inadvertence, and excusable neglect.

Denial of Late Claim Applications

Despite the facts weighing heavily in favor of accepting the Late Claim Applications, the Government Defendants have accepted any of the Late Claim Applications as of the date of this Petition. This stands in contrast to Defendant the City of Los Angeles Acting By and Through the Los Angeles Department of Water and Power (the "City"), who informed Petitioners on December 8, 2025 that the City will send Petitioners a letter stating that Petitioners' Late Claim Applications are

1 accepted as filed. (Odell Decl. ¶ 6.)

2 By contrast, the Late Claim Applications at issue in the Petition were either denied by the
3 Government Defendants, deemed denied because no response was received within 45 days (Govt.
4 Code § 911.6(c)), or Petitioners have not yet received a response to their Late Claim Applications that
5 are still within the 45 days window before they are deemed denied. Petitioners met and conferred
6 extensively with the Government Defendants over the last several weeks in an attempt to resolve this
7 issue. (Odell Decl. ¶¶ 3-8.)

8 State. The State informed the Court in the November 10, 2025 Joint Status Conference
9 Statement, “There are a limited number of late claim applications for which a response could not be
10 processed within the requisite 45 day period and thus said applications were automatically denied by
11 per statute. Late claim applications with the required fee for which a response was provided within
12 45 days have been accepted.” However, Petitioners have not received any responses to their Late
13 Claim Applications from the State, and counsel for the State in this litigation have been unable to
14 inform Petitioners which, if any, of their Late Claim Applications have been accepted or identify
15 which claims were allegedly filed without the fee. In meet-and-confer discussions with attorneys
16 representing the State, Petitioners’ counsel were told that the Late Claim Applications were processed
17 by a different state agency and the Attorney General’s office would not be able to gather any
18 information about which Late Claim Applications have or will be denied. (Odell. Decl. ¶ 7.)

19 MRCA. MRCA has not provided a definitive response on whether they will accept the Late
20 Claim Applications. Petitioners received no response from MRCA on their Late Claim Applications
21 until December 3, 2025, when counsel for Petitioners were informed that “the MRCA Board approved
22 the late claim applications to the extent that the City and/or the State has agreed to accept late claim
23 applications (i.e., if there is some condition attached by the City and/or the State, the MRCA would
24 include that condition as well).” (Odell Decl. ¶ 8.) MRCA counsel reiterated on December 5, 2025
25 that “if there is an agreement as to late filing with the City and State, you will have the same agreement
26 the MRCA.” (*Id.*)

27 County. The County denied many Late Claim Applications and has not provided any response
28 to the remainder. (Cumiskey Decl. ¶¶ 7-8; Odell Decl. ¶¶ 13-15; Yenikomshuyan Decl. ¶¶ 3, 6.)

1 The County did not respond to numerous requests from Petitioners' counsel to meet and confer on
2 this issue. (Odell. Decl. ¶ 4.)

3 SMMC. SMMC has not provided any response to the Late Claim Applications they have
4 received. (Cummiskey Decl. ¶¶ 9-10.)

5
6 **Relief Requested**

7 In accordance with section 946.6 of the Government Code, Petitioners now bring this Petition
8 seeking relief from the requirements of Government Code § 945.4, and respectfully request that an
9 Order be entered relieving Petitioners from the claim filing deadline requirements and granting
10 Petitioners leave to file a Complaint within 30 days.

11 This Petition is based upon the accompanying Memorandum of Points and Authorities, the
12 Declarations of Christopher J. Cummiskey, David J. Furtado, William A. Daniels Jr., Ben Odell,
13 Matthew J. Stumpf, James West, and Sarkis Yenikomshuyan and the exhibits attached thereto, the
14 pleadings and papers on file in this action, those facts of which the Court may take judicial notice, and
15 on such further argument and evidence as may be presented at or before the hearing on this motion.

1 **MEMORANDUM OF POINTS AND AUTHORITIES**

2 **I. INTRODUCTION**

3 The Palisades Fire has become the worst urban conflagration in the history of Los Angeles,
4 having destroyed 6,837 homes and businesses, damaged another 973 structures, and killed 12 people.
5 According to a recent study, 5,058 single family homes, 135 multi-family residences, 361 mobile homes,
6 101 commercial buildings, 51 school structures and 6 church structures were destroyed in the Palisades
7 Fire.¹ Petitioners were victims of the Palisades Fire, which destroyed and upended virtually every
8 aspect of Petitioners' lives. The fire wiped away Petitioners' homes, cars, clothing, belongings,
9 photographs, family heirlooms, financial and other important economic documents, titles to their
10 homes, and a host of other immeasurable losses, in addition to destroying their sense of security and
11 physical well-being.

12 Due to these circumstances, which are outlined more fully below, Petitioners did not submit
13 their claims to the Government Defendants until after July 7, 2025. These circumstances applied equally
14 to all Petitioners, who all suffered the displacement and upending of their lives as a result of the fire.
15 Petitioners' inability to meet the six-month deadline for filing government claims for personal injury or
16 damage to personal property constitutes excusable neglect that is entitled to relief under the Government
17 Code. *See* Govt. Code § 946.6(c)(1). In a small number of instances, mistakes by attorney handling
18 hundreds or thousands of government claims resulted in the failure of some claims to be filed by July 7,
19 2025. This constitutes a mistake that is entitled to relief under the Government Code. *See* Govt. Code
20 § 946.6(c)(1).

21 Once a claimant makes a sufficient showing of "mistake, inadvertence, surprise, or excusable
22 neglect," as Petitioners have here, they are entitled to relief under Government Code section 946.6
23 unless the public entity proves prejudice to its defense of the claim by reason of the late filing. There
24 is no possible prejudice here to the Government Defendants. Petitioners' claims arise from the exact
25 same event, involve the same factual circumstances, and implicate the same governmental conduct
26 that is already the subject of tens of thousands of other government claims received by the Government
27

1 Defendants. The Government Defendants have been on notice of their potential liability for months,
2 and adding Petitioners' claims to the existing tens of thousands of others is entirely inconsequential
3 to the Government Defendants' ability to investigate and defend these matters. By contrast, if the
4 Court were to deny this Petition, the harm to Petitioners would be immense as they would lose the
5 opportunity to seek any recompense for personal injury and personal property damage against the
6 Government Defendants they allege are culpable for the devastation caused by the Palisades Fire.

7 Petitioners therefore submit this Petition seeking the opportunity to file claims in the Palisades
8 Fire Litigation. Accordingly, this Master Petition requests that the Court issue an Order pursuant to
9 Government Code Section 946.6 that relieves Petitioners from Government Code section 954.4 and
10 grants Petitioners leave to file their Complaints and/or adopt the relevant sections of the Master
11 Complaint within 30 days.

12 **II. LEGAL BASIS**

13 **A. The Statutory Framework for Late Claim Applications**

14 California's Government Claims Act recognizes that strict adherence to filing deadlines can
15 work an injustice on deserving claimants, and therefore provides a structured pathway for relief when
16 circumstances prevent timely filing. Government Code § 946.6 provides a vehicle through which
17 Petitioners can alleviate the harshness of strict compliance when such claims are presented by persons
18 with excusable neglect. *Segal v. Southern Cal. Rapid Transit. Dist.* (1970) 12 Cal.App.3d 509, 512.

19 When a claim required to be presented within six months under Government Code section
20 911.2 is not timely filed, a claimant may submit a written application to the public entity for leave to
21 present a late claim under section 911.4 (a "Late Claim Application"). This Late Claim Application
22 must be presented within a reasonable time not exceeding one year after the cause of action accrues,
23 and must state the reason for the delay. If the public entity denies the Late Claim Application—or
24 fails to act within 45 days, which constitutes a deemed denial under Government Code section
25 911.2(c)—section 946.6 authorizes the claimant to petition the Superior Court for relief from the
26 claim-filing requirements.

27 The Legislature never intended strict compliance with government claims statutes to operate
28 as an absolute bar to meritorious claims. Section 946.6 is a remedial statute intended "to provide

1 relief from technical rules that otherwise provide a trap for the unwary claimant,” and as such, it is
2 construed in favor of relief whenever possible. *See Cabamongan v. City of Long Beach* (1989) 208
3 Cal.App.3d 946, 950; *Ebersol v. Cowan, supra*, 35 Cal.3d at 435; *Viles v. California* (1967) 66 Cal.2d
4 24, 30-31; *Bettencourt v. Los Rios Comm. College Dist.* (1986) 42 Cal.3d 270, 276. The remedial
5 purpose of section 946.6 reflects a fundamental principle of California jurisprudence: technical
6 procedural requirements should not be allowed to defeat substantive justice when the circumstances
7 warrant equitable relief. As the California Supreme Court emphasized in *Viles v. California*, where
8 any doubts exist as to relief under section 946.6, an outcome where the action is heard on the merits
9 is preferred. *Viles*, 66 Cal.2d at 29, 32.

10 The court's role in evaluating these petitions is carefully circumscribed by statute.
11 Government Code section 946.6(c) mandates that the court shall relieve the petitioner from the claim
12 submission requirements if one or more specified grounds for relief apply. One of those grounds is
13 that the failure to present the claim was through “mistake, inadvertence, surprise, or excusable
14 neglect.” *See* Govt. Code § 946.6(c)(1). The California Supreme Court in *Ebersol v. Cowan* (1983)
15 35 Cal.3d 427, 435 defined “excusable neglect” as neglect which might have been the act or omission
16 of a reasonably prudent person under the same or similar circumstances.

17 Government Code section 946.6(d) requires the court to make an independent determination.
18 If relief is granted, the lawsuit must be filed within 30 days. Gov. Code § 946.6(e).

19 **B. The Petition Should Be Granted Because Petitioners’ Failure To Submit Claims**
20 **Within Six Months Was Due to Excusable Neglect or Mistake.**

21 A claimant who makes a sufficient showing of “mistake, inadvertence, surprise, or excusable
22 neglect” is entitled to relief under Government Code section 946.6 unless the public entity pleads and
23 proves prejudice to its defense of the claim by reason of the late filing. *Moore v. State of California*
24 (1984) 157 Cal.App.3d 715, 726. All Petitioners have made that showing.

25 **1. Petitioners Are Fire Victims Who Faced Overwhelming Burdens That**
26 **Constitute Excusable Neglect**

27 Excusable neglect entitled to relief under Government Code section 946.6 is “neglect that
28 might have been the act or omission of a reasonably prudent person under the same or similar

1 circumstances.” *Renteria v. Juvenile Justice, Dept. of Corrections & Rehab.* (2006) 135 Cal.App.4th
2 903, 910; *Ebersol v. Cowan* (1983) 35 Cal.3d 427, 435; *see also Han v. United States* (1995) 37
3 Cal.App.4th 549, 557-58. That standard is clearly met by Petitioners.

4 The Late Claim Applications presented by Petitioners detailed the confluence of
5 overwhelming burdens that consumed Petitioners' following the fire. (*See* Cummiskey Decl. Exs. 1-
6 8, Daniels Decl. Exs. 1-2, Furtado Decl. Exs. 1-2, Odell Decl. Exs. 1-7, Stumpf Decl. Exs. 1-3, and
7 Yenikomshuyan Decl. Exs. 1-3.) The impact of the fire on Petitioners' lives was incredible—the
8 amount of work Petitioners needed to perform daily to relocate and stabilize themselves and their
9 families, and to address insurance claims and coordinate potential rebuild, restoration, or replacement
10 of their property and lives, was all-consuming. *See id.* These were not ordinary life challenges—they
11 were the extraordinary demands of survival in the wake of catastrophic loss, demands that are
12 impossible to comprehend by anyone not directly impacted.

13 Petitioners had to simultaneously manage multiple critical tasks, including: relocating their
14 families; securing new housing in unfamiliar locations; replacing their possessions; obtaining medical
15 treatment for fire-related injuries and trauma; navigating complex insurance claims; addressing
16 financial crises; coordinating debris removal from their destroyed properties; working with numerous
17 building professionals including architects, engineers, surveyors, and geologists to plan rebuilding
18 efforts; and addressing significant mental and emotional difficulties, such as concentrating, focusing,
19 and completing tasks, that were directly caused by the displacement and complete destruction of their
20 lives as they existed before the fire. *See id.* Each of these tasks alone would be daunting; any
21 combination of them together, created an impossibly demanding daily existence. The complete
22 upheaval and destruction of Petitioners' lives, coupled with the loss of their homes and belongings,
23 created circumstances where even a reasonably prudent person would be unable to meet the six-month
24 filing deadline. *See Perez v. City of Escondido*, 165 F. Supp. 2d 1111, 1117 (S.D. Cal. 2001) (when
25 faced with “overwhelming circumstances,” the fact that claimant did not file claims within six months
26 constituted excusable neglect).

27 Given these extraordinary circumstances it is clear that Petitioners' failure to file timely
28 governmental tort claims was due to neglect. The uncontradicted evidence establishes adequate cause

1 for relief, and denial would constitute an abuse of discretion. The Court must therefore grant
2 Petitioners' Petition and permit them to proceed with their claims on the merits.

3 **2. Petitioners are Entitled to Relief When Late Claim Applications Were**
4 **Submitted Late Due to Mistake**

5 In a small number of instances, a Petitioner's claim was submitted after July 7, 2025 due to a
6 mistake by Petitioner's attorney or its attorney's vendor, such as inadvertently omitting one claim
7 from a large submission of government claims. (*See, e.g.,* West Decl. Ex. 1.) Courts routinely hold
8 that this type of attorney error constitutes a "mistake" that is entitled to relief from the claim
9 submission requirements of the Government Code. For example, in *Renteria v. Juv. Just., Dep't of*
10 *Corr. & Rehab.* (2006) 135 Cal. App. 4th 903, 907, a petitioner's claim was submitted late due to a
11 calendaring error in the attorney's office. The Court of Appeal held that under these circumstances,
12 the trial court abused its discretion when it denied the petition. *See id.* at 912; *see also Nilsson v. City*
13 *of Los Angeles* (1967) 249 Cal. App. 2d 976, 983 (same). Courts have similarly held that petitions
14 must be granted by the Court when the lateness of the claim was due to circumstances such as a
15 mistake by the attorney in calculating the appropriate deadline to file claims, *see Segal v. S. California*
16 *Rapid Transit Dist.* (1970) 12 Cal. App. 3d 509, the attorney's "failure to open a file which in turn
17 would have reminded them" of the deadline, *see Flores v. Bd. of Supervisors* (1970) 13 Cal. App. 3d
18 480, 483, or an attorney's failure to properly identify a potentially liable public entity before the
19 deadline despite a diligent investigation, *see Kaslavage v. W. Kern Cnty. Water Dist.* (1978) 84 Cal.
20 App. 3d 529, 536.

21 Here, counsel for Palisades Fire victims were collectively responsible for submitting tens of
22 thousands of government claims to multiple public entities prior to July 7, 2025. It is unsurprising
23 that in a few isolated instances, attorneys inadvertently led to claims being submitted after the six-
24 month deadline for claims relating to personal injury or damage to personal property. These mistakes
25 are entitled to relief under Government Code section 946.6(c)(1) and should not foreclose Petitioners
26 to from filing claims seeking the full extent of their damages caused by the Palisades Fire.

1 **C. The Government Defendants Will Not Be Prejudiced By Granting This Petition**

2 Once a petitioner demonstrates that the failure to present a timely claim was through mistake,
3 inadvertence, surprise, or excusable neglect, the burden shifts to the public entity to establish by a
4 preponderance of the evidence that it would be prejudiced if the court relieves the petitioner from the
5 claim presentation requirements. *Cabamongan v. City of Long Beach* (1989) 208 Cal.App.3d 946,
6 950. Petitioners have made the requisite showing of excusable neglect. The burden therefore rests
7 squarely on the Government Defendants to prove prejudice—a burden they cannot possibly meet
8 under the circumstances of this case.

9 The Government Defendants will not be prejudiced in the slightest by granting this Petition.
10 The Government Defendants have been on notice since the first Palisades Fire claims were submitted
11 that they would face potential liability for their actions and inactions related to the fire. The
12 Government Defendants have had the opportunity and in many cases certainly have been actively
13 investigating the Palisades Fire’s causes, preserving evidence, and preparing to defend against
14 claims for months. Petitioners’ claims arise from the exact same event, involve the same factual
15 circumstances, and implicate the same governmental conduct that is already the subject of tens of
16 thousands of other government claims received by the Government Defendants, as well as extensive
17 investigation and litigation. The Government Defendants have ample knowledge of the factual basis
18 for the multitude of government claims and lawsuits filed against them related to the Palisades Fire.
19 Adding Petitioners’ claims to the existing tens of thousands of Palisades Fire claims against the
20 Government Defendants is entirely inconsequential to the Government Defendants’ ability to
21 investigate and defend these matters.

22 The traditional concerns that animate the prejudice analysis are entirely absent here. No
23 discovery has been conducted in any related litigation; nor liability discovery nor damages discovery
24 specific to any individual plaintiff. No trial dates have been set. No witnesses’ memories have faded
25 beyond what has already occurred for all Palisades Fire victims. No evidence has been lost that would
26 not equally affect all claims arising from the fire. The Government Defendants are in precisely the
27 same position to defend against Petitioners’ claims as they are to defend against the thousands of other
28 Palisades Fire claims that they received from claimants.

1 Whenever possible, relief should be granted, as it is the policy of the Legislature and the courts
2 that claims for injury should be tried on their merits and not rejected on harsh technical grounds. *See*
3 *Cabamongan v. City of Long Beach* (1989) 208 Cal.App.3d 946, 950; *Ebersol v. Cowan* (1983) 35
4 Cal.3d 427, 435; *Viles v. California* (1967) 66 Cal.2d 24, 30-31; *Bettencourt v. Los Rios Comm.*
5 *College Dist.* (1986) 42 Cal.3d 270, 276.

6 Here, denying relief would serve no legitimate governmental interest. The Government
7 Defendants cannot claim surprise, cannot claim loss of evidence, and cannot claim any impediment
8 to mounting an effective defense. Denying relief would simply bar meritorious claims on a procedural
9 technicality—precisely the outcome the remedial provisions of section 946.6 were designed to
10 prevent. Moreover, the harm to Petitioners if relief was denied would be severe. If the Petition is
11 denied, Petitioners, who suffered immense personal injury and lost much or all of their personal
12 belongings in the Palisades Fire, would be left unable to seek any recovery for personal injury and
13 personal property damage against the Government Defendants.

14 **D. The Court Should Grant the Petition As to All Petitioners Immediately, Including**
15 **Those With Pending Claims**

16 Certain of the Petitioners whose Late Claim Applications are the subject of this Petition seek
17 approval to file claims even though the claims have not been denied, either formally or because the
18 45 day response time has elapsed.² Relief is required for all Petitioners immediately, including as to
19 those Petitioners whose Late Claim Applications have not been officially denied by action or inaction
20 because the 45-day period to approve has not run. These Petitioners should not have to wait any
21 longer for a response and, for the reasons set forth below, potentially risk losing their right to certain
22 damages.

23 The prejudice that would result from not permitting all Petitioners to file their lawsuit now is
24 real, because if Petitioners do not file their complaints in the Palisades Fire Litigation until after
25 January 1, 2026, under current law, to the extent these Petitioners obtain a judgement for pain,

1 suffering, or disfigurement and then die before it is final, that judgment may not be recoverable by
2 their estate or successor-in-interest. Cal. Civ. Proc. Code §§ 377.30 and 377.34 govern survival
3 actions and allow a decedent's estate to recover damages the decedent incurred before death, such as
4 medical expenses, lost earnings, and property losses. In general, such actions exclude damages for
5 pain, suffering, or disfigurement. However, California Senate Bill 447, enacted in 2022, temporarily
6 expanded the scope of noneconomic survival damages under Cal. Civ. Proc. Code § 377.34,
7 permitting estates to recover a decedent's damages for pain, suffering, or disfigurement for survival
8 actions so long as the claims were filed between January 1, 2022, and January 1, 2026. Beginning in
9 2026, however, this provision will sunset, and an estate may no longer be allowed to recover pain,
10 suffering, and disfigurement in survival actions. As a result, unless Petitioners with reduced life
11 expectancies file their lawsuits in connection with the Palisades Fire by the end of the year, their estate
12 may be unable to recover noneconomic damages they have suffered as a result of the fire in the event
13 of their passing before the resolution of the Palisades Fire Litigation.

14 The Court, therefore, should extend relief to all Petitioners, including those whose claims have
15 not yet been formally denied, based on its inherent equitable powers. The Government Defendants
16 have not, as of the date of this Petition, granted any Late Claim Applications and there is no reason to
17 believe that the Late Claim Applications that are still pending will be treated differently than the
18 dozens that preceded it – in other words, they will eventually be denied or deemed denied. Moreover,
19 at least one Government Defendant – MRCA – has indicated it has no intention of individually
20 assessing the Late Claim Applications. (*See* Odell Decl. ¶ 8 (MRCA informed Petitioners it will
21 follow the lead of the City and State with respect to accepting or denying Late Claim Applications.))

22 As a result, Petitioners request that the Court include all Petitioners in its order granting this
23 Petition, and authorize them to file their complaints immediately even if the 45-day period for the
24 Government Defendants to review their Late Claim Applications has not concluded. Doing so would
25 not be improper, as illustrated by several cases holding that when government claims were submitted
26 to public entities according to statute but were prematurely filed in court before being ruled on, this
27 constitutes substantial compliance with the claims presentation requirement. In *Bahten v. County of*
28 *Merced* (1976) 59 Cal. App. 3d 101, a petitioner submitted an application for leave to file a late claim

1 and four days later filed a complaint, which alleged the same claim that was the subject of its pending
2 late claim application. The public entity did not act on the late claim application, resulting in it being
3 deemed denied 45 days later. *Id.* at 103. The petitioner then filed a petition for relief with the Superior
4 Court, which was granted. *Id.* at 104. The public entity demurred to the complaint, arguing that it
5 did not state a cause of action because the claim requirements of the Government Code had not been
6 complied with at the time the complaint was filed. The Court of Appeal disagreed, holding the
7 “prematurely filed complaint” satisfied the requirements of the Government Code. *Id.* at 107. *Bell v.*
8 *Tri-City Hospital Dist.*(1987) 196 Cal. App. 3d 438, 443-44 similarly held that a prematurely filed
9 complaint, which was already on file before the conclusion of the government claim process, properly
10 stated a claim against the public entity defendant. *See also* State of California v. Superior Ct. (2004)
11 32 Cal. 4th 1234, 1244, (“In those cases where the plaintiffs submitted a timely claim but prematurely
12 filed a complaint, the courts refused to dismiss the action because the plaintiffs had substantially
13 complied with the claim presentation requirement.”). Granting authorization for the Petitioners whose
14 claims have not yet been deemed denied to file their complaints now would thus not run afoul of the
15 requirements of the Government Code, and would ensure such Petitioners can preserve their right to
16 all currently-available damages.

17 **III. CONCLUSION**

18 For the reasons stated above, the Petitioners respectfully request that the court grant the
19 Petition, issue an order relieving Petitioners from section 945.4 of the Government Code, and permit
20 them to file their complaints within thirty days, in accordance with Government Code section 946.6
