Plumbing & Water Conditions Agreement

This Addendum is attached to and forms an integral part of the Purchase Agreement.

1. Water Chemistry & Supply Variability (City & Well)

Customers acknowledge that municipal (city) or private well water quality fluctuates naturally due to environmental factors, municipal treatment changes, or water table shifts beyond Hydro Solutions' control. Fluctuations in hardness, chlorine, Total Dissolved Solids (TDS), raw sodium, sulfates, iron, sulfur, pH, sand, or sediment may affect post-treatment mineral appearance, cause white salt/scale residue on fixtures, or accelerate required equipment maintenance, filter changes, and media replacement. Equipment conditions water per standard manufacturer design specifications but does not alter underlying baseline source water chemistry beyond system parameters.

2. Pre-Existing Plumbing, Scale & Corrosion

Hydro Solutions is not responsible or liable for pre-existing, ongoing, or subsequent mineral build-up, hard water scale, pipe corrosion, pinhole leaks, sediment, or physical degradation of household piping (copper, galvanized, PEX, brass, or lead), fixtures, faucets, valves, or water heaters. Water treatment equipment does not repair existing pipes or reverse prior corrosion. Hydro Solutions assumes no liability for plumbing clogs, fixture blockages, or water damage caused by pre-existing pipe scale, debris, or sediment breaking loose after installation.

- Ambient weather exposure, freezing temperatures, extreme heat, or acts of nature; or
- Failure of the customer to place the equipment in system bypass during home plumbing repairs, main line flushes, or boil-water advisories.
