Putt's Camp Reservation Fees and Payment Schedule - 2025

Whenever you fill out the Reservation-Agreement of Use Form to reserve your stay at Putt's Camp you are the Lessee and you will fill in your name or your organization's name at the top of the form. Next you fill in the date you are arriving at camp and the date you are departing.

Your Total Camp Fee is composed of a \$100.00 Security Deposit, the Camping Fee and the Facilities Fee.

CAMP FEE:

The Camping Fee is a minimum \$120/night for up to 20 persons. Any campers over this will be charged an additional \$6.00/night/person.

FACILITY FEE:

ADIRONDACK SHELTERS FEES: If you are camping EACH Adirondack Shelter's fee is \$15.00/night. If you are camping for a week each Adirondack Shelter's fee is \$75.00/week. A week is a maximum of 7 nights.

DAY USE FEE and ONE (1) NIGHT CAMPING FEE FOR BIKERS or HIKERS: If you are NOT CAMPING and wish to use the Pavilion for one (1) day, the fee is \$125.00/day.

CAMPER PAVILION FEE: PAVILION FEES: If you are camping and want electricity at the Pavilion, the fee is \$25.00/day. If you are camping for a week the Pavilion fee with electricity is \$125.00/week (7 consecutive days).

The One (1) night Camping Fee for Bikers and Hikers passing through the area is \$10.00/night/person with no Facilities.

EXCLUSIVE USE OF PUTT'S CAMP BY YOUR GROUP:

If you so desire, when you lease Putt's Camp and you do not want anyone else in camp, while you are there, you can pay an Exclusive Use Fee and then you have exclusive use of the camp while you are Camping there. We have established an Exclusive Use Fee for Putt's Camp based on fifty (50)/persons/night for a weekend stay or week-long stay.

A WEEKEND STAY will be three (3) days, usually arriving on Friday and leaving on Sunday, but could be any three (3) consecutive days and the fee will be \$880.00. This includes up to fifty (50) persons staying for three (3) days and camping for two (2) nights along with the use of the Pavilion and the two (2) Adirondack for three (3) days. If you have more than fifty (50) persons camping, the number over fifty (50) will be charged \$12.00 each, for the two (2) nights, which will be collected when you check-in.

A WEEK-LONG STAY will be eight (8) days usually arriving on Saturday and leaving on Saturday and the fee will be \$2,700.00. This includes fifty (50) persons camping for seven (7) nights and the use of the Pavilion and Adirondack Shelters for eight (8) days. If you have more than fifty (50) persons camping, the number of persons over fifty (50) will be charged \$42.00 each [Fee for the seven (7) nights], which will be collected when you check in.

ALL PERSONS CAMPING OR USING THE CAMP FOR A DAY, HAVE ACCESS TO THE POTABLE WATER AND THE REST ROOMS (Latrine).

CANCELLATION POLICY: Once you have made a reservation and decide you want to cancel your reservation, it must be cancelled at least fifteen (15) days before your arrival date at camp, to give us time to rent the camp to someone else and you will be refunded the Total Camp Fee you paid. If you cancel within the fifteen (15) days before your arrival at camp, you will be assed 50% of your Total Camp Fee.

Once you compute your Total Camp Fee, you will be required to submit that Total Camp Fee along with your <u>SIGNED</u> Reservation-Agreement of Use Form. Be sure to <u>SIGN</u> the Reservation-Agreement of Use Form as it is a binding Legal Agreement between you and the Friends of Raystown Lake. Your Total Camp Fee may be paid by check or Money Order made out to <u>Putt's Camp FRL</u>. We do not accept credit cards.
