LYSS Academy Riding

Thank you for choosing Lindsay Yinger Show Stables, where we focus on creating a welcoming barn family with a focus on safety and horsemanship as well as riding skills. All of our students progress through our levels. In addition, Our students can attend our unmounted horsemanship lessons once monthly. Please read through our welcome packet where you will find our price list, annual calendar, and copy of our riding school agreement. Let your instructor know if you have any questions. We are looking forward to you and your family joining our barn family!

We operate on an annual term of 46 weeks on, 6 weeks off, throughout the year to give the lesson horses a break, and receive vet work. It will allow students to plan holidays without missing lessons and to provide one pre scheduled make-up day in the event we have to cancel lessons. The weeks that are off will be communicated via the attached calendar and available on our website. In the event that the weather prevents riding – unmounted horsemanship lessons will be substituted. In the event that weather prevents the barn from being open – video analysis of your riding or via zoom horsemanship lesson may be substituted at your regular riding time.

Introductory Lesson - \$100.00 Introduction lesson, to include tour of the facility, overview of safety rules and procedures, grooming, tacking up, riding time, untacking and time to schedule your next lesson. Helmets will be provided for the first lesson. After that we require that each student have their own fitted helmet and appropriate riding boots.

Academy Riding 1x a week - \$360.00/mo. Includes access to 1 lesson a week on pre schedule days and time stable will hold unmounted horsemanship lessons as often as 1 time per month. Please note LYSS Academy operates on an annual schedule of 46 weeks on 6 off. No discounts will be given for missed lessons. Lessons canceled within 24 hours of scheduled lessons will be forfeited. Students may reschedule up to 2 lessons per trimester with advanced notice and approval of stable. Option to lease and ride the same horse every lesson for an additional \$125/mo.

Riding School 2x a week - \$700.00/mo. Includes access to 2 lessons a week on pre schedule days and time stable will hold unmounted horsemanship lessons as often as 1 time per month. Please note LYSS Academy operates on an annual schedule of 46 weeks on 6 off. No discounts will be given for missed lessons. Lessons canceled within 24 hours of scheduled lessons will be forfeited. Students may reschedule up to 2 lessons per trimester with advanced notice and approval of stable. Option to lease and ride the same horse every lesson for an additional \$225/mo.

LYSS Camp Info

Camp \$395/week - Our camps run from 10 am to 3:00 pm - 4 days a week. In our camps we cover horsemanship skills, craft time, riding time, hands on grooming and tacking up, basic skills needed to take care of a horse. We take water and snack breaks as needed and lunch time.

We also offer 1 day camps for kids to have the opportunity to get a taste of the horse life.

Other Programs Available at LYSS

IEA- Requires 1 day a week Academy program at the minimum. However, we strongly recommend 2 lessons per week & participation in IEA practices which are offered during the IEA season @\$65 per student. Practices are typically scheduled on Fridays after school hours. IEA season runs from Aug 15-March 1. Post season shows are by qualification only. Regionals, Zones, Nationals.

Lyss Charges a team membership fee when you join our IEA team of \$150 per student per season.

IEA student membership is also required to be completed on the IEA website. rideiea.org
The cost is \$65 per student. Paid directly on the website.

Leasing- Access to horse showing on a regional/national level. Half leases begin at 3 days a week and allows you access to jump over 18 inches or what is appropriate for you and your horse. Half lease prices start at \$850 and vary depending on horses ability. Half leases require a split of shoeing and vet bills in addition to lease fee. Lesson fees will be on an a la carte basis during lease period.

Full leasing/Owning- Full access and availability to lessons and shows. . On a Regional and National program. This requires the owner and lessor to pay all expenses on the horse, and have full access to lessons/schedule/showing/ practice rides.

Barn Rules

1. Leave the area or item in better condition than you found it. That is a great rule of thumb for all things in life!
2. Clean up after yourself and your horse.
3. Every client must sign a release form before handling or participating in any horseback activity.
4. Minors must be accompanied by an adult if a trainer is not present.
5. All riders must wear an ASTM approved helmet while mounted.
6. A lead rope must be used at all times while leading a horse.
7. Hair must be tucked up under the helmet neatly, with a hair net.
8. Always be prepared to ride with a crop and have spurs available.
9. Breeches and boots are preferred during riding lessons. However, long pants and heeled boots are required.
10. Please groom your horse thoroughly checking for any cuts, swellings, loose shoes, ect. before and after riding. Always pick your horses feet! Allow 30 mins before and after riding. Groom your horses sweat marks after riding, paying special attention to their faces and between legs.
11. Towel off horse's legs after a bath/shower so he gets put away with completely dry legs.
12. Tack should be wiped clean and tied up correctly after each use.
13. Take pride in your appearance. Polish your boots and come to the barn in respectfully dressed. No spaghetti straps, belly shirts, or offensive language please. No hooded or oversized shirts during lessons. No flip flops while handling horses. Collared shirts or polo's are recommended.
14. No jumping outside of a lesson unless advised to do so by your instructor. No trail riding alone or without someone knowing your whereabouts.
15. No outside dogs allowed off leash at any time. Dogs can be in your car with the AC on or windows down in appropriate weather. Please clean up after your dog.
16. No Smoking!!!!!!!!!!!!!!!!!!!!!!
17. Please drive slowly on the driveway, speed limit **less than 5-10** mph.
18. Please clean and sweep your area after use. Wash down the wash rack when finished and roll up the hose.
19. Please feel free to speak to us if you have a question or concern. We are always willing to listen, and will do our best to help.
20. Have fun with your horse!!!!!!!!!!!!!!!!!!!!!!

Additional School Horse Rules

1. Ask questions, No question is stupid, and you usually learn if you ask.
2. Please realize that using the school horses and tack is a privilege, not a right.
3. Use the brushes provided. That means the curry comb, then dust brush then finishing brush, don't forget faces and legs. Put brushes away in the buckets.
4. Be sure that hoofs are picked well, before and after each ride. This is very important for the horses' soundness.
5. Use boots or polos on the horses as needed. Clean them if they are dirty. Ask if you need help.
6. Use a half pad on each horse under the saddle.
7. Clean all the sweat marks from the horses. Don't forget faces & girths.
8. Please clean all tack after riding, including school saddles. This is also a good time to inspect equipment for safety. Tie up bridles after cleaning and hang up girth, martingale and bridle on the correct hook.
9. Sweep up after yourself and your horse.
10. Return things in better shape than you found them; i.e, the horse, brushes and tack.
11. Allow yourself plenty of time before and after your lesson to properly care for the horse and equipment. Plan on 30 mins before and 30 mins after.
12. In winter, un-blanket your horse in the stall or in the cross-ties. When you are done be sure that the correct blankets are on and the straps are secure. Back leg straps should be crossed. Ask if you need help.
13. In summer, please roll up the hose and turn off the water after showering your horse. Scrape him down. Towel his legs and return him with his legs completely dry. This is a great time to hand graze.

The Client and LYSS agree as follows:

- The Services.** Stable will provide the Student with ____ riding lesson(s) per week and one unmounted horsemanship class per month. Stable operates on an annual term of 46 weeks on with 6 weeks off throughout the year to give the lesson horses a break and allow students to plan holidays without missing lessons and to provide pre scheduled make-up days in the event we have to cancel lessons.
- Student Requirements** Student agrees to follow all Barn Rules as follow:
 - Courtesy is expected and manners are required. Help us make the farm a fun, friendly and supportive environment for all! Be nice to others, both people and horses, NO exceptions. Social media posts must be LYSS approved.
 - All riders or persons handling a horse must sign a release before riding and/or interacting with any horse in any way. Students/Student's parent(s)/guardian(s) are responsible for having all guests sign releases which are available in the Stable's office.

- ASTM-rated riding helmets must be worn at ALL times when mounted on a horse.
 - NO smoking allowed on the Stable premises at any time.
 - NO Dogs or pets on the Stable property. (They may remain in the car, at all times, with a window open or AC on).
 - The speed limit on the Stable property is 5-10 MPH for the safety of horses, riders and children.
 - Children must be supervised by an adult at all times.
 - Appropriate footwear MUST be worn around horses and when handling them, no sandals or flip flops in the barn. NO exceptions.
 - NO jumping outside of a lesson unless approved by the trainer.
 - We prefer that no treats are given. If you must give treats only to your horse and in feed buckets and not by hand.
 - Clean up after your horse and yourself. There are trash containers, shovels, brooms and muck buckets available for the disposal of manure, shredded hair, hoof cleanings.
 - If you don't do it at home....don't do it at the Stable. Common sense and courtesy at all times! Please treat the barn as if you are in my home.
3. **Annual Membership Fee** - \$=25/per trimester. This is for supplies needed to care for your horse. Fly spray, saddle soap, Shampoo, and the like. 1 time charge per semester.
4. **Tuition.** Monthly tuition is based on annual value. Client is required to provide Stable with a valid credit or debit card which will be kept on file and automatically charged:
_____ Lesson Package 1 (1 mounted and 1 unmounted lesson a week) \$360/month
_____ Lesson Package 2 (2 mounted and 1 unmounted lesson a week) \$700/month
_____ Lesson horse \$125 a month to ride the same lesson horse 1x weekly or \$225 for 2x weekly lessons.
- Tuition is due on the first day of enrollment and is due the same day each following month. Students are responsible for providing stable with updated/current credit card information for their account if this information changes.
5. **Scheduling.** Students will receive a dedicated time and a day of the week where there will be an appropriate school horse and group of riders with similar ability. Please remember that Stable operates on an annual term of 46 weeks on and 6 weeks off throughout the year. Stable must pay all costs for the number of school horses needed to teach the scheduled lessons. As a result, stable's expenses stay the same, regardless of whether the student's lesson is taken. Therefore, stable does not offer a discount for missed lessons. Lessons canceled within 24 hours of scheduled lessons will be forfeited. Students may reschedule up to 2 lessons per semester, with approval of stable. The best way to get the most value out of the program is to make it a priority and a

commitment not to miss your dedicated lesson time(s). All lessons canceled by Stable due to unforeseen weather or other circumstances will be rescheduled. If Student would like to make a long-term change to his/her dedicated lesson time, he/she may do so ideally no more than of 1 time in a trimester period, providing Stable with written notice of Student's requested change.

6. **Cancellation.** This Agreement may be canceled by either party with at least **30** days written notice prior to the desired date of termination, however, no refunds will be given.
7. **Additional Services.** Additional services (listed below) requested by the Student and which Stable agrees to perform will be automatically charged to the Student's credit/debit card on file at the time of service at the following rates* below:
Additional Lessons outside of lesson agreement: \$100/per lesson, horse usage included.
8. **No Guarantee.** Stable does not warrant or guarantee any specific level of performance or results. The results of your riding program are largely based on the Student's efforts.
9. **Communications.** Student agrees to communicate all scheduling changes or any other concerns about the program by texting/emailing

Risks including but not limited to bodily injury and/or death from using, riding or being in close proximity to horses. The undersigned understands that horses are unpredictable and that both horse and rider can be injured in supervised or unsupervised activities in and around horses including but not limited to the following:

- A) The propensity of an equine to behave in ways that may result in injury, death, or loss to persons on or around the equine;
- B) The unpredictability of an equine's reaction to sounds, sudden movement, unfamiliar objects, persons, or other animals;
- C) Hazards, including, but not limited to, surface or subsurface conditions;
- D) A collision with another equine, another animal, a person, or an object;
