

Two main problems: Student Safety and Financial Impropriety.


Fixing it from the inside and outside.

We used Lawful Transparency to resolve both issues.

In 2020, then-Attorney General Josh Shapiro said the 44<sup>th</sup> Investigating Grand Jury recommended criminal charges for the former Scranton Superintendent, the retired Chief operating officer, and the then-head of maintenance for failing to protect their students from lead and asbestos exposure.




