# BYLAWS <br> OF <br> METHOW RIVER RANCH PHASE 11 <br> HOMEOWNERS ASSOCIATION 

## ARTICLE 1

## Name and Location

The name of the corporation is Methow River Ranch Phase II Homeowners Association ( MRR2 ), hereinafter referred to as the "Association." The principal office mailing address of the Association will be P.O. Box 66593 Burien, WA 98166, but meetings of members and directors may be held at such places within the State of Washington, as may be designated by the Board of Directors.

## ARTICLE 11

## Definitions

The terms used in these Bylaws shall have the same meaning as those used in the Declaration of Covenants, Conditions and Restrictions for Methow River Ranch Phase II (the "Declaration"), recorded under Okanogan County Auditor's File No. 3089392, and as amended from time to time. In the event there is a conflict between the terms and requirements of these Bylaws and the Declaration, the Declaration shall control.

## ARTICLE 111

## Meetings of Members

Section 1. Annual Meetings. The first annual meeting of the Members shall be held at the discretion of the original Directors within one (l) year from the date of incorporation of the Association. Thereafter, annual meetings shall be held on the anniversary of such date in each succeeding year, or on such date as approved by a majority of the membership if they decided the annual meeting should be held on another date for each succeeding year.

Section 2. Special Meetings. Special meetings of the Members may be called at any time by the President. a majority of the Directors. or on written request of Members entitled to vote. in the aggregate, ten percent $(10 \% / 6)$ of the votes.

Section 3 Notice of Meetings. Written notice of each meeting of the Members shall be given by. or at the direction of. the Secretary or person authorized to call the meeting, by hand delivery or by mailing a copy of such notice. postage prepaid. at least twenty-one (21 ) days before but not more than sixty' (60) days before such meeting to each member entitled to vote at the meeting, addressed to the Member's address last appearing on the books of the Association, or supplied in writing by such member to the Association for the purpose of notice. Such notice shall specify the place, day. and hour of the meeting, and the items on the agenda to be voted on by the Members, including the general nature of any proposed amendment to the Declaration. Articles of Incorporation. or Bylaws, changes of a previously approved budget that result in assessment obligations, and any proposal to remove a Director or officer. All meetings shall be held at such place as is convenient for the Members as determined by the Board of Directors.

Section 4 Quorum. The presence at the beginning of any meeting of Members entitled to cast thirty percent ( $30 \%$ ) of the votes of the Association shall constitute a quorum throughout that meeting for any' action.

Section 5. N[anner of Voting. At ali meetings of Members. each Member may V'Ote in person, by mail, or by proxy. There should be one voting agent for each entity that owns a Lot, as defined in the Declaration. An entity may include an individual. a marital community, a company or corporation or any other entity authorized to own real property in Washington State. Each entity owning rnore than one lot shall be entitled to one vote per lot owned. Such v'0ting agent shall be designated by the Owner or Ovyners of a Lot by written notice signed by' each party with an ownership interest. which notice shall be filed with the Secretary of the Board of Directors, The voting agent need not be an Owner. Any' designation of voting agent may' be revoked at any time by any one of the parties with an ownership interest in the Lot on written notice filed with the Secretary of the Board of Directors. Such designation shall be deemed revoked when the Secretary receives actual notice of the death or judicially declared incompetency of the Owner of the Lot. or of the conveyance of such ownership interest. When no designation is made. or where designation has been made and revoked and no nevv designation has been made. the voting agent shall be the person or group convosed of all Owners of that Lot who attend any meeting of the Association: however, ${ }^{\mathrm{e}}$ otes mas not be split by multiple Owners of a Lot. Thus. if multiple Owners cannot agree on a vote, their vote will not be counted on a vote of the Association membership, even though those may be counted for purposes of a quorum (as if abstaining). A proxy is void if it is not dated or purports to be revocable without notice. Unless stated otherwise in the proxy. a proxy terminates eleven (11) months after its date of issuance.

## ARTICLE [V <br> Board of Directors; Selection; Term of Office

Section 1. Number of Directors. The affairs of the Association shall be managed by a Board of Directors. The number of Directors which shall constitute the wholeBoard shall be no less than three (3) and no more than seven (7).

Section 2. Compensation. No Director shall receive compensation for any service rendered to the Association.

Section 3. Term of Office. The Directors shall serve terms of office for one y•ear, [n the event new elections are not held for any reason. the Directors last elected shall continue to serve until new elections are held.

Section 4. Removal. Any Director may be removed, with or without cause, upon the affirmative vote of a majority of the voting power of the Association present, in person or by proxy, at a properly called meeting at which a quorum is present.

## ARTICLE V <br> Standard of Care for Directors

Section 1. Standard. A Director shall perform the duties of a Director, including the duties as a member of any committee of the Board upon which the Director may serve, in good faith, in a manner such Director believes to be in the best interests of the Association, and with such care, including reasonable inquiry. as an ordinarily prudent person in a like position would use under similar circumstances.

In performing the duties of a Director, a Director shall be entitled to rely on information. opinions, reports, or statements, including financial statements and other financial data. in each case prepared or presented by':
(a) One or more officers or employees of the Association whom the Director believes to be reliable and competent in the matter presented;
(b) Counsel. public accountants. or other persons as to rnattet•s whichthe Director believes to be within such person's professional or expert competence: or.
(c) A committee of the Board upon which the Director does not serve, duly designated in accordance with a provision in the Articles of Incorporation or

Bvlaws. as to matters within its designated authoritv. which committee the Director believes to merit confidence: so long as. in anv such case. the Director acts in good faith. after reasonable inquiry when the need therefor is indicated by the circumstances and without knowledge that would cause such reliance to be unwarranted.

This section shall not apply where the consequences of an act. otuission, error. or negligence are covered by the insurance obtained bv the Board.

Section 2. Amendment. If the statutory standard of care is. at any time. different than the standard of care set forth in these Bylaws, the BY'laws shall be deemed amended so that the standard of care shall be that standard set forth statutorilv for nonprofit corporations in the State of Washington.

Section 3. Indemnification. Each person who was or is made a party to or is threatened to be made a party to or is involved (including. without limitation. as a witness) in any actual or threatened action, suit, or proceeding whether civil, criminal. administrative, or investigative, shall be indemnified and held harmless by the Association if that person is or was a Director of the Association. The person shall be indemnified if the basis of a proceeding is an alleged action occurring while the person was acting in an official capacity' as a Director. The Association shall indemnify and hold harmless to the full extent permitted by applicable law as then in effect, against all expenses, liability and loss (including, without limitation, attorney fees, judgments, fines. or penalties and amounts to be paid in settlement) actually or reasonably incurred or suffered by such person in connection therewith. However, no person shall be released from liability or indemnified (i) for acts or omissions which involve intentional misconduct by the Director or a known violation of law by the Director. or (ii) for any transaction from which the Director will personally receive a benefit in money, property or services to which the Director is not legally entitled. Further. no indemnification shall be provided under this Article to any such person if the Association is prohibited by the non-exclusive provisions of the Washington Non-Profit Corporation Act or other applicable law as is then in effect from paying such indemnification. The right to indemnification conferred in this section shall be a contract right and shall include the right to be paid by the Association the expenses incurred in defending any such proceeding in advance of its final disposition; provided, however, that the paytüent of such expenses in advance of the final disposition of the proceeding shall be made to or on behalf of a Director only on deliverv to the Association of a written agreetnent, bv or on behalf of such Director. to repay all amounts so advanced if it shall liltitüate[y be determined that such Director is not entitled to be indemnified under this Article or otherwise, which agreement may be unsecured and may be accepted reference to financial ability to make repayment.

## ARTICLE VI

## Meetings of Directors

Section 1. Regular Meetings. Regular meetings of the Board of Directors shall be held no less than one (1) time a year at such place and hour as may be fi.xed by the Board of Directors. Notice shall be given annually to the Members of next vear's meeting times.

Section 2. Special IVfeetings. Special meetings of the Board of Directors shall be held when called by the President of the Association, or by any Director, after not less than three (3) day'S notice to each Director. The meeting shall be held at the same place as the regular meetings. unless unavailable, in which event the President shall designate the place of the special meeting.

Section 3. Quorum. A quorum is deemed present throughout any meeting of the Board of Directors if a majority of the Board of Directors are present at the beginnin ${ }^{g}$ of the meeting. Members present through use of telephone shall be deemed present for purposes of a quorum. and may vote by telephone. Every act or decision done or made by a majority of the Directors present at a duly held meeting at which a quorum is present shall be regarded as an act of the Board.

Section 4. Onen Meetings. Except as provided in this subsection. all meetings of the Board of Directors shall be open for observation by all Owners of record and their authorized agents. The Board of Directors shall keep minutes of all actions taken by the Board. which shall be available to all Owners. Upon the affirmative vote in open Illeeting to assemble in closed session, the Board of Directors may convene in closed executive session to consider personnel matters; consult with legal counsel or consider communications W'ith legal counsel; and discuss likely or pending litization. matters involving possible v'iolations of the governing documents of the Association. and matters involvinz the possible liability of an owner to the Association. The motion shall state specifically the purpose for the closed session. Reference to the motion and the stated purpose for the closed session shall be included in the minutes. The Board of Directors shall restrict the consideration of matters during the closed portions of meetings only to those purposes specifically e.xempted and stated in the motion. No motion. or other action adopted. passed. or agreed to in closed session may become effective unless the Board of Directors. following the closed session. reconvenes in open meeting and votes in the open meeting on such motion. or other action which is reasonably identified. The requirements of this subsection shall not require the disclosure of information in violation of law or which is otherwise exempt from disclosure.

## ARTICLE

## V'll

## Powers and Duties of Board of Directors

Section I Powers. The Board of Directors shall have the power to do the following.
(a) exercise for the Association all powers, duties. and authority' vested in or delegated to this Association and not reserved to the membership by' other provisions of these Bylaws, the Articles of Incorporation, or the Declaration or as set forth in Ch. 64.38 RCW, as currently enacted or hereafter amended;
(b) as necessary to pursue the Association responsibilities. employ an independent contractor, or such other employ•ees as the Board deems necessary, and to prescribe their duties; and,
(c) enforce all covenants, restrictions, and conditions of the Declaration as amended (this power does not in any way reduce the power of any member to enforce such covenant, nor does it require enforcement unless the Board of Directors deems such enforcement necessary).

The Board shall not act on behalf of the Association to:
(a) amend the Declaration in any manner that requires the vote or approval of the Lot Owners;
(b) amend the Articles of Incorporation;
(c) take any action that requires the vote or approval of the Owners;
(d) terminate the Association; or,
(e) elect members of the Board of Directors or determine the qualifications, powers. and duties. or terms of office of members of the Board of Directors; provided. however, that the Board of Directors mav fill vacancies in its membership for the unexpired portion of any terni.

Section 2. Duties. [t shall be the duty of the Board of Directors to do, in their discretion. as follows:
(a) keep a complete record of all its acts and corporate affairs and to present a statement thereof to the Members at the annual meeting of the Members.
or at any special meeting when such statennent is requested in writing by any one of the Members who are entitled to vote:
(b) supervise all officers. agents, and employees of this Association. and see that their duties are properly performed:
(c)as more fully provided in the Declaration. to do as follows:
(i) fix the annual budget at least forty-five (45) days in advance of each fiscal year;
(ii) send written notice of, and call a meeting of the ${ }^{M}$ embers to ratify the budget, at least fourteen (14) but not more than sixty (60) days in advance of the meeting;
(iii) file a lien if the assessment is not paid within sixty (60) days; and,
(iv) when deemed necessary, may foreclose on the lien after sixty (60) days but prior to three (3) years from date of assessment;
(d) issue, or to cause an appropriate officer to issue, on demand by' any person. a statement signed by the treasurer setting forth whether or not any assessment has been paid. A reasonable charge may be made by the Board for the issuance of such statement. [ f a statement states an assessment has been paid, such statement shall be conclusive evidence of such payment;
(e) enforce covenants as provided in the Declaration when deemed necessary by a vote of a majority' of the Directors (this power of enforcement is in addition to the powers of the enforcement OF any individual Owner);
(f)in the event of Common Areas, procure and maintain adequate liability and hazard insurance on property owned by the Association. [f available at a reasonable cost. maintain earthquake insurance on all Common Areas. Procure and maintain adequate liability insurance for the Directors OF the Board of Directors:
(g) tnaintain any Common Areas as set forth in the Declaration: and.

## ARTICLE

(h) perform any and all other functions which are necessarv for tuaintenance and continuance of the Association.

## Vlll

## Officers and Their Duties

Section 1. Enumeration of Officers. The officers of this Association shall be a president. vice president. secretary. and treasurer, who shall at all times be members of the Board of Directors. and such other officers as the Board may from time to time by resolution create.

Section 2. Election of Officers. The election of officers shall take place at the first meeting of the Board of Directors following each annual meeting of the Members.

Section 3. Term. The officers of this Association shall be elected annuallv bv the Board and each shall hold office for one (1) year, or until that officer's successor is elected. unless the officer sooner resigns, or shall be removed, or otherwise is disqualified to serve.

Section 4. Special Appointments. The Board may elect such other officers as the affairs of the Association may require. each of whom shall hold office for such period, have such authority, and perform such duties as the Board may. from time to time, determine.

Section 5. Resignation and Removal. Any officer may be removed from office with or without cause by' the Board. Any officer may' resign at any time by giving 'vvritten notice to the Board, the president, or the secretary. Such resignation shall take effect on the date of receipt of such notice or at any later time specified therein, and unless otherwise specified therein. the acceptance of such resignation shall not be necessary to make it effective.

Section 6. Vacancies. A vacancy in any office may be filled by appointinent by the Board. The officer appointed to such vacancy shall serve for the remainder of the term of the officer who is replaced.

Section 7. [Multiple Offices. The offices of secretary and treasurer mav be held by the same person.

Section 8. Duties. The duties of the officers are as follows•
(a) President. The president shall preside at all meetings of the Board of Directors: shall see that orders and resolutions of the Board are carried out: and shall sign all written instruments and promissory notes.
(b) Vice President. The vice president shall act in the place and stead of the president in the event of absence. inability. or refusal to act, and shall exercise and discharge such other duties as may be required by the Board.
(c) Secretarv. The secretary shall record the votes and keep the minutes of all meetings and proceedings of the Board and of the members: serve notice of meetings of the Board and of the members: keep appropriate current records showing the members of the Association together with their addresses: prepare. execute, certify and record Amendments to the Declaration on behalf of the Association; and, perform such other duties as required by the Board.
(d) Treasurer. The treasurer shall receive and deposit in appropriate bank accounts all monies of the Association and shall: disburse such Funds as directed by resolution of the Board of Directors: sign all checks and promissory notes of the Association; keep proper books of accounts; cause an annual audit of the Association books to be made by a public accountant whenever the annual assessment exceeds $\$ 50,000$, unless waived by sixty'-seven percent ( $67 \%$ ) of the Members; and. prepare an annual budget and a statement of income and e.xpenditures as set forth above. The desired time for preparation shall be prior to the tegular annual meeting so that the budget and statement can be presented to the membership at its regular annual meeting. ARTICLE IX

## Committees

The Board of Directors shall appoint such committees as it deems appropriate in carry'ing out its purpose.

## ARTICLE X

## Books and Records

The books. records. and papers of the Association shall at all times. during nonual business hours as determined by the Board. be subject to inspection by any Member. holder of a mortgage on a Lot. and their tespective agents on reasonable advance notice. The Declaration. the Articles of Incorporation. and the Bylaws of the Association. shall be available For inspection by any IMember at the office of the Secretarv OF the Association. where copies may be purchased at reasonable cost.

## ARTICLE

## Amendments

Section 1. Bvlaws. These Bylaws may be amended with the written approval of a majority of the Directors. Any amendment shall be signed by' the approving Directors and copies shall be delivered to all Members within thirty (30) days of adoption.

Section 2. Conflict. [n the case of any conflict between the Articles OF Incorporation and these Bylaws, the Articles shall control: and in the case of anv conflict between the Declaration and these Bylaws. the Declaration shall control.

## ARTICLE Xll

## Indemnification of Directors and Officers

Section L Right of Indemnification, The Association shall indemnify its Directors and Officers against all liability', damage, or expense resulting from the fact that such person is or was a Director or Officer, to the maximum extent and under all circumstances permitted by' law.

Section 2 Effect on Other Rights. The right to indemnification and the payment of expenses incurred in defending a proceeding in advance of its final disposition conferred in this Article shall not be exclusive of any other right which any person may have or hereafter acquire under any statute, prov'ision of the Articles of Incorporation, By-lcmws, agreement. vote of shareholders, or disinterested Directors or otherwise.

Section 3. Insurance. The Association may rnallltatn Insurance. at Its expense. to protect itself and any Director. officer. employee. or agent OF the Association or another association. partnership. joint venture. trust. or other enterprise against any expense, liability. or loss. whether or not the Association would have the power to indemnify such person against such expense. liability. or loss under the Washington Nonprofit Corporation Act. The Association may enter into contracts with any Director or officer of the Association in furtherance of the provisions of this Article and Imay create a trust Fund. grant a security interest. or use other tneans (including. without lirnitation. a letter of credit) to ensure the payment of such amounts as may be necessary to effect indemnification as provided in this Article.

Section 4. Advance Pavment. The Association niav. bs action of its Board of Directors from time to time. provide indemnification and pay expenses in advance of the final disposition of a proceeding to employees and agents of the Association with the same scope and effect as the provisions of this Article with respect to the indemnification and advancement of expenses of Directors and officers of the Association or pursuant to rights
granted pursuant to, or provided by, the Washington Nonprofit Corporation Act or otherwise.

## ARTICLE Xlll

## Transactions Involving Directors

Section 1. Transactions. No contracts or other transactions between this Association and any other corporation, and no act of this Association shall in any way be affected or invalidated by the fact that any Director of this Association is pecuniarily or otherwise interested in, or is a trustee, director, or officer of, such other corporation.

Section 2. Disclosure. Any Director, individually, or any firm of which any Director may be a member, may be a party to, or may be pecuniarily or otherwise interested in, may be a party in any contracts or transactions of the Association; provided, that the fact that such Director or such firm is so interested shall be disclosed to or shall have been known by the Board of Directors or a majority thereof.

## Article XIV

## Attorney Fees

Should any dispute arise regarding the terms of these Bylaws, the Declaration, the Articles of Incorporation, or the Rules and Regulations of the Association, the prevailing party shall recover reasonable attorney fees and costs, including those for appeals.

## ARTICLE XV

Venue
Venue, for the purposes of these Bylaws, shall be Okanogan County, Washington.

## ARTICLE XVI

## Fiscal Year

The fiscal year of the Association shall be a calendar year, unless determined otherwise by the Board of Directors.
