UNDER KENTUCKY LAW, A FARM ANIMAL ACTIVITY SPONSOR, FARM ANIMAL PROFESSIONAL, OR OTHER PERSON DOES NOT HAVE THE DUTY TO ELIMINATE ALL RISKS OF INJURY OF PARTICIPATION IN FARM ANIMAL ACTIVITIES. THERE ARE INHERENT RISKS OF INJURY THAT YOU VOLUNTARILY ACCEPT IF YOU PARTICIPATE IN FARM ANIMAL ACTIVITIES.

By signing a Nazareth Stables boarding agreement, Nazareth Stables liability waiver, and/or visiting the premises of Nazareth Stables, you hereby agree to the following rules:

# **NAZARETH STABLES BARN RULES**

### **Conduct:**

- The farm is open to boarders from 7 a.m. to 9 p.m. Please notify the barn owner if you will be on the farm outside these hours.
- Any concern, question, request or complaint should be directed to the barn owner.
- NO smoking, vaping, or any drug use allowed on or near the property at any time.
- Do not borrow tack or equipment that is not yours without prior permission.
- Do not handle another boarder's horse without their permission.
- Do not give treats to horses other than your own, unless approved by the owner.
- No dogs allowed.

## Safety:

- All visitors (including but not limited to guests of boarders and outside trainers) are required to sign a liability release waver before handling or riding any horse on the property.
- All Boarders, Visitors, Trainers, Instructors, Students and Staff are required to wear an ASTM-approved helmet when mounted on a horse (NO EXCEPTION) for pleasure and instruction.
- Appropriate attire (long pants and closed toed shoes) must be worn while riding.
- It is the responsibility of parents/guardians to supervise their children at all times when on the farm.
- Do not permanently store items on the floor in the barn aisleway.
- Always ride in control and be courteous of other riders around you. Remember to look out for less experienced riders, especially in the arena.
- When riding in fields, watch out for groundhog holes and other marked and unmarked obstacles.
- If a gate is shut when you go through it, please shut it back behind you.
- Be respectful of the property residents and do not ride in resident yards or general home areas, especially near home doors or vehicles.

### **Use of Facilities**

- No volunteer/trainer/instructor/equine professional (whether paid or unpaid) is permitted to
  use these facilities without prior permission from the management, and if permission is
  granted the user must present a certificate of Liability Insurance Coverage of a minimum
  \$1,000,000.00, with Nazareth Stables, LLC and Jena & Wesley Scott as additional named
  insured on the policy.
- If you give someone else permission to visit/handle/ride your horse when you are not on the farm, please let the barn owner know ahead of time. These visitors MUST sign a Nazareth Stables Liability Release Waiver before they may handle or ride any horse.
- Clean up any messes that you or your horse make, whether in the barn or the arena.
- If your horse is tied or crosstied in the aisle and another horse needs to pass, you must safely move your horse so the other can pass through.
- Please do not waste water; turn off water after use and use buckets whenever possible. Please coil hoses when you are done using them, and drain them before coiling in the wintertime.
- Please turn off all lights (outdoor light, aisle, tack room) if you are the last person in the barn.
- Please notify management of any necessary repairs, maintenance, problems, or needed supplies so that repairs may be made or problems remedied as soon as possible.
- Any damage done to the barn, stalls or other facilities by your horse will be repaired at the
  horse owner/boarder's expense. Horses that crib or chew wood are required to wear a cribbing
  strap or muzzle at the owner's expense.

### **Horse Care**

- Horses are fed twice daily. To request a feed change, please discuss the change with the barn owner. Do not help yourself to extra feed, hay or shavings without prior permission.
- Horses may not be moved to a different paddock at any time without the notification and permission of the barn owner. The barn owner reserves the right to make any and all turnout decisions.
- Please notify the barn owner immediately of any injury or sickness detected in any horse on the property.
