Personal Data We Collect

We only collect data that helps us achieve the purpose set out in this Privacy Policy. We will not collect any additional data beyond the data listed below without prior notification.

Data Collected Automatically

When you visit and use our Site, we may automatically collect and store the following information:

1. IP address;

2. Location;
3. Hardware and software details;
4. Clicked links; and
5. Content viewed.

Data Collected in a Non-Automatic Way

We may also collect the following data when you perform certain functions on our Site:

1. First and Last Name;
2. Email address;
3. Phone number;
4. Address; and
5. Files uploaded.

This data may be collected using the following method(s):

1. Contact request.

How We Use Personal Data

Data collected on our Site will only be used for the purposes specified in this Privacy Policy or indicated on the relevant pages of our Site. We will not use your data beyond what we disclose in this Privacy Policy.

The data we collect Automatically and Non-Automatically when the user performs certain functions may be used in the following purposes:

1. Assist law enforcement and respond to subpoena;
2. Compile anonymous statistical data and analysis for use internally or with third parties;
3. Create and manage your account;
4. Email you regarding your account;
5. Generate a personal profile about you to make future visits to the Site more personalized;
6. Increase the efficiency and operation of the Site;

How Long We Store Personal Data

User data will be stored until the purpose the data was collected for has been achieved.

How We Protect Your Personal Data

In order to protect your security, we use the browser encryption as provided by the Site's host. All of our data is stored on servers in secure facilities. All data is only accessible to employees of our organization who require data access to perform the functions of their position. Our employees are bound by strict confidentiality agreements and a breach of this agreement would result in the employee's termination.

Children
