# THE LANDIS SEWERAGE AUTHORITY REGULAR MEETING August 3, 2020

Pledge of Allegiance.

The regular meeting of the Landis Sewerage Authority was called to order by Chairman Reuben at 6:00 p.m. The following members were present at roll call: Barse, Merighi, Villar, Errickson and Reuben were present.

It was moved by Villar and seconded by Barse that the reading of the minutes of the regular meeting held on July 20, 2020 be dispensed with and the same be approved in the form submitted to all members by mail. Roll call: Barse, Merighi, Villar, Errickson and Reuben voted "yes".

The Chairman asked if there were any general public comments or comments on the proposed Resolutions. There were none.

#### **Resolutions:**

It was moved by Errickson and seconded by Barse that Resolution No. 2020 - 77, "Be it resolved by the Landis Sewerage Authority, that the following bills of items or demands are hereby approved and authorized for payment out of the Revenue Fund Revolving Payroll Account.... \$81,303.08", be adopted. Roll call: Barse, Merighi, Villar, Errickson and Reuben voted "yes".

It was moved by Errickson and seconded by Barse that Resolution No. 2020 - 78, "Be it resolved by the Landis Sewerage Authority, that the following bills of items or demands are hereby approved and authorized for payment out of the Revenue Fund Bills.... \$355,102.97", be adopted. Roll call: Barse, Merighi, Villar, Errickson and Reuben voted "yes".

It was moved by Errickson and seconded by Barse that Resolution No. 2020 - 79, "A Resolution of the Landis Sewerage Authority authorizing the Executive Director to join a collation to contest the NJDEP new rules on PFOA/PFOS/PFNA..." be adopted. Roll call: Barse, Merighi, Villar, Errickson and Reuben voted "yes".

# Executive Director

Dennis Palmer reported that we are transitioning into the Edmonds Package for finance for our computers. The staff has had several days of training as part of accounts receivable, accounts payable, general ledger, billing and payroll. We will be transitioning this week on some of the programs.

Dennis has talked to Steve Barse, most of our supervisors and most of our staff about the State travel advisory and also PFOA/PFOS issues. Also, our guys have gone out to Brookfield Street. We have a bad line there so we want to eventually go out and advertise for that.

#### Solicitor:

Stephen Barse reported that he and Dennis worked together last week regarding the Opioid litigation. We will see where that goes. The attorney that we consulted with was very helpful. We made sure we had the appropriate information. So that has been done and there is really nothing for us to do. We filed 2 days before the deadline. We filed about \$60,000 worth of potential claims. The attorney said we may or may not hear from them. It may be small enough that they give us something or we won't know for months. Stephen and Dennis also talked about the travel ban on going to other designated states and have to quarantine when you return. They will have to use PTO time in order to get paid. Dennis said we are inserting a flyer in employee's paycheck this week listing the states that are on the current list. The list of designated states changes from day to day. We will deal with this on a case to case basis. Everything is in a state of flux.
