It was moved by Barse and seconded by Merighi that Resolution No. 2021 - 63, "A Resolution of the Landis Sewerage Authority authorizing correction on credits, charge-offs and refunds and cancellation of accounts in the amount of \$10,722.03..." be adopted. Roll call: Barse, Merighi and Reuben voted "yes".
