# What's New?

Increased Treatment Access Model

As of April 1, 2025 Stonybrook Center, Inc. will be moving to a new open access model for intakes and assessments for medidication assisted treatment services! In order to increase access to treatment, Stonybrook Center, Inc. will be offering walk-in assessments on Tuesday and Thursday mornings.

In order to qualify, clients must first complete a pre-screening via phone. Upon approval, clients can then present to the clinic for walk-in services on a Tuesday or a Thursday. In order to be guaranteed an assessment spot for the day, clients must present to the clinc between 6a-6:15a. The latest a walk-in will ever be accepted is 8a.

As a reminder, intake/assessments for medication assisted treatment services take approximately 4.5 hours to complete from start to finish so clients should come prepared to spend a good portion of their day at the clinic. Stonybrook Center, Inc. does offer snacks and beverages to clients participating in the intake/assessment process.
