- 3) Town Clerk Report:
 - Community Garden fence is up and gates are in place. Fen Dek did a great job.
 - Eastern Health Clinic has suspended blood collection in Mount Carmel and St. Mary's temporarily.
 - There were three submissions for the Canada Day art contest so prizes were given to all three (\$25.00 Toys R Us Gift Cards): Victoria Nugent, Ethan Dean and Kendall Nash
 - Received a complaint from a resident on Marrie's Road that there are several roaming dogs which prevent her and other residents from putting their dogs out on leashes.
 - Had to place an emergency call to Squires Water Well Drilling Inc for a service call on the water pump downstairs. Pressure gauge had to be replaced. Total cost of \$301.36 (taxes incl). Thanks to Philomena and Kevin for looking after this.
 - A business in the Town has been having issues with Eastern Waste. They haven't been picking up their garbage and when they do, they are only taking 6 bags, as per allowances for businesses. The business owner is wondering how to arrange for extra garbage pick-up as they often have more than six bags, especially if none is picked up the week before. Eastern Waste has contacted the office to see if we are charging this business an additional fee to cover extra garbage. Apparently, this week they didn't pick up any of her garbage. The Clerk has advised the business that they need to contact ERSB directly, which she assured her she has been doing. Council advised that there is presently no mechanism in place to pay additional fees for extra garbage pick-up. This can be reviewed after the municipal election in September.
 - There has been a considerable increase in poll tax exemption requests this year.
- 4) Recreation Committee:
 - Council has received feedback from the Community Survey. Priority for trail development was identified as follows: Hurley's Bridge, Harricott Point, Garden Trail, D'Iberville Trail and Old Road, in that order. There were also five community members who expressed an interest in sitting on the Recreation Committee. Council decided to wait until after the September election to form a new Recreation Committee.

• Work on the playground is ongoing. There have been delays due to the non-availability of peastone but the contractor is hopeful work will be completed soon. The Clerk will research cost of playhouses vs having one built due to time constraints, etc.
