World War II

PFC – William Coleman - 21. Lost November 1, 1944, while clearing a booby trapped mine in the Forest of Gremecey in France, the mine exploded during the effort and Pfc. Coleman was killed in the blast. Accounted for January 25, 2022.

SSGT. Adolph Olenik - 19. Lost August 1, 2943, during Operation TIDAL WAVE, a bombing attack in Ploesti, Romania. SSG Olenik's B-24 Liberator was shot down over the target area. In 2007, the DPAA began exhuming unknown service for potential identifications. Laboratory analysis let to the identification on SSG Olenik. Accounted for January 26, 2022.

SSGT Grady Canup - 30. Lost November 14, 1944, during the Battle of Hűrtgen Forest. SSG Canup was in a fox hole that was hit by enemy artillery. He was killed and his remains could not be recovered. The DPAA recently reexamined a set of unknown remains that had been recovered in 1947. The remains were identified as SSG Canup. Accounted for January 26, 2022.

Pvt. Walter Wildman - 20. Lost November 14, 1944, during the Battle of Hűrtgen Forest. He was reported killed in action, because of the fighting, his body was unable to be recovered. The DPAA recently reexamined a set of unknown remains that had been recovered in 1947. The remains were identified as Pvt. Wildman. Accounted for January 26, 2022.

PFC – Edward Benson, Jr. -22. Lost March 22, 1946 when Japenese aircraft stafed Sorido Airstip in Indonesia. Two days later the remains of the personenel killed in the attack were buried at US Army Air Forces Cemetery Bosnik #1. These included remains of 37 service members and three unidentifed set of remains. Recent laboratory anlysis established on set of those remains belonged to PFC Benson. Accounted for January 31, 2022.

Pvt. Andrew Ladner – 30. Lost November 30, 1942 when his unit was was part of the Huggin Roadblock in New Guinea. In November 2016 the DPAA disentered the unknowns associated with the campaign, Ladner was identified as one of those remains. Accounted for July 2021. Announced February 3, 2022.

1st Lt. Richard Horrigan – 24. Lost April 19, 1945 his P-47D Thunderbolt crashed behind enemy lines in Germany. In June 2019 History Fligh, Inc., a nongprofit organization excaveted the site. They recovered remains later identified as Lt. Horrigan. Accounted for August 19, 2021. Announced February 9, 2022.

Navy Storekeeper 1st Class Harry Walker – 36. Lost December 7, 1941, during the attack on Pearl Harbor – USS Oklahoma. Accounted for March 9, 2021. Announced February 10, 2022.

Fireman 1st Class George Price – 23. Lost December 7, 1941, during the attack on Pearl Harbor – USS Oklahoma. Accounted for August 3, 2021. Announced February 14, 2022.

Electrician's Mate 1st Class Harvey Herber – 34. Lost December 7, 1941, during the attack on Pearl Harbor – USS Oklahoma. Accounted for July 22, 2021. Announced February 15, 2022.

Army 1st Lt. Myles Esmay – 21. Lost June 7, 1944 when his unit was taking part in the siege of Myitkyin, Burma. In April 2019 unknown remains from the Punchbowl in Hawaii were disentired. Laboroaty analysis identified on set of those remains as Lt. Esmay. Accounted for May 2021, Announced February 22, 2022.

1st Lt. John Heffernan – 24. Lost February 22, 1944 while on a bombing mission in a B-25G in Burma when his plane burst into flames and crashed. In 2020 recovery teams found possible human remains and eveidence at the site of the crash. The remains were identified as Lt. Heffernan. Accounted for November 2, 2021. Announced February 22, 2022.

Seaman 1st Class James Ward – 20. Lost December 7, 1941, during the attack on Pearl Harbor – USS Oklahoma. Accounted for August 19, 2021. Announced February 22, 2022.

Navy Chief Water Tender Claude White - 40. Lost December 7, 1941, during the attack on Pearl Harbor – USS Oklahoma. Accounted for January 4, 2021. Announced February 25, 2022.

Korea

PFC, Kenneth Bridger. Lost November 27, 1950, after his unit was attacked by enemy forces near Chosin Reservoir, North Korea. Pfc. Bridger was reported missing in action. In 2018, Korea returned to the U.S. custody fifty-five boxes containing remains of service members killed during the Korean war. Laboratory analysis let to the identification of PFC. Bridger. Accounted for January 26, 2022.

Corporal Donald Menken. Lost June 10, 1953, while defending Outpost Harry near Surang-ni, North Korea. In 1953 a search team recovered two sets of remains from near Outpost Harry. In 2019 a family request prompted the disinterment of those remains. Laboratory analysis established the remains as those of CPL Menken. Accounted for February 2, 2022.

Cpl. Lawrence Brown – 21. Lost March 31, 1951, as a Prisoner of War Camp #5 in the vicinity of Kujang, North Korea. Accounted for February 14, 2022.

Corporal Francis Jury – 23. Lost December 2, 1950, when his unit was attacked by enemy forces near Chosin Reservoir. In June 2018, the DPRK turned over 55 boxes of remains to the US. Laboratory analysis let to the identification of Cpl. Jury from among the remains. Accounted for February 10, 2022.

Cpl. William Zoellick – 18. Lost February 27, 1951, after being captured by Chinese People's Volunteer Force on November 30, 1950. He died February 27, 1951, as a Prisoner of War in Prison Camp #1 Ch'angsong, North Korea. Accounted for February 22, 2022.

Sgt. Roy Delauter – 21. Lost December 2, 1950, when his unit was attacked by enemy forces near Chosin Reservoir. In June 2018, the DPRK turned over 55 boxes of remains to the US. Laboratory analysis let to the identification of Cpl. Jury from among the remains. Accounted for January 18, 2022. Announced February 23, 2022.
