**Finance Officer:** Current Post Account Balance \$187,707.11; Lottery Account 50,487.39; Maintenance Account 3,351.01; Operating Cash - \$6528.68 = total assets of \$248,074.19. Upcoming expenditures: \$6,500 – drainage line for parking lot. HVAC repair \$693.00; Replacement for computer \$1,400.00.

Copier Contract for 5 years is \$16,694 provides 1,000 black and white and 400 color copies, extra charges if we go over. The contract increases 6% annually have 18 months left. Contacted by new company that says they can buy off the contract and get us a better deal. Will be contacting current company and see if they can get us a better deal.
