#### The Battle of Hamburger Hill Vietnam War - May 11-20, 1969

The Battle of Hamburger Hill was a battle of the Vietnam War which was fought between the United States and South Vietnam against the North Vietnamese forces from May 10-20, 1969. Although Hill 937 was of little strategic value, U.S. command ordered its capture by direct assault.



The battle took place on Dong Ap Bia( Ap Bia Mountain) in the rugged, jungle-shrouded mountains of South Vietnam, 1.2. miles from the Laotian border. Rising from the floor of the western A Shau Valley, Ap Bia Mountain is a looming, solitary massif, unconnected

to the ridges of the surrounding range. It dominates the northern valley, towering some 937 meters above sea level. The entire mountain is a rugged, uninviting wilderness blanketed in doubleand triple-canopy jungle, dense thickets of bamboo, and waisthigh elephant grass that in some cases was taller than an M113 Armored Personnel Carrier. Local Montagnard tribesmen called Ap Bia "the mountain of the crouching beast." Official histories of the

engagement refer to it as Hill 937, but the American soldiers who fought there dubbed it "Hamburger Hill", suggesting that those who fought on the hill were "chewed up like a hamburger" This also pays homage to a similar fight during the Korean War known as the Battle of Pork Chop Hill.



The U.S. lost 56 men and had 420 wounded during the Battle of Hamburger Hill; the North Vietnamese lost over 600 men. After a long and difficult battle, the U.S. and South Vietnamese were victorious and Hill 937 was secured. However less than fifteen days later orders were given to abandon Hamburger Hill. The sacrifices had provided no advantage.

The media covered the Battle of Hamburger Hill and the subsequent withdrawal extensively and questioned why the battle was necessary. The loss of life, cost in resources and number of wounded at Hamburger Hill made it a key moment in the political arguments that eventually led to the U.S. withdrawal from Vietnam.





Many veterans don't realize that their military service entitles them to be interred in a National Cemetery at no cost to them or their families. Even if you never received disability or any other benefit from the VA, if you served on active duty and were honorably discharged you are eligible. Most veterans and families don't take advantage of this benefit, which would save them thousands of dollars. The most effective way to ensure you get the burial or memorial benefits you and your spouse have earned from military service is through the VA program entitled "*Pre-Need Eligibility*."

Pre-need establishes eligibility for VA burial and memorial benefits before you die, so your family doesn't have to go searching for documents. Go to <u>www.cem.va.gov/pre-need</u>, fill out the *Application for Pre-Need determination of eligibility for Burial in a VA National Cemetery*, VA Form 40-10007 and fax or mail it to the address indicated on the website.

VA encourages all veterans to take advantage of Pre-Need eligibility to ensure they, and their families know their eligibility status in advance.

The VA will review your application, and you will get a letter confirming or denying eligibility. If approved, place the letter in a safe location, inform your family and rest easy.





- Honoring Those Who Died in Service to the Nation
- Established in 1868 as Decoration Day by the Grand Army of the Republic; a time for the nation to decorate the graves of the war dead.
- A crowd of about 5 thousand people attended the first large celebration at Arlington National Cemetery in 1868.
- Waterloo, New York, was declared the official birthplace of Memorial Day by President Lyndon Johnson in 1966.
- Declared a federal holiday in 1971 and observed on the last Monday in May conforming to the Uniform Monday Holiday Act of 1968.
- The National Moment of Remembrance Act of 2010 encourages a moment of silence at 3 pm local time to honor those who died in service to the nation.

Marine Corps Pfc. Elden R. Baumbach – 19. Lost November 22, 1943 after several days of intense fighting at Tarawa Atoll, Gilbert Islands. Accounted for February 4, 2020. Announced April 16, 2020.

Marine Corps Pvt. Jacob Cruz – 18. Lost November 22, 1943 after several days of intense fighting at Tarawa Atoll, Gilbert Islands. Accounted for April 14, 2020. Announced April 17, 2020.

Marine Corps Sgt. Fred Farris – 19. Lost November 20, 1943 after several days of intense fighting at Tarawa Atoll, Gilbert Islands. Accounted for April 14, 2020. Announced April 17, 2020.

Army Pfc. Oliver Jeffers – 31. Lost November 10, 1944 when his unit was engaged in battle in the Hürtgen Forest, Germany. Accounted for April 23, 2020. Announced April 24, 2020.

Army Pfc. Clarence W. Brotherton – 20. Lost October 14, 1944 when his unit was engaged in battle in the Raffelsbrand Forest, Germany. Accounted for April 23, 2020. Announced April 24, 2020.

Marine Corps 1st Lt. Hugh D. Fricks – 22. Lost November 20, 1943 after several days of intense fighting at Tarawa Atoll, Gilbert Islands. Accounted for March 16, 2020. Announced April 27, 2020.

Marine Cpl. Raymond J. Tuhey – 24. Lost November 23, 1943 after several days of intense fighting at Tarawa Atoll, Gilbert Islands. Accounted for April 20, 2020. Announced April 27, 2020. Marine Pfc.
