The website is up and fully functional at this time. We are still working on getting a google search to direct to the new site but it is able to be found when you search for Post 21 and click on the clubs website link.





#### Month of the Military Child 2025: Honoring Young Heroes

April is recognized as the **Month of the Military Child (MOMC)**, a special time dedicated to honoring the resilience, strength, and sacrifices of military-connected children. Established in 1986 by former Defense Secretary Caspar Weinberger, this month highlights the unique challenges these children face, such as frequent relocations and parental deployments, while also celebrating their contributions to their families and communities. A key event during the Month of the Military Child is **Purple Up! Day**, a nationwide initiative that encourages communities to show their support for military children by wearing purple. The color purple symbolizes all branches of the U.S. military—blending Army green, Navy blue, Air Force blue, Marine red, and Coast Guard blue.



In 2025, different organizations may observe Purple Up! Day on different dates:

- •April 15, 2025 The Department of Defense Education Activity (DoDEA) will recognize Purple Up! Day.
- •April 23, 2025 The Military Interstate Children's Compact Commission (MIC3) has chosen this date for its official observance.

Regardless of the specific date, communities, schools, and organizations nationwide are encouraged to participate by wearing purple and hosting events that recognize the contributions of military children.

## Gold Star Spouses Day: Honoring the Sacrifices of Military Families



Every year on **April 5**, the United States observes **Gold Star Spouses Day**, a day dedicated to honoring and recognizing the sacrifices made by the spouses of fallen service members. This solemn occasion serves as a reminder of the resilience, strength, and dedication of those who have lost their loved ones in military service. The term **"Gold Star"** dates back to **World War I**, when families of service members displayed service flags with blue stars to represent those actively serving. If a service member was killed in action, the blue star was replaced with a gold star, signifying their ultimate sacrifice. This tradition continues today, with Gold Star families receiving the **Gold Star lapel pin or Next of Kin lapel pin** as a symbol of their loss and the nation's gratitude.

Originally known as **Gold Star Wives Day**, the observance was officially recognized in 2010 to acknowledge the sacrifices of military widows and widowers. The name later changed to **Gold Star Spouses Day** to be more inclusive of all surviving spouses. The day is an opportunity for the country to come together in remembrance and support of these individuals.

On April 5, military organizations, veterans' groups, and communities across the nation hold various events and initiatives to recognize Gold Star spouses. These include:

- **Memorial Services and Ceremonies** Many military bases and organizations host ceremonies to honor fallen service members and their families.
- **Community Gatherings** Support groups and organizations, such as the **Gold Star Wives of America**, provide opportunities for spouses to connect and support one another.
- **Public Recognition** Government officials and military leaders often issue proclamations, acknowledging the sacrifices of Gold Star spouses.
- **Social Media Tributes** People across the country use hashtags like **#GoldStarSpousesDay** to share messages of gratitude and remembrance.

Gold Star Spouses Day is not just about remembrance—it is about ensuring that the sacrifices of both service members and their loved ones are never forgotten. As a nation, we honor these spouses for their resilience and unwavering devotion to the memory of their fallen heroes.


