**Chaplain:** Sick and Inured – Terry Ward is in good humor. We have quite a few member families suffering from cancer, please keep them in your prayers. Last month there were 543.75 volunteer hours.

At Large – Mike Billings: Thank you to the Sons for labor in installing a Gazebo at Old Stone Village. Looking into getting a Highway Sign directing drivers to The American Legion. Have a Purple Heart Veteran by the name of Abel, he is a dual member of the VFW and the Legion. He was in a traffic crash a year ago, didn't think he qualified for assistance. He is \$1,638 behind with a late fee of \$200. The VFW has paid the bill to prevent an additional late fee. Would like to ask that the Post reimburse VFW for \$500.00.

Motion: By Dan Brown the Post reimburse the VFW \$500.00 – Seconded by Jim Connelley – PASSED.

At Large Gale Sears: Volunteerism – what can you do to help on Friday Night. Riders – Very successful Poker Run in August. Looking forward to next year's Poker Run

**Commander:** Will contact the PIC of the Veterans Parade, Dave Lipscomb and find out what is going on. Air Show was dumped on him, but he has a tentative schedule for putting up the crowd fencing. 9/27: 9-4; 9/28: 9-4; /29: 9-5; 10/1: 3pm and 10/2 finish removing fencing. Cruikshank Road is closed, and a new gas line has been installed and Juan has made it clear that we will not be pounding posts into the ground above the gas line. They will be putting in barriers to keep traffic away. Juan will contact the county and see if they can keep the road closed until after the air show. Need trucks and trailers also for putting in the fences.

**SONS**: Membership renewals are at 15 paid which puts us at 28.3%. Bob Bonebrake a Vietnam Veteran recently had knee surgery and asked for assistance in erecting a Gazebo at his home in Old Stone Village. Sons members Del White, Pete Jensen, Jim VanScoyck, Terry Naig, Angel Mendoza, and Rich Randles put in 5 hours putting in the framework. The next day they returned and worked for five more hours assembling the Gazebo. It took a total of 50 man hours to assemble the Gazebo. Mr. Bonebrakes was very pleased. Auxiliary: Working hard on membership renewals. Will be having an open house on October 17th with Raffles.
