Working on removing the insurance from the copier as we already have insurance for the building and contents.

**Auxiliary:** Worked the Marine Breakfast, attended Jim Smith's celebration of life. Auxiliary has 20-25 volunteer hours. We had 9 new members last month and we are at !00%.

**House Committee:** Want everyone to know that the Air Force Breakfast is this Saturday, would like to see everyone there for the best breakfast in town. Parking Lot cost will be adjusted due to the shortage in fuel around the nation.
