Commanders Report: Membership is what keeps us going, we are at 75%. Let us know if something needs repaired. Each family member is important to the Post.

Need a Chairman for the Nomination Committee, they will need to let potential candidates know what the duties are for the position they would like to hold. Mike Billings volunteered to chair nomination committee.

Fist Vice: Has resigned.

Second Vice: Jim Connelly is willing to take the First Vice Position. Upcoming events are Superbowl on 2/12; and Valentines Day Dinner on 1/14.

Service Officer: Veteran lives in Newberg needs help with rent would like to see the Post donate \$400 to pay a portion of his rent. He is a veteran and he and his wife are both unemployed, landlord says he needs to catch up on rent or he they will be evicted.

Finance Officer: Current Post Account Balance \$233,213.87; Lottery Account \$79,483.31; Maintenance Account \$4,247.62; Operating Cash - \$10,586.02 = total assets of 327,530.82. Showing a growth of \$23,733.26 since November 14, 2022. Requesting to transfer \$1,186.66 (5% of profit) to maintenance account.

Motion: By Dan Brown that Finance Officer be authorized to transfer \$1,186.66 to the Maintenance Account.

Gail stated that he will be stepping down as Finance Officer, he is willing to train a replacement. Did an audit of the Rose Garden Account all is correct.

House Committee: Executive Committee has approved having the restrooms cleaned on a monthly basis. Issue with power at RV Park looking at bringing up power from 200 amp to 400 amp. Quote from Farnham says we don't need to bring up to 400, the box we have is 20 years old. They believe we can either change some of the circuits and spread out the wires. Replacement of box and circuits will cost almost \$1,875, replacing circuits will cost \$375. Need to get a new vacuum for Rick.

At Large – Rich Pimm: Monument artwork is complete it is still curing, will take at least 10 days to cure. Concrete work is complete need to have lights installed. There is \$11,000 in the account, would like to have \$8,000 left to cover the people who have pre-paid to have names engraved on the new monument. Tunnels 2 Towers project is going well have already sent \$300.00 will be sending about \$110 a month.

Chaplain: If you have family or know of a Veteran that is in the Hospital, let him know he will visit them in the hospital. When a member of Post 21 passes we drape the charter and lower the flag, the family is invited.

Historian: Plaque presented to Post from Sea Cadets. Leroy stated he is willing to be the Liaison for the Sea Cadets and the Boy Scouts. Has recently installed a new amp and it is working great.
