## World War II

**Paul L. Boemer – 21, Navy Coxswain.** Lost during the attack on Pearl Harbor, December 7, 1941 – USS Oklahoma. Accounted for September 29, 2020. Announced October 28, 2020.

#### Korean War

Army Cpl. Paul W. Wilkins – 19. Lost July 19, 1950, while fighting enemy forces near Choch'iwon, South Korea conducting a night recon patrol near Taejon, South Korea he was never found, nor were any remains recovered. Accounted for October 30, 2020. Announced November 3, 2020.

# Why the Military is still identifying Sailors killed during the attack on Pearl Harbor.

For decades, Defense POW/MIA Accounting Agency and its predecessors have worked to identify those killed in the Korean War, Vietnam War and other conflicts. Thanks to their hard work and scientific innovations — like DNA testing — investigators have started to look even further back: to the Pearl Harbor dead and others from World War II.

With each passing conflict, the Department of Defense scientists gradually fine-tuned their ability to gather information from human remains and compare genetic information from family members to DNA gathered from service members' remains, including some that have been degraded or commingled. Forensic analysis of the remains discovered something surprising: the traces of about 100 people in the single casket.

Department of Defense DNA Operations, says that DNA and other identification technologies have evolved rapidly in the past few decades as the military has pursued more identification projects, including for people who perished in the Korean War. The technique was used to help identify service members from the Korean War, whose remains were returned to the U.S. by North Korea in 55 boxes last year.

In 2010, Congress added identifying the remains of World War II dead to the accounting agencies' mission. In 2015 as part of the USS Oklahoma Project the Defense POW/MIA Accounting Agency, through a partnership with the Department of Veteran Affairs exhumed all the coffins containing the unknown remains from the USS Oklahoma and began the lengthy identification process. . More than 200 service members from the ship have been identified just in the last four years.



# Wreckage of Three WWII planes have been found

The last time anyone saw these military aircraft, U.S. forces were attacking Japanese targets in the western Pacific during World War II. "Operation Hailstone" in February 1944 was a decisive victory for the U.S. but it came at a cost to American forces.

Launched from the Aircraft carriers USS Enterprise and USS Intrepid two Dauntless dive bombers and one Avenger torpedo bomber were among the missing US. Planes. Now, 76 years later, they have been found. A recovery operation discovered pieces of the long-lost planes at the bottom of Truk Lagoon in Micronesia.

When the smoke from the two-day battle cleared approximately 30 American aircraft were also lost, along with 23 aviators and crewmen. The three planes that were recovered went undetected until 2019, even though the spot is a popular destination for divers.

The mission to find the planes was led by scientists and volunteers with *Project Recover*, a private organization of divers, aviators and historians dedicated to finding WWII service members missing in action in the South Pacific. Underwater surveys of the sea bottom in Truk Lagoon identified potential airplane debris, after deploying divers and robots equipped with high-definition cameras they found the debris fields contained the remains of the three aircraft.

Many of the big Japanese ships — oil tankers and merchant vessels measuring hundreds of feet long — that were sunk in Truk Lagoon in 1944 have since become overgrown with coral and are now popular destinations for divers to visit. The holds of some of the ships are actually filled with Japanese airplanes and trucks. They are amazing places to go scuba diving. But by comparison, airplanes that broke into fragments aren't necessarily recognizable to recreational divers, which could explain why the missing planes — or what was left of them — were overlooked for so long.

As for the crewmen who were aboard the planes, there's a high likelihood that intact remains could be found inside the wreckage, particularly in the case of the torpedo bomber, in which two crew members were pretty much locked inside the back of the airplane.

Now that the crash sites have been located, *Project Recover* will turn its data over to the U.S. Department of Defense's Defense POW/MIA Accounting Agency. The federal agency will then evaluate the sites for the possible recovery and identification of any remains.

Project Recover stated that "We won't know until that recovery

actually happens, whether anyone is still inside the aircraft. But from our experience, I'd say that there is a very good probability that that is the case."
