Yes, Medicare is complicated. I get it. I turn 65 in November. My wife retired at age 66 in May, so it was time for her to sign up. I am also a Service-Connected Disabled (70%) Veteran. We are immersed.

Why do I continue to be an independent Medicare broker when I don't have to? To help people understand how to navigate the mine fields of Medicare, how it works with Veteran Disability benefits and Tricare, and get them signed up for the appropriate medical coverage. I work with non-Veterans too.

My Recommendations to those eligible for Medicare or those wanting change/review:

Robocalls: Hang up on them.

TV: Mute or laugh at them.

Mailers: Throw them in the recycle bin.

Emails from those you don't know: Trash them.

Last week, I was golfing with a fellow disabled Veteran who mentioned that he was told, as a disabled Veteran, he could not have both Medicare and Disabled Veteran benefits. Not true. This common misconception is out there, and it is wrong.

Tricare for Life: In order to remain on Tricare for Life, you must keep your Parts A & B up to date. 2024 projected Part B cost is \$174.80 per month. A Medicare Advantage "Patriot" Plan is not required for you, but may be right for you, providing "extras," such as free basic gym membership. Again, get ahold of me with any questions/needs.

World War II

Army Air Forces Sgt. Irving Newman – 22. Lost May 6, 1943 when the B-24 Liberator he was piloting was hit by enemy anti-aircraft fire and crashed in flames. No one survived the crash, but Sgt. Newman was not able to be rescued and his remains were not recovered. Announced August 31, 2023.

Army Air Vorce 1st Lt. Edward McGuire – 22. Lost August 1, 1943 when the B-24 Liberator he was piloting crashed as a result of enemy ant-aircraft fire during Operation Tidal Wave. His remains were not identified following the war. Announced August 31, 2023.

Tuskegee Airmen, Army Air Force 2nd Lt. Fred Brewer – 23. Lost October 19, 1944 when the P-51C Mustang he was piloting crashed over the Udine area Italy. Brewer's aircraft rolled over with the canopy jettisoned, he was not observed ejecting his remains were not recovered. Announced September 1, 2023.

Army Pvt. Daniel Moniz – 19. Lost November 11, 1944 when his unit was engaged in battle with German forces near Hürtgen Forest and he was killed. Due to the tactical situation his remains could not be immediately recovered. Announced September 1, 2023.

Army Air Force 2nd Lt. Edward Barnett – 24. Lost August 1, 1943 when the B-24 Liberator he was the co-pilot was hit by enemy anti-aircraft fire and crashed during Operation Tidal Wave. His remains were not recovered. Announced September 5, 2023.

Army Pvt. 1st Class Thomas Brooks, 23. Lost April 9, 1942 when Japanese forces invaded the Philippine Islands. After being subjected to the 65-mile Bataan Death March and being held at Cabanatuan POW camp he died as a Prisoner of War. Announced September 5, 2023.

Army Air Forces 1st Lt. George Winger – 25. Lost August 1, 1943 when the B-24 Liberator he was serving as pilot on was hit by anti-aircraft fire and crashed during OPERATION TIDAL WAVE. Announced September 7, 2023.

Army Pfc. Roy Searle – 22. Lost December 6, 1944 when he was mortally wounded when his unit was defending

the towns of Pachten and Dillingen, Germany during the Battle of the Bulge. Announced September 7, 2023.

Army Air Forces Flight Officer Chester Rinke – 33. Lost June 26, 1944 when B-28 Superfortress crashed into a rice paddy in the village of Sapekhati, India. All 11 crew members were killed instantly in the crash. Announced September 8, 2023.

Army Air Forces Flight Officer Chester Rinke – 33. Lost June 26, 2944 when the B-29 Superfortress he was serving on as the flight officer crashed in Sapekhati, India. All 11 crew members were killed instantly. Announced September 8, 2023.

Army Air Forces 1st Lt. Charels Reynolds. Lost November 27, 1943 when the B-25D he was a crewmember on was hit by anti-aircraft fire and crashed in Karau Lagoon in the Murik Lakes. His body could not be recovered. Announced September 11, 2023.

Army Air Force Tech. Sgt. Turner Johnston – 21. Lost August 1, 1943 when the B-24 Liberator he was an engineer-gunner on was hit by enemy anti-aircraft fire and crashed during OPERATION TIDAL WAVE. His remains were not identified after the war. Announced September 14, 2023.

Army Air Forces 2nd Lt. Abert Stahl – 22. Lost when the B-24 Liberator he was the navigator on was hit by anti-aircraft fire and crashed during OPERATION TIDAL WAVE. His remains were not identified following the war. Announced September 14, 2023.

Army Cpl. James Hurt 25. Lost April 9 1942 when Japanese forces invaded the Philippine Islands and when he was captured. He was subjected to the 65-mile Bataan Death March. Cpl. Hurt died as a prisoner of war in Cabanatuan POW camp. Announced September 21, 2023.

Korea

Army Sgt. Richard Sharrow – 22. Lost July 25, 1950 when unit sustained heavy casualties while defending against the North Korean Army's advance near Yongdong, South Korea. Due to the intense fighting his body could not be recovered and there was never any evidence that he was a prisoner of war. Announced August 14, 2023.

Army Pvt. Alvin Thurman - 21. Lost November 6, 1951 when he was killed in action during his unit's withdraw from Hill 200. present-day Korea Demilitarized zone. Announced August 15, 2023.

Army Sgt. Willie Baty – 20. Lost September 14 1950 when his unit was forced to withdraw from the Masan are of the Pusan Perimeter, South Korea. Following the battle his remains could not be recovered, and there is no evidence that he was ever a prisoner of war. Announced August 31, 2023.

Army Sgt. Stanley Turba – 27. Lost April 26, 1951 when his unit was engaged in a firefight with Chinese Peoples Volunteer Forces in the vicinity of the Hwachon Reservoir. Due to the intense fighting his body could not be recovered and he was never a prisoner of war. Announced September 7, 2023.

Army Sgt. 1st Class James Dorrance – 20. Lost December 1, 1950 when his unit was withdrawing from Kunu-ri North Korea. He was captured and died as a prisoner of war in Camp #5, Pyoktong, North Korea. Announced September 21, 2023.

Army Air Forces 2nd Lt. Max Dailey – 21. Lost August 1, 1943 when the B-24 Liberator he was serving on as a navigator crashed as a result of anti-aircraft fire and crashed during OPERATION TIDAL WAVE. His remains were not recovered, and he was never identified as a prisoner of war. Announced September 21, 2023.

Army Cpl. Lewis Hill – 18. Lost when his unit was forced to retreat from the vicinity of Taejon, South Korea. Due to the fighting his body could not be recovered and there was no evidence that he was ever a prisoner of war. Announced September 21, 2023.

Vietnam

Army Pvt. Alvin Thurman - 21. Lost November 6, 1951 when the A-6 Intruder he was serving on as a pilot during a nighttime combat mission his radio communications ceased, and he never returned to base. His remains were never recovered. Announced August 9, 2023.
