

**Resolution: Denounce, Abolish, and Terminate the Fraudulent Republic of Texas Court in Common Law Website in every, any County in the Republic of Texas Nation with Abdicated Justice Susan Ann Miller and Abdicated Treasurer Donna Cartwright rtcacl.net Website Owner, and any, all other co-conspirators involved.**

Joint Session of the 27<sup>th</sup> Congress

JHR 95-08-27-2023

Enacted by the Joint Congressional Investigation Committee

Be it resolved by the House of Representatives and the Senate of the Republic of Texas, One Nation Under One God, The God of Abraham, Isaac, and Jacob, in Congress assembled, a resolution enacted by the Joint Houses of the Twenty-Seventh Congress of the Republic of Texas.

By the Authority vested in the Twenty-Seventh Congress and after the people's Congressional House of Representatives and the Senate for the Republic of Texas, in a meeting of Congress assembled, the following Joint Congressional Investigation Committee Resolution No. 95-11-02-2023, was approved and adopted, originating from the House of Representatives Investigation Committee and is titled:

**Resolution JHR 95-11-2-2023 Resolution: Denounce, Abolish, and Terminate the Fraudulent Republic of Texas Court in Common Law Website in every, any County in the Republic of Texas Nation with Abdicated Justice Susan Ann Miller and Abdicated Treasurer Donna Cartwright rtcacl.net Website Owner, and any, all other co-conspirators involved.**

Due to discovering the fraudulent court and website, operating without Congressional review, consent, and authorization, Abdicated Justice Susan Ann Miller and Abdicated Treasurer Donna Cartwright rtcacl.net Website Owner, proceeded in an act of crimination to purposely deceive and harm the Texian people. As a result, all rulings and determinations will never be recognized by the Republic of Texas Nation or the Texian people for the safety and protection of the Texian people and the Republic of Texas Nation.

Under the Republic of Texas Constitution of 1836 Voted by ballot and passed September 5<sup>th</sup>, 2007 by the Texian people.

**Article IV Sec. 1** *"The judicial powers of the government shall be vested in one supreme court, and such inferior courts as a Congress may, from time to time, ordain and establish. The judges of the supreme and inferior courts shall hold their offices for four years, be eligible to re-election, and shall, at stated periods, receive for their services a compensation, not to be increased or diminished during the period for which they were elected."*

**Article IV Sec. 6** *"The clerks of the district courts shall be elected by the qualified voters for members of congress, in the counties where the courts are established, and shall hold their offices for four years, subject to removal by presentment of a grand jury, and conviction of a petit jury."*

**General Provisions Section 8** *"All persons who shall leave the country for the purpose of evading a participation in the present struggle, or shall refuse to participate in it, or shall give aid or assistance to the present enemy, shall forfeit all rights of citizenship, and such lands as they may hold in the republic."*

Sec 1. Be it resolved, the Speaker of the House never being petitioned with a request to review, ordain, or establish any commerce, equity, website for-profit, mixed, (foreign) jurisdictions common law court(s), or grand jury, which is a violation of the Constitution and their oaths of office for the Republic of Texas, putting the Texian people at risk.

Sec. 2. Be it resolved, the Congress hereby denounces, abolishes, and terminates the fraudulent "Republic of Texas in Common Law Website, Court(s)" in every, any County(s) in the Republic of Texas Nation with Abdicated Justice Susan Ann Miller and Abdicated Treasurer Donna Cartwright rtcacl.net Website Owner, and any, all other co-conspirators involved.

Sec. 3. Be it enacted, due to the fraud and treason against the Republic of Texas Nation and the Texian people, all rulings and, or determinations will never be recognized by the Republic of Texas Nation or the Texian people due to the unconstitutional consequences.

Sec. 4. Be it resolved, according to the Proclamation presentment:




