I further declare, I myself am responsible for all my actions, affairs and public conduct.

I, having been an inhabitant domiciled on the lands within the constitutional republic of Texas boundaries, as sealed by lawful International Treaties, for a previous six months minimum do hereby **declare** that I am a natural man/woman character living-soul; a Texian North American Sovereign, who desires living, operating and conducting my affairs under Almighty God's Law for all nations and the Texas republic Common Law. I am not wanted or under indictment for any crime in Texas or any other entity under Common Law. My declaration is made without deception or for evasion purposes.

## HOW TO MAKE APPLICATION FOR TEXIAN ID CARD

When filling in your Texian ID CARD APPLICATION, if you are not yet a Texian, you must also complete and return the AFFIDAVIT OF FACTS AS A TEXIAN form which can be found under this same tab.

For your ID CARD you must also send a digital image of yourself to: [adamkranston@pm.me](mailto:adamkranston@pm.me) . A phone image is acceptable if you don't have a digital camera. The image should be a quality head shot, similar to a passport photo. Try to use an uncluttered, light, even background. No hats, caps or glasses. This will be the image that will appear on your card for the next 5 years. It's okay to smile!

There is a charge of \$35.00 for the ID card to cover the costs incurred. If sending a check or money order, make payable to: SOS Kenneth Barnett. The ID card is valid for 5 years. If your card is lost or stolen or needs replacement during that time there is a cost of \$20.00 for a replacement card. We have Congressional sessions once a month, which location, date and time are shown on the home page of this website. You can attend these meetings if you wish, to learn more about why and how your government exists and operates. If you come to one of these meetings you may also pay for your ID card with 1 oz of silver instead of \$35.00. I wouldn't recommend mailing an oz of silver but it has been done and you can. We also accept federal reserve notes.
