Registration and Tuition Agreement:

I hereby agree to pay all monies due to JNS Dance at agreed upon time. All classes must be paid for, regardless of the student's attendance. Any classes cancelled by the instructor due to illness will be made up by an instructor for JNS Dance at no additional cost. Any classes cancelled due to weather, will NOT be made up by JNS Dance.

Monthly payments will be equally divided by 9 months (Sept – May) despite the number of classes in the month. Monthly payments must be paid on the 1st or the 15th of each month Sept – May (Sept 1st payment can be made at registration or on the first class). Thirds payments must be made Sept 30th, Dec 30th and March 30th. Biannual payments must be made once on Sept 30th and the second on Jan 30th.

There is a 5% discount for each additional discipline (class) taken by the same dancer. The discount will be applied to the

lower value(s) of classes. (Ei. Int Ballet \$360 + Int Jazz \$396 = Int Ballet \$360 – 5% + Int Jazz \$396).

There is a 10% sibling discount. The discount is taken off one sibling's tuition (the lower amount)

There will be a \$25 fee for any returned cheques (NSF).

Withdrawal Policy

Should a dancer withdraw from class. A refund will be issued for any remaining paid classes. In the event of a withdrawal, a Withdrawal Form filled out and signed by a parent/guardian must be submitted before any money is returned, no classes will be refunded before the day/time of the Withdrawal form filled out and signed. There is no refund for classes missed by the dancer.

Should the studio be temporarily closed due to a government mandated closure, there will be NO refunds for classes. Instead, classes will move to an online format such as Zoom.
