DURING THE FIRST YEAR, WE WERE REMINDED OF A TRUTH ABOUT HUMANS - THAT CHANGE CAN BE BOTH EXCITING AND UNSETTLING. SOME FARMERS DECIDED THEY DIDN'T WANT TO DIVERSIFY THEIR CROPS. YET, A FEW WERE HAPPY TO EXPAND THEIR SELECTION OF CROPS.
