- **Speakers Meeting Report** - The May 30 speakers meeting was received very positively, with respondents giving consistently high marks for the event overall, the speaker, the atmosphere, and how welcome they felt. Attendance was 29 in person and 18 online, showing strong participation across both formats.

**Attendees especially valued Haley's honesty and vulnerability, the chance to hear a full personal story, and the strong sense of hope, connection, and mutual support in the room.** Several comments described the meeting as genuine, powerful, and inspiring, and some members specifically expressed interest in having more speaker meetings in the future.

**Suggestions for improvement focused mainly on space and logistics rather than content.** Multiple responses noted the need for a larger room or more chairs, reflecting the strong turnout. Other suggestions included using a microphone for audience participation, making materials easier for online attendees to read, possibly moving the start time to 8:30, and finding a more comfortable way to recognize newcomers.

Overall, the feedback indicates that the meeting was highly successful, meaningful, and well received, with strong support for continuing and possibly increasing the frequency of speaker meetings.

A new room has been secured in the auditorium on the first floor education wing for future speakers meetings. Next speakers meeting will be the last Saturday in August.

- **12 Steps Workshop Survey:** The most requested workshop topic was the 12 Steps. To help shape this workshop around the needs of the fellowship, the Events Committee has prepared a Step Work Survey to be shared by all IGRs in their groups in the near future. Groups are asked to pass around the QR code and allow a few minutes during the meeting for members to complete it. The purpose of the survey is to gather input on members' experience with step work, areas where support is most needed, and what format would be most helpful for a future workshop. The survey should take only a few minutes to complete. Date to be determined.
- **Sponsorship Forum:** The second most requested topic was sponsorship. In response, the Events Committee will coordinate a Sponsorship Forum where current sponsors can come together to share their experience, strength, and perspective on how best to meet the needs of fellows seeking sponsors within our fellowship. This forum is intended to support stronger connections, shared understanding, and practical discussion around sponsorship. Date to be determined.
