#### **OUR MISSION**

Classical Christian School for the Arts is committed to providing our community with excellence in academic and artistic education at an affordable family rate. CCSA depends upon our donors' generosity to continue to keep tuition costs reasonable.

We are proud to offer a Godly, secure, and caring environment. CCSA students are encouraged to achieve their highest spiritual, academic, artistic, athletic, and personal goals. The CCSA curricular goals include a classical arts education, wherein instructors understand that students learn incrementally in three phases including memorization, logic - reasoning, and rhetoric.

#### **OUR GOAL**

At CCSA it is our desire to graduate students whose lives reveal spiritual and academic excellence. We hopefully anticipate as we trust God that our graduates:

- Choose a lifestyle that reflects a clear Godly testimony of kindness and love.
- Seek to understand and identify God's purpose in their lives; take time to explore their many gifts.
- Are adequately and comprehensively prepared for higher education.
- Understand and adhere to excellent work ethics.
- Commit to personal study in academics and arts (in addition to required class/homework).
- Hold personal convictions that demonstrate a Godly, compassionate worldview.
- Understand the importance of serving their communities to demonstrate the concern and love of God.
- Become life-long learners.
- Develop an appreciation of the arts and understand their relevance to the Creator

#### CODE OF CONDUCT

Students are expected to be prompt and demonstrate courteous obedience to all school personnel, staff members, and campus guests.

Students are expected to remain out of any unauthorized area unless accompanied by a teacher or with special permission. Students are not allowed in a classroom without a teacher present or express permission.

Students are expected to arrive to each class on time (arriving late to the same class 3 times will result in detention) and come prepared with books, assignments, pencils, pens, and any other materials that may be necessary for the daily class work.

Students are expected to listen attentively to teachers at all times as well as other students when appropriate.

Students are expected to respect school property and the personal property of others. Students are not to deface, damage. or remove any school property or the property of another person. Parents will assume full financial liability for any and all damages (including textbooks) incurred at school, or at school sponsored functions and activities, which are the result of their child's actions.

Students are expected to assume personal responsibility for doing their part to keep the campus looking neat and clean. This means that students are expected to keep personal property out of walk areas and to place trash in the appropriate receptacles.

Students are expected to show respect and courtesy to fellow students at all times. Students are never permitted to violate another person's character either verbally or physically.

Students are expected to maintain appropriate self-control in their classroom conduct. Passing notes, tossing or playing with irrelevant objects or other activities which are disruptive in nature are not allowed in the classroom.

Students are expected to use the restrooms for their intended purpose only. Restrooms may not be used for loitering, eating, or as a group hang-out or any non-sanctioned activity.

Students are expected to not chew gum on campus at any time.

Students are expected to dress appropriately and follow the modesty guidelines; showing a demonstrative willingness and cooperative spirit in adhering to the CCSA dress code policy at all times. This also encompasses field trips, school-sponsored events at the Performing Arts Center, sports programs and any other special

CCSA-sponsored off campus functions.

Students are expected to refrain from any public displays of affection while on campus or at any school sponsored activity or function.

Students are expected to commit to honor and integrity by never allowing theft, cheating, gossip, or other wrong behavior to occur, first in their own lives, and secondly, by those persons around them.

#### MAJOR INFRACTIONS OF THE CODE OF CONDUCT

Although not all-inclusive, the following may result in suspension or immediate expulsion from the school:

Abusive or Profane Language – using abusive or profane language, verbal abuse and disruptive classroom behavior will not be tolerated and will result in disciplinary action. This includes threatening, intimidating language or causing bodily harm to any person or property, as well as interference with the rights of others.

Disrespect – disrespect towards CCSA Faculty and Staff will not be tolerated. Disrespect includes arguing, talking back, being defiant, refusing to follow simple directions the first time, raising one's voice or making inappropriate comments. A student who is disrespectful towards a CCSA faculty or staff member will be sent home or placed in In-School Suspension.

Academic Dishonesty – any attempt to gain an unfair advantage on an assignment, a quiz, or a test. Use of a cell phone during a quiz or test will result in an automatic zero and is considered a major offense.

Drug and Substance Abuse -The possession, use, or distribution of drugs, alcohol, and tobacco products is prohibited. This also includes electronic nicotine delivery systems also known as e-cigarette, e-cigars, e-hookahs and e-pipes. Vaping devices and products are prohibited. Any situation where a student is suspected of engaging in such activities will be thoroughly investigated and parents will be notified and the student will be subject to possible expulsion.

Damage to School Property – Parents are responsible for the cost of replacing or repairing school property, including computer equipment damaged by their child. This includes classroom items, furniture, textbooks, playground equipment, PE equipment, and school buildings. Report cards will be held until all fees are paid. Under no circumstances will the administration tolerate any type of student pranks on campus.

#### **CHAPEL & AWARDS**

CCSA students will begin each morning with Bible study that will include character development and a comprehensive study of the Code of Ethics. The Bible curriculum

includes note-worthy, student-friendly publications. Once per week, students will enjoy a chapel service with a variety of special guests including local youth pastors, missionaries, and inspirational speakers.

CCSA homeroom classes participate in the chapel service through music, skits, and recitations. Chapel provides an opportunity to award students for their academic, civic, and artistic achievements. Awards are presented quarterly.

#### PARENTAL SUPPORT & VOLUNTEER HOURS

Parents are viewed as ultimately responsible for the education and spiritual development of their children. By placing them in CCSA, they agree to accept and abide by the policies and procedures established by the school. Negativity and maligning will not be tolerated and is grounds for student withdrawal. Parents are always welcomed and encouraged to schedule an appointment to discuss concerns at any time. Your suggestions are always welcomed and considered with an open mind. The CCSA staff desires a harmonious relationship with parents. If parents have a question about a school policy or event that involves their child, they are to notify their child's teacher and schedule a meeting to discuss the matter. If a school administrator is available, he/she may join your meeting. An effort will be made to resolve any differences and maintain excellent communication between parents and school staff.

CCSA Parents are required to volunteer 10 hours per school year. Parents need to log their own hours and submit their volunteer logs at the end of each quarter. If parents are unable to volunteer the required hours, they will be required to make a payment of \$300.00 per year in lieu of volunteer service. Parents that have not completed 5 hours by the end of the second quarter will receive an invoice for \$150.

#### PERSONAL RESPONSIBILITY

Classical Christian School for the Arts encourages school employees, students, and parents with a personal online presence to be mindful of the information they post. Your online behavior should reflect the same morals, professional and personal standards of honesty, respect, and consideration that you use face-to-face and in work-related settings.

The lines between public and private, personal and professional are blurred in the digital world so by virtue of identifying yourself as a CCSA employee, student, or parent online, you are now connected to colleagues, students, parents and the school community. Teachers, parents, and students are reminded that regardless of where their posting originates, any text, photographs, or videos they put on any social media which would be disruptive and derogatory to the school or the school community, or threaten, demean, or bully students, faculty, or parents is prohibited.

#### **OUR TEACHERS**

CCSA seeks to employ devoted Christian teachers with a passion for education, a love for students, appreciation for the arts, and a willingness to grow both spiritually and

academically. We seek teachers with good communication skills who understand the value of the parents' role in education. All of our teachers have a Bachelor's Degree or Master's Degree or have 3 years of special skills and expertise in the classes they teach including music, art, dance, and the fine arts.

CCSA Arts subcontractor instructors are selected for their passion for their personal educational background and experience in their chosen field of expertise.

#### **ARTS & ACTIVITIES**

CCSA provides students the opportunity to develop an understanding of culture and statesmanship through participation in the arts as a required portion of their curriculum. Arts and activities are selected for the year and may only be changed in the first 2 weeks of school.

All students in Grades 4 and 5 are required to participate in Band. It is the parent's responsibility to ensure that the student has a band instrument in good condition beginning the first week of school. Instruments are available for rent through the school at a rate of \$20 per month.

#### PHYSICAL EDUCATION

CCSA believes that physical fitness is a vital part of a balanced education. For this reason, children in grades K-8th will attend physical education classes weekly.

#### FINANCIAL POLICIES

The operating budget for Classical Christian School for the Arts depends upon tuition and fees. Financial responsibility is required to provide quality Christian education for your child. Your cooperation with the financial policies is necessary for the responsible operation of the school.

#### PAYMENT PLAN

The annual tuition and fees may be paid in 10 equal installments at 0% interest beginning in August of the incoming or renewing school year. Tuition may be paid via cash, check or recurring billing through CCSA's bank partnership. Please see Mr. Hammer for details. Tuition payments are nonrefundable. Tuition is payable in full by August 1<sup>st</sup> to qualify for a 5% discount.

#### **DELINQUENT ACCOUNTS**

We realize that from time to time extenuating circumstances exist. If you are unable to make your payment in a timely manner, please speak directly with administration as soon as possible to avoid possible student dismissal.

#### **ACADEMIC POLICIES**

Parents may check the status of the student's academic progress through Renweb, a parent-school online interface. Parents are strongly encouraged to check their child's grades on a bi-weekly basis.

<u>Parent-teacher conferences may be scheduled at any time by the parents or the teacher by contacting the school office</u>. Parents are strongly encouraged to meet with their children's teachers routinely and to correspond by e-mail or by pre-scheduled meetings. Additionally, CCSA annually hosts an opportunity for parents to meet with teachers at the conclusion of quarter 1 and quarter 3.

#### FINES/DEBTS/FEES

Occasionally fines or debts may accumulate which could include loss of books or damage to school property. The school office will send statements to inform you of any outstanding charges. Payments should be made directly to Classical Christian School for the Arts when they are due.

#### WITHDRAWAL POLICY

To withdraw a student, the parent or guardian must notify the school office and complete a withdrawal form. Completed withdrawal forms are to be submitted to the school office. Students need to turn in all textbooks and other school property to the school office. Records will not be released until all forms are completed and all financial matters are resolved. If the student is expelled, tuition through the quarter in which the student was expelled is payable immediately. The school will not release student records to another school or to parent(s) until all financial obligations have been paid in full and all school materials have been returned.

#### SCHOOL HOURS - ARRIVAL AND DISMISSAL GUIDELINES

School is in session from 8:00AM - 3:00PM Monday through Friday. Students should arrive no later than 7:50AM to ensure classes begin on time. If you wish to walk your student to the classroom, please park in a proper parking spot. Do not leave your car unattended in the drop-off line. Do not park in front of the school doors. Students must be picked up promptly at 3:00PM. CCSA does not assume responsibility for students dropped off before 7:30AM or not picked up by 3:15 PM.

#### **TARDINESS**

Parents understand the importance of arriving at school early in order to avoid class disturbances. Excused tardies are given for the following reasons: Doctor/Dental visits, traffic situations that result in a large number of students being late. All other tardies will be considered unexcused.

Three unexcused tardies will equal one absence. After accumulating 10 unexcused absences, parents will be reminded that any additional absences could result in possible grade retention of the student.

#### **DISMISSAL**

School ends at 3:00pm. Parents who have immediate needs or must pick up their students early are required to park in a parking space in the parking lot. Please call the school upon arrival and we will call your child to the office for dismissal.

Early dismissals will be granted for emergencies, and medical and dental appointments that could not be scheduled before or after school hours.

#### **ABSENCES**

It is the parents' responsibility to ensure that their children are in school daily.

Excused Absences: Parent or Guardian MUST call the school to notify the office of the student's absence. These absences are still reported with the student's total absences on the report card and transcript, but without penalty for makeup work or exams, if made up during the designated period of time. Examples of academically excused absences include illness of a student, death in the immediate family, unavoidable family emergency, pre-approved absences (available from Principal only). When a student is absent, he/she must present a note from the parents to the school office upon return. When a student is absent for 3 or more consecutive days for illness, a note must be presented from the child's physician. After accumulating 10 unexcused absences, parents will be reminded that any additional absences could result in possible grade retention of the student.

<u>Unexcused Absences</u>: An absence not reported to the school office by a parent or guardian on the same day of absence, any absence that does not fall under one of the above excused reasons, missing 15+ minutes of a class for an unexcused reason, running errands, personal reasons, employment.

#### MAKE UP WORK-PLEASE NOTE TIME LIMITS

Work missed due to an unexcused absence should be made up, however, no credit will be given for this work. Parents who feel they have legitimate, reasonable grounds for their child's unexcused absence may set up an appointment with the Principal to present the circumstances of their situation.

For an excused absence, students have one day for each day absent to make up work, regardless of the reason for the absence. Credit will be given for work submitted within the established timeframe.

For unexpected absences, students should utilize Renweb for missed instruction and communicate directly with the teacher(s) via email while absent. Please do not call the school office to request assignments.

#### **VISITORS**

All visitors must sign in at the front office to receive a Visitor's Tag. You are welcome to join your student for lunch or chapel but, as a rule, visiting the school during school hours is not permitted. If you would like to schedule an appointment with administration or staff, please email for an appointment. Please do not take your student's teacher away from the classroom during school time.

#### **LUNCH & SNACKS**

CCSA does not offer a lunch program. Please pack your student's lunch daily, ensuring it can be kept hot or cold throughout the day. Students do not have access to a microwave or a refrigerator. Any student found using the microwave or refrigerator without written permission from an administrator will be subject to disciplinary action.

CCSA does NOT allow student deliveries of food. If a parent wishes to drop off lunch for a student, they must park their car in the parking lot and personally deliver it to the front office. Administration will ensure the student receives their lunch. Students are not allowed to wait in the front office for their lunch.

#### **HEALTH AND NURSING**

Students who become ill or suffer an accident will be sent to the school office and the parents will be contacted promptly. Students who are ill during school hours will need to be picked up by the parents in a reasonable time. If we are unable to reach the parents, we will contact whomever the parent has listed on the application for admission as the emergency contact. In cases of serious injury, 911 will be called.

Any prescription or over-the-counter medication that must be administered during school hours should be accompanied by a written request from a parent/guardian. All medications must be in their original, properly labeled container. The school will not accept medication in unlabeled bottles or zip lock bags. Students are never allowed to keep prescription or over-the-counter medications in their personal possession while on campus, including lunch boxes, personal bags, backpacks or lockers. If you wish to keep Tylenol, ibuprofen, Tums, etc. for your child to use upon occasion, be sure it is clearly marked and brought to the front office. Parents are encouraged to inform the school office regarding any infectious or contagious disease. Scoliosis screening for students in Grade 6 will be provided annually in accordance with the State of Florida guidelines.

Students receive quarterly recognition for outstanding achievement in numerous areas.

Honor Roll Recognition is given to students who receive all A's and B's

Principal's List Recognition is given to students with all A's

#### **HOMEWORK**

Homework assignments are not optional. Any assigned homework will be meaningful

and not homework for homework's sake. It may include preparation for a lesson, reinforcement of an area covered, or aid for a student in an area of difficulty. Completing classwork is not considered to be homework unless assigned as such. Homework is required to be completed and turned in promptly on the day that it is due. Students in grades 2-5 who do not submit their homework may be held in from recess to complete the work. Homework is a vital part of our education program and all homework assignments are mandatory. Teachers will maintain effective communication through the use of Renweb so that parents will be aware of assignments given on a daily or weekly basis. Parents are asked to check Renweb for homework assignments.

\* Late homework will cause students to lose overall points in class.

#### ACADEMIC PROBATION

If a student's cumulative average for the quarter falls below a 64% average, he/she will be probated from sports until the grade average has been elevated to a 70%. Students must maintain a GPA of 2.5 to play team sports

#### STUDENT RETENTION

- Retention of students in kindergarten will be at the discretion of the teacher and the administration.
- Retention of students in Grades 1-4 will be determined by the academic and social progress of each child at the discretion of the teacher and the administration.
- Students in any grade who fail two subjects for the year will be retained.

#### GRADUATION REQUIREMENTS for HIGH SCHOOL

- 4 Credits each: English, Math, Science, Social Studies
- 2 Credits of a Foreign Language
- 20 Volunteer Hours

#### **DISCIPLINE POLICIES**

CCSA expects students to follow directions, be courteous and honest, and to be respectful. Respectful with and towards their classmates and fellow students, respectful of the classroom and learning environment, respectful of the campus and buildings, and respectful with and towards their teachers. Students who are not able to meet these expectations, follow the code of ethics, follow this handbook, or follow the specific rules set forth by teachers and classes will face school discipline. School discipline, depending on the offense, may be assigned any of the following forms of discipline at the discretion of school administration:

<u>Lunch Detention</u>: Students will be given the task of ensuring the Cafeteria is clean and

tidy for one week.

<u>Before School Detention</u>: Students will report to the Third Grade Room promptly at **7:10 am** and will remain there until **7:50 am**, writing the CCSA Code of Ethics.

Parents will be notified of detentions at least 2 days in advance to ensure time to make necessary transportation arrangements.

After a student has been assigned detention 3 times for the same infraction (ex: dress code violation) the student will serve an In-School Suspension for each following infraction

Students who have been assigned three In-School or Out-of-School Suspensions will be placed on Probation. While on Probation, a student may be asked to leave CCSA if an additional infraction occurs.

When assigned to serve an In-School or Out-of-School Suspension, any work that is missed, not taken or due on the day of suspension will be given a grade of zero and is not eligible to be made up or retaken. In-School Suspension is considered an Unexcused Absence and will count towards the total Unexcused Absence count.

#### **UNIFORMS AND DRESS**

Basics: A student's appearance reflects their values. That which is visible often reflects and represents that which is not visible. We do not want your child's appearance to conflict with the values of CCSA.

#### **ALL STUDENTS:**

All clothing should be in good condition and not in need of repair. Shirts are to be tucked in at all times. Long sleeve t-shirts are not allowed under short sleeve uniform shirts unless they are the same color. Students may only wear school uniform shirts, polos, sweaters or sweatshirts with the CCSA logo in the classroom. School uniform shirts must be worn under sweatshirts. Hats, doo rags, and head scarves are not to be worn in the school building or at school related activities. No "slides" are allowed to be worn in the school building. Boots are not allowed in the classroom but may be worn outside in inclement weather.

HOODIES ARE NEVER ALLOWED TO BE UP INSIDE THE SCHOOL BUILDING AND AT SCHOOL RELATED FUNCTIONS UNLESS THE STUDENT IS OUTSIDE DURING INCLEMENT WEATHER.

#### **Prohibited Attire for Boys and Girls:**

- Clothing that promotes violence, hate speech, drugs, alcohol, or offensive language or imagery.
- Excessively revealing clothing, including but not limited to strapless tops, short

- shorts, or clothing that exposes undergarments.
- Attire associated with specific subcultures, such as goth or similar styles, that may include excessive dark makeup, spiked accessories, trench coats, chains, or other items that could disrupt the educational environment or pose safety concerns.
- Hats, doo rags, head scarves, leg warmers
- Slides, Crocs, Boots
- Tattoos are prohibited. Students are not allowed to draw on themselves.

The administration reserves the right to determine if a student is dressed or groomed appropriately. CCSA requires uniforms for all students in all grades. Students need to be fully dressed and in compliance with the CCSA dress code upon arrival on campus. School uniforms may be ordered through the school website <a href="www.ccsa.us">www.ccsa.us</a>. It is recommended to label uniforms with your student's name.

#### BOYS

- Navy blue twill pants with pockets limited to the top front and back; Cargo pants are not permitted. They may not bag or sag abnormally on the body.
- Navy blue Bermuda shorts, uniform style; Cargo shorts are not permitted. They may not bag or sag abnormally on the body.
- Plain, basic blue jeans. No rips, tears, holes, jewels, beads, graphics, art, designs, frays, excessive fading, jeggings, must not be skin tight. No blue jeans shorts allowed.
- Red, white, or navy polo shirts with CCSA logo; shirts must be tucked in at all times.
- Shoes must be enclosed at the toe and the heel. Shoes may not be mismatched. Solid navy, white or black socks only.
- Gym uniforms are required for P.E. and sports but may not be worn on other days.
- CCSA Sweatshirt.

#### **GROOMING FOR BOYS**

Hair must be combed and kept above the collar; it must be neat in appearance. Hair may not cover the eyes. It must not create a distraction to the learning process or interfere with vision. Mohawks or designs cut into hair/scalp are not allowed. Any student who does not exercise good judgment with regard to what would be considered appropriate for school will be asked to leave campus and not permitted to return until it is fixed. Unnatural hair colors are not permitted. Hair needs to be one color. Face must be clean shaven with no facial hair. Boys who arrive at school unshaven will be issued a detention. Sideburns must not extend below the bottom of the ear. Boys may not wear earrings or other body piercings on campus or at any school-sponsored events.

#### GIRLS: Grades K-5

• School Uniform: Navy skort or jumper. Skorts must be no more than 3 inches above the knee and worn properly with the zipper done up and the waistband buttoned.

- Red, white, or navy polo shirts with CCSA logo. Improperly fitted shirts are not permitted
- Plain blue jeans. No rips, tears, holes, jewels, beads, frays, excessive fading, jeggings, must not be skin tight. No blue jeans shorts allowed.
- Shoes and sneakers must be enclosed at the toe and the heel, with no more than a 2" heel. Shoes and sneakers must be a solid color and match.
- Socks are required. Socks must be a solid color of navy, black, red or white. Leggings must be navy blue or black, only to be worn underneath skorts.
- Gym uniforms are required for P.E. or sports but may not be worn on other days.
- CCSA Sweatshirt

#### GIRLS: Grades 6-12

- Red, white, or navy polo shirts with CCSA logo. Improperly fitted shirts are not permitted. This includes shirts that are too tight and/or too short.
- Plain blue jeans. No rips, tears, holes, jewels, beads, frays, excessive fading, jeggings, must not be skin tight. No blue jeans shorts allowed.
- Navy Bermuda Shorts
- Navy Joggers
- Shoes and sneakers must be enclosed at the toe and the heel, with no more than a 2" heel. Shoes and sneakers must be a solid color and match.
- Socks are required. Socks must be a solid color of navy, black, red or white.
- Gym uniforms are required for P.E. or Sports but may not be worn on other days.
- CCSA Sweatshirt.
- Modesty dress guidelines: Skorts, skirts or dresses worn on or off campus at school related events must be no shorter than mid-thigh in length. No cleavage or tight-fitting tops.

#### **GROOMING FOR GIRLS**

Girls in grades 7 and up may use moderate makeup. Fingernails may be 1" long only. Nail polish may be pink, red, or clear. Perfume may be used sparingly. Unnatural hair colors, including fairy hair, hair tinsel, and glitter strands, are not permitted. Earrings must be limited to no more than 2 per earlobe and may not be worn on any other body parts. Earrings cannot exceed 1" long. No stickers of any kind are allowed. This includes but is not limited to pimple or acne patches. Bracelets and anklets must be appropriate for a school setting (dog collar and/or spike style is not allowed).

#### **WINTER GARMENTS**

Hats or coats may not be worn in the school building at any time; sweaters with the CCSA logo or the CCSA sweatshirts may be worn inside the school building.

Any student who brings a weapon of any kind including knives or any item that could be used or mistaken for a weapon will be suspended until the administration has ample time to determine whether or not the student should continue at CCSA.

#### LOST & FOUND

All articles left on campus will be placed in the Lost and Found. Unclaimed items will be disposed of periodically. CCSA does not assume responsibility for damage to personal property or lost items. Please be sure all jackets, sweaters, sweatshirts, and other personal items are marked with the student's name.

#### **ATHLETICS**

Student athletics is a privilege. A CCSA student is first and foremost a student, but also a representative of the school on the courts and the fields, home or away. High School athletes must maintain a minimum cumulative GPA of 2.5 to be considered eligible to try out for a sport or to be placed on the team roster. All athletes will sign an "Athlete Contract", in which they understand they will be models of good behavior in the classroom and during athletic practice or competition. Any infractions in the classroom or at school-sponsored events may result in the athlete being "benched" or removed from the roster.

All students participating in CCSA athletics are required to have proof of insurance, a current medical release, and a Sports Physical, on file in the school office.

#### **ELECTRONICS AND TOYS**

Cell phones, Smart watches, headphones, Airpods, electronic toys and such items are not permitted to be in use in the school building. If a student needs to bring their cell phone or other electronic device (including headphones) to school, it is recommended that it be locked away in their locker or given to the front office to hold until the end of the school day. All electronics should be off and put away at 7:55AM.

If a student is found with their electronics turned on or out of their pocket/backpack, etc during school hours, the cell phone, smartwatch, or airpods that are out and being used during school WILL be confiscated by teachers and staff and given to the principal. The student will serve a Before School Detention. The confiscated electronics will only be returned to a parent or guardian. No exceptions.

#### WEATHER RELATED INCIDENTS

CCSA follows the procedures of Pinellas County Schools'.
