NOTICE OF RACE 2022 MARINA CUP SERIES

Invitation:

You are cordially invited to participate in the 2022 MARINA CUP SERIES (the "SERIES") to be held from June 16, 2022 through Mid September 2022, and sponsored by the Dillon and Frisco Marinas, with support from the Dillon Yacht Club, which are designated as the organizers and hosts, respectively.

Eligibility:

The Series is open to all sailing yachts that are currently docked, moored or dry stored at the respective marinas. In addition, all yachts and competitors must meet all requirements set forth in this Notice of Series, and have signed the participant waiver form in order to become a Series participant.

Crewmembers and helmspersons, are not required to be members of their boats class association.

Rules:

The Series and the individual races that make up the Series will be governed by the rules as defined in the 2021-2023 Racing Rules of Sailing and this Notice of Series.

In accordance with the Notice of Series all yachts must have a sufficient cooler that properly chills the necessary beverages for competition, knowledge of at least the first names of all crew members and be on a first name basis with the Principal Race Officer. Spot inspections maybe conducted at any time throughout the series for compliance.

All yachts must also carry aboard the proper number of life jackets that meet USCG standards for each crew member.

Sails:

Must be used for propulsion whether it's for forward, sideways or backwards movement.

Entry:

Each yacht shall sail by on starboard the transom of the RC boat and check in before the evenings races. If a boat is checking in and representing the Frisco Marina, please identify yourselves otherwise the RC will score you as representing Dillon Marina.

Racing Fee:

No fee is required to enter each race or series.

However, it is encouraged that each boat owner considers at least a Social Membership to the Dillon Yacht Club for \$50.00 and the one-time initiation fee of \$50.00 has been waived for these competitors. Schedule:

There are 26 races schedule to make up the total race series.

June 16, 23 & 30 July 7, 14, 21 & 28 August 4, 11, 18 & 25 September 1 & 8

Racing:

Up to two (2) races will be scheduled for each Thursday. Racing will be windward/leeward courses or variations thereof. The RC may change the racing format to a Pursuit Race and will be announced to all competitors.

Series Scoring:

Each race will be scored and tallied throughout the summer to determine the overall Series Marina Cup Champion. One race can constitute as a Series scoring.

If Ten (10) or fewer races are scored, then no scores will be excluded. If eleven (11) races are scored, each team's two (2) worst scores will be excluded.

Each participating boat is allowed one race day to be excluded for personal reasons. They will be allowed to be scored as to their average score throughout the series. This date must be announced to the RC for proper scoring.

Weekly Prize:

We will tally which marina the winning yacht is representing. If from Dillon, Dillon gets one point, if from Frisco, Frisco gets one point. The marina with the lowest amount of accumulated points at the end of the series, wins the series.

Series Perpetual Trophy:

An overall Marian Cup Series Trophy will be awarded to the winning yacht for the lowest accumulated scores. This trophy is to remain with the marina for which the yacht represents.
