- 1. Treasurer Report

- 2. Director's Report
 - a. Spielman told the board that the camps will not be in session this summer due to financial losses.
 - b. Paint has been purchased and started at the site of renovation.
 - c. We need quite a bit of mulch at BPP again. We also need a lot of rock for the drive at the end. Spielman would like to explore speedbumps. As we see increased traffic, even with our new speed limit signs people are driving very fast. Kamm suggested speaking to Ace in the Hole to get their input.
 - d. The Park District received the safety grant again this year. Spielman used it for the kids safety signs.
 - e. Spielman was unable to attend the most recent library meeting, but will be participating in the next.
 - f. With the cancellation of camp, Spielman suggested moving the GaGa pit to Brighton Park. She has a troop ready to install.
 - g. Spielman has been working with Brockhouse to evaluate options and pricing for pool concessions.

 - b. Brockhouse will be purchasing chemicals at a lower cost than previous years.
 - c. Brockhouse is considering muriatic acid replacements.
