Tax Levy Ordinance/Truth in Taxation Hearing	Treasurer Garber presented the Tax Levy Ordinance and discussion/review ensued. Kamm made a motion to approve Ordinance 20-21-03, the 2020 Tax Levy Ordinance. Driskell seconded the motion. Damian Baumann, Myranda Driskell, Andrew Kamm and Matt Bidne voted in favor. None voted against. Kerry Brock was absent. Motion passed.
Brighton Park Drainage	Discussion about the drainage issues, ownership, and easements were discussed in light of documents in tonight's packet. Bidne requested that Spielman establish a conference call or virtual meeting with William Conner, legal counsel for the Park District. The commissioners in general expressed a willingness to accept a limited amount of cost sharing but felt the decisions and direction for proposed work should be determined by the Village. They will look to legal counsel to consider the specifics of any agreement.
Vehicle discussion	Spielman spoke with the commissioners about the usefulness and money-saving aspects of a used, older dump truck for the Park District and various ways this desire could be met. Discussion ensued.
First Midstate (bond)	Tabled at this time.
Electronic Collaboration	Tabled at this time.

New Business

Pool Property Offer	Bidne has been contacted regarding the possibility of purchasing a large portion of the parking lot for the swimming pool from an agent for an undisclosed purchaser. Some discussion ensued, and Spielman and Bidne will collect additional information on if the remaining parking is adequate, who the purchaser is, and if the Village President would like to comment.
