

THE ROAMING NOMI CONTRACT

ALCOHOL POLICIES

Legal Age & Identification

It is illegal for anyone under the age of 21 to consume alcohol at any event. We suggest that all guests have a photo ID present; the state of Michigan law requires all patrons to show proof of age at time of service. We have the right to refuse to serve anyone at the event who appears excessively drunk or uses threatening or abusive behavior towards staff or guests. We will also refuse to serve anyone who attempts to provide alcohol for someone under the age of 21. The bar staff reserves the right to close the bar at any time if they feel the behavior of guests are threatening or unruly and may cause harm to others or property. The decision on such matters will be made by The Roaming NoMi staff.

Alcohol Not Included

Our packages do not include alcohol. You will need to purchase anything that will be served at your event, we will take it and handle the rest. We can help provide you with tips on how much to provide and how to make it a smooth process. We also can pick up your order upon request.

Serving of Alcohol

Only the bartenders of The Roaming NoMi or servers from another catering/bartending service may serve alcohol at the event. Clients and their guests are not allowed to bring and/or serve outside alcohol. Outside alcohol will be taken and kept behind the bar. Outside alcohol will not be served UNLESS (1) you, the hosts, authorize the serving of said alcohol and (2) if payment for an upgraded package is agreed upon. Whole bottles of wine and pitchers of beer will not be served to guests.

Inside the Mobile Bar

Only Roaming NoMi staff are allowed in the mobile bar. If you'd like photos taken inside the mobile bar, arrangements may be made before or after the event. If guests are entering the mobile bar, taking alcohol from the bar, or causing any damage to the mobile bar, The Roaming NoMi reserves the right to leave the event immediately and no refund will be given.

Release of Liability

The Roaming NoMi is cautious and observant when serving alcohol to guests to ensure a fun and safe environment. The Roaming NoMi is not responsible for any individual who may become intoxicated or for any damages that may be caused by an intoxicated guest. Event host is liable for any and all alcohol-related injuries or accidents during or following the event.

SERVICES PROVIDED BY THE ROAMING NOMI

The Roaming NoMi will:

- Provide compostable cups and napkins for all of the beverages we provide.
- Supply non-alcoholic mixers (soda water, tonic water, coke, diet coke, 7up, ginger beer), syrups, garnishes and fresh juices needed to make the cocktails that have been pre-selected.
- Provide all ice for all cold beverages served out of the trailer, the beverage dispensers, and the self-serve non-alcoholic station.
- Be responsible for all setup and take down of the trailer and bar.
- Be responsible for ensuring that no underage patrons are served alcohol from the bar. The Bartenders will also use their discretion to cease serving patrons who are visibly intoxicated, behaving inappropriately, or who may pose a risk to themselves or others.
- Provide professional service for the duration of the party unless additional hours are added. If additional hours are added prior to the day of the event, such agreement shall be discussed and agreed upon beforehand and an additional cost will be added to your invoice. Additional hours cannot be added the day of or during the event.
- We are NOT responsible for busing glassware or disposing of glassware during the event. We are not responsible for on-site garbage removal.
- We will remove all garbage/bottles that we use in the bar during the event, including empty alcohol bottles. We do not have the physical capacity to take and dispose of anything we do not bring to the event.

CLIENT RESPONSIBILITIES

- ❖ It is the client's responsibility to have a plan for garbage disposal. Trashes need to be emptied throughout the event properly and at the end of the event. This duty is not performed by The Roaming NoMi. The trash cans should be provided by the client or rented.
- ❖ At the end of the event, there needs to be a clear path for the truck to be able to pull the trailer out. It is the client's responsibility to make sure there are no tables, chairs, etc. blocking in the trailer.
- ❖ Additional insurance of any kind required by the venue will be paid for by the client. The Roaming NoMi will already be providing General and Liquor Liability Insurance.

FEES & EXPENSES

Deposit

To reserve your date, a \$175 deposit is due upon signature of this Agreement. This deposit will book the specified date for the event and is NON-REFUNDABLE.

Final Payment

- 60 days before the event, the client will pay for the hourly rate. The hourly rate for The Roaming NoMi is \$175/hr.
- 30 days before the event, the client will pay the remaining fee which covers the price per guest fee, any additional services, and gratuity.
 - Price per guest depends on the package chosen. This ranges from \$3-\$7 per guest.
 - Gratuity is equal to 18% of the total price of the hourly rate and the per person rate.
 - Additional services: Additional cocktail server = \$50/hour, Generator = \$150, Pick-up/Drop-off of stemware = \$50, Traveling outside of our 40 mile radius = \$0.75 per mile each way. Additional fees may be required to cover hotel costs if the event runs late and is far away from Traverse City.
- The \$175 deposit will be deducted from the owed amount.

Postponement Fee

If for any reason the event is postponed to a future date clients will be charged a 25% postponement fee.

CANCELLATION

In the event of cancellation, the initial deposit to save the date is non-refundable. If the event is canceled within 30 days of the event the full amount will become non-refundable.
