The use of anonymity in Government Services is not permitted, nor ever has been and this shows the level of collusion between state, actors, and technology teams. In a totalitarian state, anonymity is fundamental to success for the avoidance of prosecution, creating the time necessary to enjoy their 'takings'. Here and later, I will further describe my observations in the hope that the psychological department can educate me well enough to appropriately label and develop the contingent human manifestations.

These tyrannical members teams *de facto* accept there is a fall guy and a scape goat which they use to confuse subjects by playing piggy in the middle. By using various mediums of communication, they accomplish confusion and timewasting or the exploitation of public expenditure using a 'constructive waste of time'.

The agreement to use of anonymity's importance to them (by winning passive consent or commitment) collectively avows members to collude *and* feel the obligation to provide cover. Enforcement of that collusion is collectively coordinated by coercive group behaviour (by leadership

directives/approval by ignoring suffering) follows and causes a radicalised 'leadership formation' to arise, creating the group behaviour of collective compliance. The external label would be a 'mob'. This becomes apparent when two or more separatist groups are compared, by contrasting the juxtapositions of common behaviours.

Dissidents of within groups (objectors or those alarmed by the groups inhumanity) are selectively managed by bullying or victimisation until marginalised or groomed. Grooming with antagonization is to create the aggressors by inflicting suffering on them; deceiving the onlookers as to the truth behind the group subversive activities. They are the side show. The dissident is the victim, often the first out or injured by the mob justice of the group. The bullying keeps them in check with the survival needs of the group. These dissidents of the mob should see themselves as fortunate. They are excluded from the prosecution of criminal behaviour because the mitigating circumstance of bullying is apparent. A psychologist can easily identify who the dissident victim is.

These intergovernmental groups create separate funds or trusts where they can access resources (money/people/materials/fantastical immeasurable labels like emotion) to accomplish tyrannical ambitions. Everything has a price and value to them, and a value or number devalues the actual human value of say, effort. They use dehumanising language like 'key performance indicators/targets/goals' All descriptors which have nothing to do with a government office. They are military or sporting terms. This language shapes the environment and it is inappropriate to use such terms when people are sick, weak, injured and in need of help. One can only conclude the intelligence meant them to exasperate all operating in the department.

Change and growth makes tyrants uncomfortable because they cannot cover the criminality emanating from their activity, even if it is done with naive negligence. The emotion of shame outweighs the exposure of accountability having the effect of them deciding to continue with dangerous behaviour. Being power driven and adverse to competency, risking independent thinking could result in a loss of control over the scape goat and fall guy or worse, exposing of the groups individual collective criminality.

Quick Release Thinking – That Fish Is Too Small To Feed 6 of US

Only freedom to think, choice and govern one's own life can ensure that person has equality to opportunity in civil life. Without the freedom to choose good things which are inconsequential and only complementary to development, maintenance of tyranny is easy.

The Jordan Peterson Effect

Thus, people become imbued in tyranny and its associated behaviours; authoritarianism, aggression developing into totalitarianism. This means that becomes the acceptable standard and systemic culture which becomes toxic and dangerous to human growth. The point of totalitarianism, the end of education and the avoidance of their failure being observed by those more competent. It's a fear driven behaviour.

These large separatist groups become desensitised to the effects of their behaviours and consequences. They have rules and guidelines. They rely on those to escape what is personal criminal liability.

They eventually exasperate the defences by creating interior conflicts. They distinctly believe that they can fake it until everyone else believes it. This does work to achieve internal targets and it fails when innocent citizens get hurt or killed. That being the reality, this is why it is being confronted. They do experience group delusions of greatness.

Snap Back to Reality – We are Talking About Anonymity

Let me offer you assurance that the most powerful technology was used in all government laptops, on site and in telecommunications that can pinpoint where any person was at any time. It is such an important bit of technology that it can overlap conversations and play them to evidence and make inescapable any evidence. This was pointed out all along and I personally made it absolutely clear.

This means, names were never required on the front face. Tech and Mi5 ensured that officers were made safe to protect officers when at home by concealing names of the claimants front end. On the back end, clearly it was clear as to who the user was. The reason claimants did not know full names was because ‘officers feared the claimants. Under the Health and Safety at Work Act 1948, the employer has to ensure your safety. It had the adverse effect of making agents feel overconfident and they further degraded claimants online and to their face. been hard work and ruthless on you and your life. We are here supporting you. If you need to know, Zen lost everything and if you still have family, a house, a mortgage, a pet, money in the bank, friends, a rented house – she has none of that because of the full assault that happened because of the overwhelming amount of force used. That was for some of your entertainment, and I get to hear what some have said. I laughed, because I am aware of my duty to protect life and really do care about you. Apologise if you must me. That will be well enough. I am sure since I was forced to leave, no one came close to what we achieved and for that I am sorry. As you might be aware my role is broad, and it cannot be ridiculed by a single or even national team. All is forgiven my end.

The McRaven Frog Float

The governments ultimate driver was minimising of threats to uninstall the Rogue State (engineered installation of political leadership worldwide to regain initial investments and ensure family names remained in power). That is a separate and massive subject.

The government being financially unprepared for this is part way evidence they meant to bring on the famine we face and they too will endure the effects of their crime in the punishment they receive.

The government knew that they could not meet the increasing social welfare and health care bills (caused by exasperating poverty) thus they used Universal Credit System to expediate the death of people by keeping welfare payments to under any minimum living wage.

The fact we as a country cannot generate an international income, and our partners refused to let us leave, delayed it as long as possible, and the Government and their hate sponsors still put the knife in, is proof of intent and suffering. They are aware the Government used Office of National Statistics to sell people for medical and chemical weapons (or biological) experiments.

Here I thank, briefly our colleague Maajid Nawaz, for his professional journalism and suffering, put to good use and wisdom, that peace is a product of great historical contextualisation and critical thinking. The Government systems used equality and diversity disclosure on application forms (including social welfare claims) to effectively allow the targeting of people by tampering with others implicit bias. They made by enforcing disclosure the effective targeting people on matters of dignity and privacy of which, if it was true equality, it would not have been asked for. In all we do at the OSJ Ltd, it is not asked for. This is because humans are vulnerable to bias and, we take privacy so seriously, many people would think the Director ignorant. It is an example of equality and the refusal of the director to create oppression nor impress limiting beliefs of a human who has limitless potential.

The government systems have been proven to propane hate speech and from their high office, encouraging such behaviour in the media. They are also wanted for misappropriating/exploiting intelligence services funding, head hunting to bribe by private hire and threatening intelligence staff.

The Government may be multicultural looking but are all united in the fascist and authoritarian outcomes of money in their culture of death. Poor and sick people are expendable if we are to judge by their activity, and with that, we can also draw the conclusion that they are unfit for such office, managing high calibre officers nor to have the safety of the public interest entrusted to them. It is all part of them devaluing people and diminishing their self-worth in difficult circumstances.

The politicians believe in the equality of the outcome of death/mortality and are the most seriously dangerous extremists on Earth. This is to keep them under budget. It is understood that they may engineered a commercial solution to profit from the people to prevent the party and the treasury going bankrupt. That still not politics. They silently agreed that killing their own (the slave master mind in everyone of them) by ultra-aggressive and ultra fascist Home Office Ministers who had no problem with harming their own Whitehall staff to inspire fear. Here, I rely on our associates Sue Grey and Simon Casey who have carefully managed bullying and harassment complaints from staff

who could at the time, not prove why the interference and threats in their private lives was prevalent as they went about their course of work.

At another ground benefit claimant level, it meant soldiers/prisoners of war returning from war (from any side) could have been managed or further victimised by a person insensitive to their reality. That injustice of inequality to inspire interior domestic conflict on peaceful soil then would have control over their life outcomes and powerful influence over them. Domination, the temptation to have illegitimate power over others, is intoxicating and can appear to an aggressor as curative.

The record shows the front face of how multi agency working can be used to selectively annihilate the vulnerable, of who the state owes their pledge of safety. This includes, children's homes, health settings, policing services and family courts. It is a rat's nest of collusion and deceit whether that was a private DWP officer or for the mass slaughter of say sections of Muslims or Christians. It is one dark place. Here are some of the antics that came out of that office and its stringing:

- Staff Username and password used abroad to target individuals or groups/The rent or hire of the same.
- The sale of identity such passports or impersonation of a dead person (hence how illegal immigration has flooded through the system – the person they purport to be is deceased, they victims from other countries and that person desecrated). European DNA Data bases can identify anyone and thus that will be happening whereby suspicions arise.
- Dead people signed up and claimants pay sent to other accounts.
- Laptops used at gun point intimidating officers when forced to work at home.
- Sex Offence and traffic rings track and trace to stop victims reporting crime against them or to blue murder them in the state. Called funnelling them through the system.
- Foreign Offices Abroad targeting British Soldiers and ensuring their prescriptions were tampered with or during cervical and prostate examinations they were internally damaged to increase chances of cancers developing.
- Sponsored rape and abuse online and in life of family members
- Enforced prostitution.
- Arranging FGM and MGM of males and females in hospitals to conceal the crime or under reporting of abuse that would require such an operation to save their lives.
- Blackmail of service personnel
- Family harassment or stalking of those who left their faith or had preferred sexuality that was considered unorthodox or matter of shame.
- Appointments used to capture, and honour kill victims.
- The enforcement of unobtainable appointments and sanctioning of the sick and injured.
- Unfair dismissals from posts in office where whistle blowing happened, or their property and life being put at risk or threat.
- Enforced religious conversions and political influencing.
- Identity theft, slander, and malicious online networking
- Theft of government property and funds
- The abuse of unregistered children for slave operations (factories/sex industry)
- Officers taking broker arrangement fees to apply for advances and making illegal entries on applications to exploit claimants.

- Polygamous spouses/marriage agents working in scam teams to target, extort and manipulate female dependence, enforcing religious conversions, gay conversion, enforced marriages or to satisfy debt in the sex industry or to inherit property and land.
- Simms – the backend chat system of the DWP used to slander, defame, and augment bigoted perspectives of individuals to inflame group egos or an individual's authority within the workplace. This was also used to target and victimise co-workers with prejudice to limit opportunities, for amusement or self en-glamourisation.

Advice for any Serving Officer in any Office of the Land – Even if You Were Born In Another Country

The abuse of DWP Officers by creating an unstable atmosphere of reliance on web browser information, micro management and the division of natural officer relations to sustain autocratic control had many experiential games.

Management may have had insights into the relevance of targets and can be held negligent for employment mismanagement. They will find themselves without reasonable defence if they have colluded to manipulating staff behaviour, targeting individuals to exploit obscured targets.

Middle management may not be aware that their requests for compliance are challengeable by officers who are the enforcers of the law. Thereby, they can deep search managements motives, competence and understanding of motions, targets, or anything else that affects the function of the office.

Police Officers do have implementation powers of holding any management to account, up to and including the arrest or detainment of them; until such time they are proven to be operating in the capacity of their job description and not for any gain of function whatsoever.

Floor DWP Officers are encouraged to demand transparency. To refuse to implementation of orders that inflict harm, the reliance of last orders, or last licit orders, to maintain the offices integrity. That is to protect the public from the harm of poverty.

Website instructions are considered unofficial and ignorable because they do not spouse from direct formal training, of which is where every and any standardised process dispenses from. They are also imperviable (live hackable) allowing real time doctoring of state rigor. It's illegal to not have printed assets, or to not be able to access them. Evidence must be tangible, and entire with integrity. Indirect orders (unwritten or unpublished by a third party publisher) are considered informal and thereby void, considered extortion of the employer. They are in effect factless. In this case the employer is the home office. Officers can indeed remain at their positions to fulfil their contractual obligations and refuse to comply until formally retrained or updated by identifiable instructors who have the present directives.

For example, in a court all evidence must be admissible (with integrity and real), often agreed with an affidavit (a human testifies its truth). A computer screen or repeating 'they said do it' simply means you are a co-conspirer to the crime. You indict yourself. Thus, the advice I am giving you is for your ongoing remedy and not a whitewash of nonsense. It is for the sake of the ship, its ability to sail life hereafter.

To be clear. The agreement a claimant has does not in any way disavow the state from their obligations. This means it is the officer's duty, with an authentic claim, to never intercept payment of any kind. That a means they must be paid, regardless of what they do, even until proven dead. To intercept that sacred transaction of ensuring life or tampering with a necessary amount to survive, surmounts to conspiracy to murder.

Strong and defiant officers who will challenge the state are essential of the nature of the state. Be one. This prevents the state from being tyrannical and the misuse of staff with bias, in a vulnerable situation themselves (being public facing and having only enough to survive to create the steps of poverty or castes), as you see is how they set you on innocent victims.

Sanctions are a term used for foreign policy and cannot be applied to foreign nationals, which is how it has been abused. Thus, sanctions are illegal, meaning any person implementing them is committing the crime and the Government becomes innocent of that guilt. The use of guidelines is not a defence when the law presides, and it does. They are there to be broken if the officer themselves is prepared to defend themselves in court under the Offences Against a Person Act. This applies to all and every case as well as and deceased, whereby the Crown Prosecution Service can elect to represent the person for their family or for the sake of judicial case law.

How DWP Officers Can Avoid Criminal Negligence

If a DWP Officer finds that they are accused or questioned under oath or by an Officers of the Law under Caution. Let me enlighten you.

Police Officers are the test of the law, if they are happy, you are not breaking the law. They are compelled to arrest anyone who is breaking the law because of the Breach of the Peace. They use the Policing Act to underpin their authority. The dispute between the two acts or to establish criminality means that an arrest (to seize a person) happens.

The first person encountered thereafter is a desk sergeant who meets the Arresting Police Officer and the Suspect. The Police Officer must explain why they have interrupted the peace to their sergeant in front of you and accuse the person with that information. The desk sergeant tests the sobriety of both parties and the rationale of both arguments (where on or the other speaks). A police Officer is not under and obligation to speak and can withhold silence after cautioning meaning both are put in a cell to settle the dispute in private. The sergeant does not have to note that or book them in. The cell becomes a place of dispute resolution, and they have 24 hours to agree a plan and settle that for the sake of the peace when released to their community.

Whereby the sergeant can see that would be dangerous to either or one is booked (to part them – the dispute remains theirs) and due process is resolved in the absence of the arresting officer. This is where a cooling off period originates. It is imperative that the public understand their officers and to go with it because they will remain free in the community, a police officer is always accountable for their behaviour. They/their life is 'commissioned'.

Both are at fault at arrest because it is not possible to arrest anyone without disturbing the peace by accusing someone. The desk sergeant becomes the adjudicating authority being the one with more experience.

By giving your name at the desk, you are admitting yourself into agreement that the desk sergeant can decide the course of justice, to maintain the peace because a) the officer might use excessive use of force to create the peace of b) it is wrongful arrest and there needs to be some distance to allow that to propagate.

If you say nothing, invoking your right to remain silent, the law is still being broken by the police and the police are obliged to establish the evidence within 24 hours, to continue detaining you in custody or hold you accused.

Therefore, if you are arrested do not freak out. Tell the Police officer the facts. Here are the facts to prove that you were inadequately trained and are not criminally negligent or maybe even a co-conspirator to murder. Someone committing suicide still has a cause and remains suicide being classed as unresolved murder. In the case of any death, there is always circumstances or persons who attributed the manifestation (caused) the death.

- The Employer has a legal duty to prove you are competent to the court. They do this by maintaining training records. To avoid **employer** negligence, they have to prove for insurance purposes and under the Health and Safety At Work Act 1948, that they have trained you to imperative detail and you have performed or demonstrated that you can consistently perform the task/responsibilities, to that training specification.
- Your employer may have given you a certificate or book to prove you were trained. That alone does not prove competency. Competency can be tested and must be recorded by the employer. Thus, a generic training session does not prove competence. The employer must prove that you were trained, and competency tested in the expected knowledge or skills (to safely accomplish the tasks) and that you have acquired adequate competency or can demonstrate the practise of under test conditions. Continuing Professional Development is the workhouse of competency.
- Hand any evidence to the police officer (not investigator). An inspector carries the authority of a police officer. You can insist on seeing their warrant or Police Identification. All officers carry Police Identification. Anyone who does not or claims to have deputised powers (devolved authority) does so at their own risk. Take heed. Real Officers have real ID. If you are arrested, you can even insist that you take yourself to a police station to prove they are real or for safety. Therefore, you show the Police Officer your qualifications, certificates, and any other evidence, especially grades so they can take copies and gather that to prove that the statistics of incompetence can be proven using a wider investigation team.

Here is not disclosed the detail or structure of competence testing to be able to gather the intelligence that puts DWP Officers in a position of innocence. Most of you are thoroughly knowledgeable in guidelines but not the law. The fact you were directed to follow guidelines over the law, maybe evidence. Keep it. Print it.

Your contracted job titles matter. There can be no such this as a Job Coach because there in a Government Office are only qualified officers. It has a grade and a rank. If people have been recruited and trained as a team or a persons and mis contracted them/you. This is gross employer negligence. Human Resources should know the correct the Job Title of Officers and that MUST BE INCLUDED IN ANY GOVERNMENT ROLE.

This would prove deliberate negligence, sabotage of a government office and a whole show more. That then degrades the person arrested to a witness and or a victim of criminal behaviour.

Suspended Arrest - Converting Public Information for Private or Commercial Beneficiaries

That means you are now under suspended arrest, are a victim or witness for criminal activity in a civilian capacity, and it might remain that way until it is proven that you as an individual has not been causal to injury or death or profited, benefited in any way.

Those who have exploited persons or information will be referred to the local or county or High Courts to have evidence tested as innocent or guilty. You are qualified and defined in law as to your contributory actions in the criminality. It educates the community as an assurance harm from state instruments can be stopped, in their interest, which is to live freely of otherwise criminally necessary actions to survive and thrive. True crime is where there is no need for a person to commit crime, yet they do.

These state mechanisms are called the ascension/procession of the law and it is there to protect civilians from ongoing illegal activity which causes undue alarm and distress. It enforces the means and space to allow lawful activity.

Court processes of hearings, tribunals may happen to ultimately dismiss most officers/employees of personal liability of criminal negligence; meaning the employer is responsible for your charges and regardless of if you did it or had a part in it, is in whole or part handed up to the war crimes court. This is how the Nurenberg Trails were conducted to bring about justice. You might be one of those oppressed. Be aware that your judgement of activity may seem over emphasised. The courts know more than you do and they need to maximise the innocent, prosecuting only the criminals complete.

Othe Procedural Activity That Might Spook You – Simply Be Well Mannered and Assist the Investigation

Police Officers might take sample evidence and ask who directed you to perform certain tasks to identify if you are under duress or have been under duress and how. This is so they can make recommendations to protect you as part of their community.

A desk sergeant can order group safety and impose on anyone in your offices anything necessary to make sure that groups of you come to no harm. They are pest removal specialists. It is rare; however, desk sergeants can walk into a DWP Office, find the floor manager, and impose on them bail conditions post their arrest using something called immediate effect. A Fire Commander has the exact same power and may accompany the desk sergeant. They have the power to challenge and

make safe any place of access their staff can. That is an exercise which is unquestionable because police and fire officers should be able to work in safety.

Whereby the manager refuses to be seen, insists on appointments and plays the toy with the police game, the sergeant can and probably will request commissions to cease and desist distress and alarm in enclosed or obscured places of government business.

Those arrest strategies undisclosed here and remains police/courts and bailiffs business. It is requested that understudy sergeants accept the most experienced will ask you to second in their roles (take the promotions) as they progress in this valuable experience gathering operation. Be prepared to accept deputised powers spontaneously if you are a uniformed officer. It is how the peace is maintained and police establish their dignity in communities. Enjoy the safety these people bring by going toes to toe with equivalent authority that has you under duress. If you need help or the police are not aware, request an appointment from a desk sergeant and meet them on your site. They will know what to do with some information. They do not know your managers; they have no personnel relations and are rock stars when you see them do this. They can help you and they are peaceful with their implementations. The same applies to DWP Officers. Some management might abscond and when they do, take the new secondment and experience gather. Work for ensuring the people often state have access to money and support must continue in a way which is uninhibited by any obstruction or intrusion.

Take This Advice – Police and Fire Officers Take Public Safety Seriously

Where criminality has occurred by DWP Officers, your authority is none. Resisting arrest will attract higher court penalties or sentencing. Use of force is already established and that is there is substantial suspicion and proof of corpses in their communities. They can and might use force. Please behave in a way that you wish to be treated because, if arrested, you will have to return to that community or be reliant on those officers initial and their testimony. Any act towards them is an offence against the state and it requires the justice on a national or local level. That is because this operation links into County Lines and those gangs are the direct influence which have diminished the police force (wasted police time) The police and fire service wish to establish the peace. Remain in the justice of the peace.

Establish Why Your Circumstance Were Mitigating

It is clear, threats, bullying, harassment, poverty, and oppression of all kind's has gone on. The police and investigation team need to know how to avoid these problems in the future. Show them about you, your life, where you live and let them in to understanding the devastation of the people who have hurt you. They will be upset or angry, that is their right to that emotion, and they will evenly distribute that in the works of justice they perform. If you have been harmful or evil tell them what enabled your evil, tell them honestly, completely as you can in an abbreviated form. Keep it relevant short and tight. They find it hard not to walk out in a fuzz ball of rage. Let them retrieve their authority and respects in your community. They are meant to be gentle giants not over authoritarian thugs. They are your community protection. Our police force is the oldest in the world and keeping

the peace is the business of the police, as much as being a deterrent to crime. All crime comes from poverty or the misplaced understanding of riches. Reform, or to get our communities into a position where that is not essential to survival is the ambition, joint if you see it.

Please continue to support these fine officers who are going after some of the world's most dangerous criminals who still may be mid flow of private operations that could threaten your lives of which we cannot defend if they are not caught.

Who Breaks The Law – Why Poor Ministers Use Mentalism – To Get You To Do it – Do Not

Being ignorant of the law or untrained is not a defence. The Officer is employed under the law, to uphold the law. Whereby that law introduced by a tyrannical or authoritarian government is enforced despite public protest and objections from the House of Lords, or the law is carried by use of force of statutory instrument otherwise; it is the signatory minister of that law and those who instruct its delivery who are liable.

It is some part of the office Officer or Minister to responsibility to be aware of the law they agree to uphold before accepting the contract. All Appointments under the state offices are responsible to the minister of that position and thereby have a means of directing accountability. That is supposing no benefit in any criminality aside the wages of the person has been a result of the engagement.

Police are the only office in the land who can make an arrest under suspicion and this gives them time to search the law to find the corruption, or law that has been breached, it or before the due time of the breach. No other office has that capacity, including Parliament, which is why in ascension laws to the House of Lords, the expression of floating is used. To be sure that there is no cause in the law which would breach the peace of the people causing any kind of dissention to it.

To be astute in the matter for the purpose of understanding all law in maritime law, the authority of land, in matters of a renegade, rogue, usurping or seditious government have an admiralty who impose the law on them. If they cannot stand upon the law they have imposed, they suffer the spiritual and temporal consequences, effectively being drowned for own incompetence or dangerous behaviour.

Thus, we find ourselves preening ourselves to ensure that what we do in mitigating circumstances that a renegade, seditious or rogue government has imposed, carries the upmost importance and why we swear to at all times remain true to that law, making it clear we are not joined with the mutiny the ship. It is the admiralty who deploy and secure the rescue of the good ship and crew, where necessary boarding it and putting into the brigg those task masters for 'theft of the ship'.

It is by fact a prerequisite for and government officer requirement that you are aware, personally of the consequences of the law even if you do not follow it, implement it or rupture it. This is so you know what your sentencing should be for corrupting the law and ensuring yourself that the judge themselves is not corrupted. The purpose of all of the rigging is to be sure that you are aware and

accountable at all times for your actions, and because we are free country, you have control of your destiny.

Corrected, Officers can make way to show they have now understood the law, (known as martialling or court martialling if it requires an authority to record and verify the need for correction) which would appease most sergeants, judges or war courts. This validation of competence of the law can be evidence for the avoidance of error in the future. Yet any arising of the same matter would be met with full and final penalty per officer offending the law. For the officers' errors prior to the dissent of the law, the home office minister respective at the time of being in office, must bear the full responsibility of every sanction and accept the punishment due, thereby giving example to officers. This having not been properly discoursed and them for example has led to the naivety of Officers who developed the same flagrant attitude.

This story is here to be completed by experts who can dissect the reality and bring prosecution to those very wealthy racists, religiously agoraphobic, authoritarians and fascists.

Write a Testimony and Submit it to GCHQ, Cheltenham

DWP employees will need testimony and courage to disseminate their experience and witness to ensure the delivery of the people that they are responsibility for. At all times, I remind all staff due process is assured in the equality of the law, representation where you need it, safety, and assurance that, given the circumstances you would not have behaved that way without extenuating circumstances.

The admiralities position here is to bring prosecution to the leadership (the captains and their lieutenants) proving their negligence which is a composition of terms between incompetent and competent. Meaning the errors or corruption, being interminable, and by the point of critical failure or damage, the vessel to be found stranded at sea and beyond recovery. There is no lesson that can be taught to that leadership, that would make able the ship to continue on a safe course without further endangering life.

It is understood like this. A ship is laden with life and cargo, including people and set to sail, on a course of which its direction must always remain on. A politic uses a manifesto. They must arrive at that destination wit only more than they left with, and this shows that they are allowed to fish for food, hunt the birds of the sky or take mammals from the ocean for training or for eating. It is a crime to waste food or resources on any ship at sea.

A missing manifesto or change/deviances in course (agreement on the reason for election) shows once orders of recourse are given for safety of life and limb, are given the assessment for loss of control. It is only a logical matter or determining whether that disobedience (or despondence or dissidence to the law that gives life) is out of incompetence or something that requires the admiralty to make safe the sea to recover the innocent life and arrest the illegal parties, who by then have formed a mutiny, proving they have commandeered the cargo for purposes other than directed.

We see inland and aboard our ship the government and their operations have sacrificed human life before disembarking cargo without due course or reason to beneficiaries, we the crew have no permission to deploy.

There are no ships logs to explain events, no accounts of deployment of resources or finances, and an accrual of wealth by illicit parties who do not have agreements to receive. another critical failing. The government, therefore are held accountable by a competent authority, the admiralty, who's responsibility it is to determine justice for the men and women of the vessel. What the admiralty have noticed is the variable agreements across smaller ships who seemingly have 'whilst at sea' negotiate the sale of cargo and people and their private assets', of which no captain has the right to deploy. Whatever the crewperson owns or brings aboard, legitimately owns. The contract is simply that the ship guarantee its safety on arrival with life, its owner.

The crew on the cascade of justice, and who have a right for recourse of justice themselves, have been impaired from rendering good and due service as obliged by their commissions; of which, they made good at all times to make do without becoming mutinous or arraying the ship. This determines them as sailors and not pirates (or ocean-going thieves). They have not followed the orders of a dysfunctional leadership. They have the right to abandon ship.

Meanwhile Somehow

You are safe to be honest. The government ministers have been informed already, most know they are under arrest and the justified use of RIPA to control their activity has been implemented. This is to prevent the obscuring of information and to ensure investigators can sift their way to direct evidence, causing a lawful prosecution. It is called a genocide because with the testimony and statistical evidence of mortality, it can be proven that groups of people were targeted and expensed at the will of a government seditious against its people and the House of Lords.

Meanwhile this report lacks statistical detail conclusions for the individuals concerned, what we do know is that wide media coverage on the Department of Work and Pensions employed and removed or resigned, has been managed by thoroughly incapable of sustaining life.

The last testimony will be those in power will admit they held that rank and role, with the likelihood that they will never leave prison and hold public office again.

The Position of Politics and Why Officers Can Relax Undertaking A Role that Deploys what a Healthy Government Should, Will and Can

Officers are reminded that viewing fascist activity through the eyes of any political class or organisation is futile. Politics has seen its end and as the country revolts and Ministers become independent to represent their constituents ridding the country of the oppositional class system; they will raise their localities interests to Parliament seconding the Parties interests to the end they should meet, a dead end. A Minister of Parliaments duty is to represent the interest of their office and ensure the deployed resources reach their people on the ground, ensuring the promise of the state is fulfilled at all times.

They government and party are mostly bankrupt and defeated by their squandering of money and lives of very threatening inside party members. As much as other Minister may wish to help, please leave that to military and the admiralty who will get them and your assets to safety. That is the defeat of fascism and you beloved people of our Nation, defeated it.

You Will Know When Justice Is Doing or Done

We are remained in the EU and thus we are using European Conventions because that must be used in International Court. In the main, the British Law has done the outstanding job of prevailing, meaning the evidence has been admissible and verifiably, ready to test against European Conventions. That then appears in contrast in the War Crime Courts of Courts (using Geneva Conventions) of Human Rights Courts. The persons accused (the person/s who hold the office and the authority of that office) will be summoned to answer as to their commands or the effects of their office. They will respond and to the accusations under the Geneva Conventions (A War Crimes Code) and the Nurenberg Conventions which are used to convert the evidence to the weight of the crime being handed to answer.

A judgement is then determined and where that converts to a charge like murder, manslaughter or otherwise that is remedied by the handing down to the highest court in the Land for sentencing and the responsible person serve that term. All of this is public. It is pursuant on media agencies to report this as part of the remedy and justice. Where they do not, bailiffs will commandeer media outlets and communications systems to ensure that the public are given their part of justice, which fulfils the obligations of justice. The public response is recognised as an appeal, be that riots or other displeasure and this assists the courts to appropriately house the criminals in such a place as to protect both rights to life. The public/societal right to life to enjoy freedoms as described in the declaration of Human Rights 1948 and the criminals' rights – which are seconded having proven that have committed the offence.

Last Warning To The Media

If you choose to continue to aggravate or influence or disturb the public or are being funded by any party with respective interest to the war crimes courts, you cannot be in contempt when you are giving evidence- anything you do or say as a journalist over the time the war courts in process can be and may be used as evidence. It means you are in a state of Perjury to lie, deceive, knowingly or not.

Your honesty and submission of evidence that brings prosecution will be recognised. Your work or evidence will have the protection of the court/s assuring exact copies and integrity will remain intact. Your real names must be used as when back in your communities the police still have to support you as we deescalate every county. Disrespecting the War Crime Courts or national courts will result in the Myanmar Operation. This is a military operation where the Journalists espousing such infringing influence/creating nuisance or disparity in the facts will be arrested and imprisoned indefinitely and for as long as the war trials continue. This is to preserve the public consciousness and their right to feedback their encounters. This form of recollection is part of remedy and healing. They have the right not to have their perspectives varnished or influenced in any way that perverts the course of justice owed to them. Technically this is called the avoidance of contempt.

Creative Licence will be suspended by the courts on journalists, to enforce the transparency of the information or preserve the facts, as and when the court feel that is an appropriate as an order of the court. Enforcement to deliver the news or moderate it, in the interest of the cases integrities include, pirate radio stations, CB broadcasts, print media, social media, and any other means of broadcast whereby the integrity of the cases, witness or evidence can be said to be put at risk from journalistic behaviour. This applies worldwide and it is expected that media cease contracepting or contravening human rights to the effective receipt of public remedy.

Other journalists will appreciate that the infantile dysfunction of fascist, supremist actors or any other psychopathy that is used to threaten you will be managed carefully by professionals who have a duty to prevent harm to the wider public, worldwide. You are expected to report threats locally who will liaise nationally. Where your response is not acknowledged locally in 24 hours of a real and present threat to your life, use federal or national reporting systems. It is also advised the military police will drug and alcohol test persons broadcasting, as well as ensuring that anyone on prescription pharmaceuticals are taken off air. One cannot be considered for work with any mendicant that affects one's sobriety.

Private Word of Thanks

I have worked with many of you from across the world as we have mastered the end of Fascism and Infantilisation, transforming the United Kingdom.
