Privacy Policy:

This Privacy Policy (Policy) is designed to inform you about Glencore Canada Corporation and the selection committee's practices regarding the collection, use and disclosure of your personal information in connection with the Glencore Brunswick Smelter Bursary. We will treat your personal information in accordance with the Policy unless you explicitly consent otherwise.

Why do we collect personal information?

Personal information may be collected for a number of purposes, including the granting of the bursaries, and the administration of the bursary process. Failure to disclose the information will prevent the proper administration of the bursary process and the selection of candidates.

What personal information may be collected?

The personal information we may collect is likely to identify you as an individual and may include, but is not limited to, your name, date of birth, mailing address, telephone number, email address, photograph, the First Nation Band you are a member of, and education and work experience.

How do we collect information?

Information may be collected when you fill an application or when you contact us with questions or comments. You may also be contacted for selection purposes or to participate in future bursary granting. Participation is always voluntary.

Who has access to the information collected?

We are the owners of the information collected during the contest. Except with your consent or as permitted or required by law, we do not give, sell, or rent your personal information to any other organisation other than as set out in this Policy. We may, however, transfer your personal information to third parties who provide services to us such as data storage or processing. We have an agreement with these third parties that provides for appropriate privacy standards, which reflect the terms of this Policy.

We may also disclose personal information collected to courts, governmental or law enforcement authorities, or authorized third parties, if required or permitted by law, or if such disclosure is reasonably deemed necessary: (i) to comply with our legal obligations, (ii) to comply with legal process and to respond to claims made against any of us or a bursary candidate, (iii) to respond to verified requests in connection with an investigation.

Can I access or change my personal information?

You may, at any time, submit a written request to access your personal information for review and correction if necessary.

How long do you keep my personal information for?

We will only retain your personal information for as long as necessary to fulfil the purposes the bursary process, including for the purposes of satisfying any legal, accounting, or reporting requirements.

In some circumstances we may anonymise your personal information so that it can no longer be associated with you, in which case we may use such information without further notice to you. Once you no longer have a relationship with us, we will retain and securely destroy your personal information in accordance with applicable laws and regulations.
