The City Clerk stated that rates are set to increase for sewer by approximately .83 per 1000 gallons of metered water usage and the customer connection charge is also set to increase by approximately \$1.00. The City Clerk stated that she drafted a new water ordinance to be posted and addressed at the next regular session. The new ordinance also includes a change to the section regarding the emergency maintenance fund, per the State Auditor's Office, the wording needed to be amended to read "water and sewer emergency maintenance fund" instead of water emergency maintenance fund.
