Gilliam asked if the interested parties were present. The clerk responded that they were. Roy Groves and Elizabeth Damm were both present. Carr stated she had an issue with one of the individuals, Roy Groves. Carr stated you cannot be an employee of the Village and reside on the Board. Carr added she understand that current Village counsel has stated that it will not be an issue because the Board members no longer receive compensation. Baumann stated that legal did not see an issue with it. Carr stated that she still opposed it. Gilliam stated that when he spoke with counsel the only issue that was seen was that Mr. Groves would have to recluse himself from votes pertaining to anything that directly affects him like raises for Village employees.

Frank Baumann nominated Roy Groves to fill one of the vacancies on the Board. The nomination was seconded by Phil Gilliam.

Frank Baumann nominated Elizabeth Damm to fill the second vacancy on the Board.

Carr stated that she did not know anything about that person. Ms. Damm stated that she has been a resident of Ferrelview for years and has lived in the same place for that amount of time. Carr stated that at previous session there was interest from another individual and it was rejected for personal reasons. Gilliam stated that he is aware that Ms. Smith was interested in the Board but his opposition was not a personal it was professional. Gilliam added that Ms. Smith had an issue with the clerk and was calling out things that were not factual. Carr stated that she spoke with both parties and they did not have an issue with each other. Gilliam added that the clerk doesn't have any issue with Ms. Smith but Ms. Smith seems to have issues with her. Carr stated that she still objects to Mr. Groves serving on the Board and added that she has spoken with a previous Village attorney and was told that it is not legal. Gilliam stated that our current counsel did not have an issue with the appointment. The city clerk asked Carr if she knew the chapter of law so that research could be done. Carr stated that she would bring it to City Hall.

The clerk stated that at the next regular session the new trustees needed to be appointed to a commissioner's position and that the process would need to be started to add the new trustees to the accounts held by the Village.
